No scope of UZ chairmen's conflict with MPs Says LGRD minister

The Awami League-led grand alliance government is preparing a huge annual development programme (ADP) of Tk 30,500 crore in the first year of assuming power to implement its election pledges.

If finalised, the ADP for fiscal 2009-10 would be 20 per cent bigger than the current fiscal year's (FY) original ADP and 32 per cent larger than the probable revised ADP.

The ADP size in the current FY (2008-'9) is Tk 25,600 crore. It will be revised and brought down to Tk 23,000 crore.

Govt plans 20pc bigger

Economists pointed out that statistics of ADP implementation in the last 10 to 15 years show that the government could never implement ADP of over Tk 200 billion. So, if a big ADP is taken up, the government would not be able to implement it, and there would be more possi-

Finance and planning ministry sources said the ADP for FY '10 has been primarily estimated to be of Tk 30,500

The finance minister has already said

the size of the national budget for the next FY would be very big.

Planning ministry sources mentioned that since the political government came to power after two years of caretaker government rule, various demands are pouring in from different parliamentary constituencies across the country.

Following the upazila elections, the local government bodies are also seeking allocation of funds. As a result, the ADP size will be big this time.

Thai PM forced to cancel Asian summit ADP to fulfil poll pledges

Pro-Thaksin protesters storm venue; foreign leaders evacuated by choppers; emergency declared in Pattaya

Thai protesters smashed their way into a major Asian summit yesterday, forcing the country's embattled prime minister to cancel the meeting and evacuate foreign leaders by helicopter.

Premier Abhisit Vejjajiva declared a state of emergency in the beach resort of Pattaya after thousands of demonstrators stormed the summit, which was supposed to focus on the financial crisis and North Korea's rocket

Choppers plucked dignitaries from the roof

of the luxury hotel venue after the red-shirted supporters of ousted Thai leader Thaksin Shinawatra breached police lines, broke down glass doors and streamed into the building unopposed.

The collapse of the summit piles more pressure on British-born Abhisit, who has pledged that his four-month-old government will heal years of political turmoil since Thaksin was ousted in a 2006 coup.

"The government has a duty to take care of the leaders, who will depart from Thailand,"

Govt may move to bring back fugitive war criminals

Diplomatic efforts to be made for this, says foreign minister

Foreign Minister Dipu Moni yesterday said if necessary the government will take initiatives to have fugitive war criminals of 1971 extradited from foreign countries.

She also said that her government wants to label Bangladesh as 'a secular country with a Muslim majority', rather than as 'a moderate Muslim country'.

She made the comments at a seminar on "Bangladesh's foreign policy and foreign relations: priorities, challenges and opportunities" at Bangladesh Enterprise Institute with its president, ex-ambassador also former foreign secretary Farooq Sobhan, in the chair.

Replying to a query, the foreign minister said diplomatic efforts are on to have the liberation war criminals extradited and 'if necessary the government will take appropriate initiatives regarding the matter'.

ACC'S REFUSAL

JS body may go for contempt move

The parliamentary committee on public undertakings sits today to decide the next course of action regarding the Anti-Corruption Commission's (ACC) refusal to allow it to scrutinise the anti-graft body's activities.

"If the anti-graft body does not appear before the committee, it will undermine parliament. Contempt of parliament proceedings might be initiated against them," committee Chairman Mohiuddin Khan Alamgir told The Daily Star yester-

He said the committee itself might initiate the contempt proceedings or will report to the House for it.

The committee chief said former Indian premier Indira Gandhi, who obstructed a parliamentary probe into her son's business affairs, was arrested and jailed for a week in 1978 on charge of contempt of parliament. The Indian parliament also expelled her, Alamgir added.

Committee member Zainul Abdin Farroque told The Daily Star over telephone that the ACC misused its power in the last two years and it is not above parliamentary scrutiny.

"They will make a mistake if they do not attend today's meeting," said Farroque, also the opposition chief whip.

The clashes erupted at around 3:30 pm when the feuding factions, one led by the president of the organisation -- Abdul Jalil Hawlader -- and the other by its secretary Delwar Hossain, came face to face with each other.

Both factions were scheduled to attend a reception arranged for local Lawmaker Mijanur Rahman Khan Dipu at East Bengal Field in the area. They attacked each other with sticks, rods and brickbats,

though both groups later denied attacking first. At least 20 people were injured in the clash that lasted for around 30 minutes, sources said.

Locals said traffic movement in the area was brought to a standstill and local businessmen closed their establishments when the violence ensued.

The standstill lasted for over and hour.

New nat'l education 20 hurt as pro-AL policy in 3 months

A new national education policy will be placed before the nation within three months for overall improvement of country's education system, said Education Minister Nurul Islam Nahid yes-

Steps would be taken to set up institutions for imparting vocational education at all upazilas across the country, Nahid said at a function on Kalabagan playground in the capital marking the 7th anniversary of the World University of Bangladesh.

The government wants to come out of the culture of frequent shift in policies that need to be implemented, he said.

Nahid said initiatives would be taken to stop the drop out of students at primary school level to free the country from illiteracy. The government has formed a 16-member committee

headed by National Professor Kabir Chowdhury last week to review the report of Shamsul Haque Education Committee-1997 to formulate a modern national education policy in line with the Qudrat-e-Khuda Education Commission-1974 report, education ministry sources said.

The committee has been asked to submit its recommendations to the education ministry within 90 days from the date of its first meeting, sources added.

Millionaires in Indian polls race

Several of the big names in Indian parliamentary elections, including chief of India's ruling Congress Sonia Gandhi, her son Rahul and leader of the opposition L K Advani are millionaires and the value of their assets have gone up in the last five years.

A look at the affidavits by the candidates declaring their assetswhich is mandatory at the time of filing nomination papersshows a sharp rise in their wealth.

The richest among the candidates who have filed their nominations so far is 53-year-old businessman Khimji Patadia, based in India's financial capital Mumbai, who in his affidavit has declared assets worth Rs 514 crore mainly in jewellery and real estate.

A college drop-out, Patadia hails from Gujarat state and is the promoter of Swastik group of companies which has construction and jewellery businesses.

The next richest is L Rajagopal, the Congress party candidate from Vijawada in the southern state of Andhra Pradesh, worth Rs 299 crore.

Among the big guns of politics are, ofcourse, 62-year-old Sonia Gandhi who has declared net assets worth Rs 1.37 crore. However, she does not own a house or a flat or a car, according to the affidavit filed to the Returning Officer in her parliamentary constituency Rae Bareli in Uttar Pradesh, the home state of the Nehru-Gandhi family.

Sonia owns 15 bighas of land in Uttar Pradesh's Sultanpur district worth Rs 2.19 lakh and an ancestral house in Italy worth SEE PAGE 15 COL 7

Violating the Narcotics Control Act, 2005, a capital. number of local tobacco companies are offering smokers on the outskirts of the capital and elsewhere in the country "gift items" as incentives to choose their prod-

Even though tobacco-product advertisement and offering incentives to tobacco consumers are prohibited under the law, the companies are offering items like cellphones, bicycles, household utensils and free cigarettes in exchange for empty cigarette packs or part of the packs. According to Clause-4 of the Narcotics

Control Act, 2005, "No one is allowed to encourage the use of tobacco products."

The company is distributing leaflets among shopkeepers so that they could distribute those among consumers and inform them of special items on offer. The company is running the campaign, titled "Slide Programme", at places including Amin Bazar, Kamrangirchar, Gabtoli, Kamalapur, Tongi, Gazipur, Kapasia in and around the capital and in different areas of Chittagong, Cox's Bazar, Sylhet and Bandarban districts to attract consumers to its brand Maries cigarette.

According to the leaflets, if one submits 15 slides, a part of the cigarette pack, to shopprovide any gift, incentive, scholarship or keepers, they will get one melamine bowl or hold any tournament with the aim to two packs of cigarettes free. He or she will get a free melamine plate for 26 slides, a bucket If anyone violates this law, he or she for 60 slides and a cellphone or a DVD player would be awarded three months' simple for 2,600 slides.

The company is also offering household utensils for buying a certain number of packs Local tobacco company--Abul Khair of its Special Abul Bidi. This programme is run in Noakhali, Chittagong, Bandarban and
