

# No sign of let-up in killings, extortion by Janajuddha

*Outlaws in Jhenidah end lull as Kuddus takes leadership*

There is no sign of let-up in killings and toll collection by Janajuddha faction of Purbo Banglar Communist Party (PBCP) in Jhenidah despite launching of several anti-crime drives and death of at least 26 cadres including its chief Abdur Rashid Malitha alias Dada Tapon in 'crossfire' incidents.

After choosing their new leader Janajuddha cadres have returned to their violent activities including killing of their rivals and toll collection from innocent people.

Sources in intelligence agencies and locals said, Janajuddha men had to stop their 'misdeeds' after their leader Dada Tapon was killed on June 18, 2008.

The cadres, however, within a short time chose Kuddus Ali, 38, of Aswastholi village under Jhenidah Sadar upazila as their new leader and started afresh their so-called 'organisational activities' including murder and toll collection in the area.

Police records and sources in intelligence agencies said, before becoming Janajuddha chief, Kuddus was linked with several underground outfits. He is also accused in several murder cases lodged with different police stations in Jhenidah. In their latest attack in the early hours of Thursday Janajuddha cadres hurled two bombs on the house of Tofazzal Miah of Mirzapur village killing Abdul Gani, a Biplobi Communist Party (BCP) cadre on the spot while he was sleeping on the veranda, police said.

On April 13, miscreants threw three bombs on the 'Barosha filling station in Jhenidah town at around 8-30 pm injuring a Class-Nine girl student identified as Shirin.

In a revenge attack last month, a former cadre of BCP (Biplobi Communist Party), identified as Enamul Huq, 32, was slaughtered on March 9 at village Kuti-Durgapur in Koatchandpur upazila of the district.

Earlier, on March 6, one Golam Kibria was bombed to death at around 7-00 pm at a tea stall at Aswastholi village in Jhenidah Sadar upazila.

Apart from killing their rivals, the Janajuddha outlaws under their new leadership have also started toll collection from locals of Kaluhati, Kuti-Durgapur, Chandpur Bazar and Sholmari Bazar areas under Jhenidah Sadar, sources in police and locals alleged.

Younus Ali, a clerk at Batai Secondary School in Sadar upazila, talking to this correspondent said a few weeks ago a man introducing himself over cell phone as follower of Kuddus Ali, demanded illegal toll.

When I contacted Kuddus over phone, he (Kuddus) also told me to meet the demand, Yunus said.

The same day Kuddus and his accomplices went to Anwar Hossain, a contractor constructing Kuti-Durgapur Government Primary School and demanded Tk 50,000 from him.

As both of them refused to pay toll, the Janajuddha cadres hurled bombs on the house of Younus and the under-

construction building of the school.

During the attack, they took away four cell phone sets from the people of the contractor and threatened Anwar of dire consequences.

Another contractor, Runu Mian, talking to The Daily Star also alleged that the accomplices of Kuddus stopped his construction work at the same village as he refused to pay Tk 50 thousand toll.

Contacted, Superintendent of Police (SP) in Jhenidah Jahangir Hossain Matabbar said, he heard about the misdeeds of Janajuddha cadres but nobody lodged any specific allegation yet with police in this regard.

The SP, however, said all-out measures have already been taken to curb the criminal activities by outlaws in the district.

Abdus Sobhan, a senior teacher at Kuti-Durgapur Siddiqia Madrasa said, "After the death of Dada Tapon, peace-loving locals heaved a sigh of relief but now again they are under serious threat as Janajuddha cadres have returned with fresh vigour with the new leadership of Kuddus."

Dada Tapon died in 'crossfire' between members of Rab and his accomplices on June 18 last year.

Several special drives including 'Operation Clean Heart' and 'Operation Spider Web' were launched in the southwestern districts including Jhenidah. But most of the drives turned futile due to leakage of information ahead of the drives, some law enforcers on condition of anonymity said.

## Jobless youths fall prey to swindle in Jhenidah

A cheat defrauded scores of unemployed youths of crores of taka by supplying fake visa in Jhenidah. He decamped with the money and is now residing in Dhaka. If anyone asks for return of money, the cheat harasses him by filing false case.

A number of hapless youths alleged this at Jhenidah, saying that the swindler, a young man, hails from Bazrapur village under Moheshpur upazila in the district.

Falling prey to the situation many families have become destitute and lost their dwelling houses. Many parents lost their cattle and valuables including ornaments as they sold them for sending their sons abroad, they added.

They said several victims were harassed in false cases filed by the swindler when they went to his so-called travel office at Naya Paltan in the capital to realise money.

On April 5, some youths went to the office and demanded the money deposited for going abroad. At this, the alleged swindler vandalised his office himself and filed cases against them. The victims also filed cases with Shahbagh Police Station on April 11. The SI, supposed to carry out investigation, is now threatening the victims over mobile phone who went to the police station to seek justice.

Victims Shaheb Ali, Kartik Chandra and Ashraf Ali recently told a press conference in Jhenidah that the cheat grabbed Tk 17 lakh from Bablu of Kanejpur village under Sadar upazila. Bablu is a resident of the swindler's father-in-law's village.

The victims claimed at the press conference that Tk 4 crore were gobbled up from hundreds of youths of Madhupur, Nagarbaran, Defolbari, Allardanga, Kushta, Kotchandpur, Moheshpur, Kaliganj, Comilla, Naoga, Mymensingh, Barisal, Meherpur,

Chuadanga and Alardanga.

Besides, the cheat took Tk 65 lakh from Osman and Khokon of Alardanga, Sufal, Anotosh and Atul of Sonadanga Magura, Shonit of Defolbari, Saidur of Allardanga Kushta, Aulad of Bhatoi Bazar, Saidur of Kotchandpur and Alim of Bidhyadarpur. The youths were not sent abroad and now they are not getting back their money.

Sources said, the person also deceived 30 people of Moheshpur, 25 of Kotchandpur and 20 of Chowgachha, Jessor.

Contacted, the said SI of Shahbagh police station denied the allegations brought against him. He said he rather tried to solve the problem.

The alleged swindler, when contacted, refuted the allegations and said he owes Tk 4-lakh 20 thousand to one Kartik. He said that one Ashraf of Dhupabila village under Sadar upazila is solely responsible for the alleged fraud.

## Quacks cash in on villagers' woes

Local quacks started to cash in on the situation. They are now treating patients by pouring water for a long time and giving them oral or intravenous saline.

They are charging 'good amounts' as fee, villagers said.

On Thursday morning, teacher Hasanuzzaman got unwell when he was teaching the students. A quack rushed to the spot and poured water on his head and injected saline. As Hasan's condition deteriorated, he was rushed to Jhenidah Sadar Hospital and later sent to Dhaka Medical College Hospital where check-up showed that he has gastric problem.

Residents of the area, on the other hand, said they have not seen any medical official to visit the villages. Mofizur Rahman and Hafizur

Rahman of Dhaura village said, as no medical official has visited the village quacks Dianot, Biren and Shahabuddin, who are charging Tk 700/800 from each patient.

Shahabuddin admitted that they are making handsome bucks as the disease can be treated only with water and saline.

Abdul Khalek, health and family planning officer of Shailkupa upazila, said, "It is not an unknown disease. From the description of the symptoms, it seems that the three patients died due to heart attack. I have visited the affected areas and advised patients to come to hospital."

Residents of the area, on the other hand, said they have not seen any medical official to visit the villages.

Nasim applies for review of 'false murder case'

Former home minister Awami League leader Mohammad Nasim has submitted an application to Pabna district magistrate's court for withdrawal of a 'false' case against him.

In the application recently submitted to the court, Nasim said his name was falsely implicated in a murder case to harass him politically, said an official source seeking anonymity.

Former minister Nasim and several other political leaders submitted application to the district magistrate for review of their cases. The time for submitting application has been extended till May 17 and we are receiving a large number of applications for 'withdrawing false political cases'. The applications will be reviewed as per rule," Additional Deputy Magistrate Md Imam Uddin Kabir told this correspondent.

The clashing groups chased each other and ransacked classrooms of the physics department. Being informed, police went to the campus and brought the situation under control.

Moin Tushar claimed that Rafiq was involved in 'admission business' at the college and creating pressure on the authorities to allow some students recommended by him for admission to honours classes.

Refuting the allegation, Rafiq said Moin Tushar and his supporters swooped on them when they were protesting Tushar's 'admission business' at the college.



## RU Shibir stages showdown, blocks highway

Activists of Islami Chhatra Shibir and their parent organisation Jamaat-e-Islami yesterday staged demonstration on Rajshahi University (RU) campus and blocked Dhaka-Rajshahi highway near Binodpur Bazar, creating panic among local people and traders.

A large number of outsiders including students of schools, colleges and madrasas also joined the Jamaat-Shibir procession in the evening and chanted slogans against Bangladesh Chhatra League (BCL) and Awami League, witnesses said.
