Govt won't reply to Khaleda notice

The government has decided to take legal action against Khaleda Zia if she fails to vacate her cantonment house within the 15-day time limit starting from April 20 when the cantonment board sent a notice to her.

The government has also decided not to reply to the legal notice of Khaleda in which she asked the government to withdraw its legal notice within 5 days.

Khaleda's lawyer sent the notice to the cantonment board on April 24.

The government's decisions were taken at a regular cabinet meeting yesterday with Prime Minister Sheikh Hasina in the chair.

While talking to reporters BNP senior leader Moudud Ahmed yesterday said, "BNP will go for legal steps if the government does not respond to Khaleda's notice. We will move ahead after the discussion at the party forum."

Power crisis slightly betters

UNB, Dhaka

Power-supply situation slightly improved in and around the capital while improvement in Chittagong region may be in sight from tomorrow (Wednesday) following some urgent governmentinterventions.

According to official sources, Dhaka city and adjacent areas started getting additional 100 megawatt (MW) electricity from yesterday morning following the prime minister's directive given Sunday about solving power and water crises.


The prime minister summoned all the chiefs of the power and water utilities to her office and directed them to improve the situation.

Managing Director of Dhaka Electric Supply Company (Desco) Saleh Ahmed told UNB that his organization has been receiving 45 MW since morning from the PDB while the rest 55 MW is being given to Dhaka Power Distribution Company (DPDC).

Wasa water poses danger

It fails to treat polluted river water; over 10,000 ended up in diarrhoea hospital

In the broiling midday sun, Rashida Khatun was standing in the queue in front of the Sabujbagh Buddha Temple with two big plastic jars and a steel pitcher in her hands. The temple authorities were providing drinking water from their own pump to the poor, who depend on the Water and Sewerage Authority (Wasa) for water.

"The Wasa water is so stinky that we cannot drink it. Honestly, I hate to even touch their water," said Rashida Khatun.

Finding no other means, they use Wasa water for 'cleaning' purpose and go to the temple for drinking water. The

Wasa used to treat the waters of the Buriganga and Shitalakshya rivers and supply the treated water to the city dwellers. Now the waters of these two rivers have become so polluted that even after applying additional chemicals Wasa cannot treat the water perfectly.

Speaking anonymously, a Wasa official said, "With all technologies we have, we cannot treat ammonia found in the waters of these rivers."

However, the Wasa chief engineer claims there is no health risk in their supply water.

5 killed in road crash

Five people were killed and eight others injured in a headon collision between a human hauler and a CNG-run auto-rickshaw at Rajendrapur in South Keraniganj thana yesterday. Of the deceased, three

were identified as Ibrahim, 35, driver of the autorickshaw, its two passengers -Nur Jahan, 45, and Khalil, 48.

Identity of two others could not be known immediately.

Local people said the human hauler collided with the auto-rickshaw on Dhaka-Maowa road leaving Nur Jahan and Khalil dead on the spot and injuring 11 others at about 9:00am.

Of the injured, Ibrahim and two other unidentified men died on way to Dhaka Medical College Hospital (DMCH).

The eight injured human hauler passengers were admitted to DMCH and Mitford Hospital.

The driver of the human hauler fled the scene soon after the accident.

PAC decides to deal with Tk 4,617cr disputes

The Public Accounts Committee (PAC) will examine audit objections involving Tk 4,617 crore in seven years till December 2007 to help recovery of the public funds feared misappropriated. The decision came yesterday at the

inaugural meeting of the parliamentary body formed on February 18.

The Comptroller and Auditor objections involving Tk 4,617.71 crore General's (CAG) office placed a report before the committee meeting at the Jatiya Sangsad Bhaban, said sources.

To expedite matters, it recommends that PAC form four sub-committees to examine the objections to different ministries' expenditure during the period mentioned.
