Unified Licensing (BTRC-Package-4.12)

The Government of the People's Republic of Bangladesh has received a credit from the International Development Association (IDA), and intends to apply part of the proceeds of this credit to payments under the contract for the Telecommunications Technical Assistance the Unified Licensing Consultant for convergence of licenses.

The Scope of Work: The overall purpose of this consultancy is to assist BTRC in developing

its unified licensing regime. Specially, the consultant will have to: (1) Develop a unified license agreement based on international best practices and

experiences; (2) Prepare documents, including a consultation paper, draft and final recommendations, and draft and final license agreement for BTRC towards the unified licensing regime; (3) Utilize an extensive consultation process with all stakeholders to inform the development of these documents; (4) Make presentations, memos, and other related supporting documentation to assist the BTRC towards the goal of designing and implementing the unified licensing regime; (5) Engage with relevant government ministries, departments, organizations and agencies to generate support for the proposals and to work towards smooth implementation of unified licensing regime; and (6) Support the BTRC through the process until the final approval of the license agreement by the commission. The tasks to be completed are as follows:

(i) Task-1: The consultant will review all the existing licenses and will identify which present and future services can be brought under unified license. This task will include (a) Preparing the consultation paper (b) First stakeholders' workshop and (c) Preparing a draft recommendation (ii) Task-2: Assist BTRC in carving out the migration path from existing to unified license, the consultant should also include in the consultation paper, the policy and legal aspect so as to address the issues of voluntary or compulsory migration as per existing telecom act or through amendment of act, (iii) Task -3: The consultant will (a) Prepare the final recommendations on the unified licensing regime (b) Prepare a draft license agreement (c) Assist in the second stakeholders' workshop (iv) Task-4: Prepare the final license agreement and other tasks towards the completion of the tasks.

(V) Training: Throughout the assignment, the consultant will provide training to total 10 Nos.

of BTRC personnel to develop their capabilities and transfer of skills.

Qualifications of Consultant: The services of a consulting firm are required for this assignment. The consultant will be selected based on their experience and capacity in carrying out this type of work. The consultant is expected to be knowledgeable in the issues related to licensing in the telecommunications sector and have experience and knowledge in the telecommunications sector in developing countries and preferably in the region. The consultant should also be familiar with international best practice in unified licensing issues relevant to the situation in Bangladesh and familiar with Bangladesh law, legal practice and legal system.

The consultant should have the following key staff in the following areas: (1) Team leader with at least 10 years work experience in the telecommunications regulation and policy; and demonstrated ability to engage with high-profile stakeholders with in the public and private sectors. (2) Lawyer with at least 10 years work experience in the telecommunications sector; should have specific experience in the drafting of regulations and licenses. Particular experience in migration of licensing regimes is also necessary. (3) Communications Engineer with at least 8 years work experience with detailed knowledge of the telecommunications sector. Specific experience is also required to address radio spectrum, numbering, and related issues. The individual should have good knowledge of next generation technologies. (4) Economist with at least 8 years work experience in telecom sector. (5) Telecommunications expert with in depth knowledge of Bangladesh telecommunications sector and must have fluency in both Bangla and English.

All the team members should have reading, writing and speaking fluency at the level of a native speaker in English. Consultant is expected to be a firm(s) and will be selected based on its experience and capacity in carrying out this type of work.

Timing: The entire assignment is estimated to be completed within 6 months from the date

of signing the agreement between the BTRC and the consultant.

Counterpart: The consultants will report to their counterpart in BTRC: (i) The counterparts will coordinate with government agencies and sector stakeholders; (ii) Facilitate access to records, information and data; (iii) Provide office space and local administrative support.

The Bangladesh Telecommunications Regulatory Commission now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may associate to enhance their qualifications.

A consultant will be selected in accordance with the procedures set out in the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers, January 1997 (revised September 1997, January 1999, and May 2002).
