# JMB's explosives expert Boma Mizan captured

Wife explodes bomb to escape arrest; finally surrenders to Rab with severe injuries after 4-hr midnight raid at a Mirpur house

STAR REPORT

After years in the hunt for him, the Rapid Action Battalion (Rab) last night captured 'Boma Mizan', explosives expert of in the city's Mirpur area.

His arrest was followed by a high drama that unfolded when a Rab team took him to his house at 61/3, Uttar Pirerbagh.

As they got on the doorstep at around 10:30pm, Mizan gave his wife Sharmin some coded instructions, and immediately afterwards a bomb went off inside.

Witnesses said the blast has blown off banned Islamist outfit Jama'atul Sharmin's right wrist and wounded her bombs, two grenades, several rounds of Mujahideen Bangladesh (JMB), at Taltola two children--two-year-old son and a few ammunition, and bomb-making materials. months old girl.

## Probe body summons Sircar, Akhtar, Delwar

Asks them to appear on June 10 to explain graft allegations

The all-party parliamentary body probing alleged graft in parliament secretariat yesterday summoned former speaker Jamiruddin Sircar, his deputy Akhtar Hamid Siddiqui and former chief whip Khandaker Delwar Hossain to appear before it on June 10.

Before hearing the three, the committee will meet on May 31 to discuss the findings of the three sub-committees formed to investigate the allegations of anomalies and corruption during the seven years' tenure of Sircar.

At a meeting yesterday, the probe commit-

tee accepted reports of two sub-committees. Of the two reports, both submitted on May 5, one recommends taking stern legal measures against the three for drawing over Tk 35 lakh as medical expenses violating laws.

The other one suggested action against the former speaker for irregularities in recruitment of 286 people to parliament secretariat.

Another sub-committee, which is probing allegations of corruption in procurement and arboriculture, is scheduled to submit report on

### Army investigation restricted, many finds inconclusive

Sees BDR grievances main reason behind mutiny; refrains from probing external links satisfactorily

Mainly the pent-up grievances among the BDR rank and file over many issues, including Operation Dal Bhat, inside the BDR led to the Pilkhana carnage, according to sources.

The carnage at BDR headquarters on February 25-26 left 74 people dead including 57 army officers.

Sources involved in the army investigation said there were no conclusive findings of external parties plotting the carnage. Analysing the incident it was perceived that some external parties might have used the soldiers' grievances to serve their own interest.

The 20-member army probe committee headed by Lt Gen Jahangir Alam Chowdhury submitted the report to army chief General Moeen U Ahmed Monday.

The reports suggested that a more powerful probe body be formed to investigate the incident and the culprits be tried under army rules.

It said only 30-35 BDR jawans and clerks started the killings. Sources said since the probe was only a departmental investigation, its terms of reference were not like those of other probe bodies'.

Due to this, the committee was unable to collect information and follow clues that might reveal involvement of civilians and political leaders in the carnage or verify information.

### Taliban ultimatum for Pak MPs to resign 60 more militants killed in offensive

The Taliban has given members of parliament representing Pakistan's Malakand Division three days to resign, or else their families will be kidnapped.

"All national and provincial parliament members from the Malakand Division must resign within three days, otherwise, we will arrest all their families, and we will destroy all their buildings," Taliban spokesperson Muslim Khan told CNN.

In a separate directive, Muslim Khan urged Pakistan's Islamist political parties to publicly show support for Taliban militants.

"All these parties must help the Taliban. They must give a press conference to show the people that we need Sharia in the Malakand Division," The Nation quoted him, as saying.

### HC lays down guidelines

The High Court (HC) yesterday issued a set of guidelines defining sexual misdemeanours to prevent any kind of physical, mental or sexual harassment of women, girls and children at their workplaces, educational institutions and other public places including roads across the country.

The HC directed the government to make a law on the basis of the guidelines, and ruled that the guidelines will be treated as a law until the law is made.

An HC bench comprised of Justice Syed Mahmud Hossain and Justice Quamrul Islam Siddiqui came up with the guidelines, directive and ruling in its verdict upon a writ petition filed as public interest litigation by Salma Ali, executive director of Bangladesh National Woman Lawyers Association (BNWLA).

The court directed the authorities concerned to form a fivemember harassment complaint committee headed by a woman at every workplace and institution to investigate allegations of harassment of women. Majority of the committee members must be women, it ruled.

Quoting the HC observations in its verdict, lawyers concerned said the committee will examine complaints from girls or women if they are subjected to any mental, physical or sexual harassment, and recommend to the authorities to take action against the accused persons.
