GOVT NOTIFICATION TO TRANSFER CORRUPTION CASES

Fate of 50 high-profile ACC cases uncertain

The fate of at least 50 high-profile corruption cases, including Niko, Gatco and Barapukuria cases filed by the Anti-Corruption Commission (ACC), has become uncertain due to a government notification transferring those cases to

other courts. Some legal experts said the government has no jurisdiction to issue such notification transferring the cases pending with a court to another court.

If any aggrieved person challenges the legality of the notification with the High Court, it (notification) will be held illegal and proceedings of the cases transferred by

this notification will be affected, they said. ACC's lawyer Advocate Khan Saifur Rahman however said the notification transferring the cases is valid and it will not

affect the cases. courts for dealing with corruption cases by issuing a gazette notification and if the

government transfers the cases by another notification, the cases would not be affected, he added.

On the other hand another ACC counsel Advocate Anisul Huq said if the legality of the notification is challenged, it would be held invalid and the proceedings of the cases will be stayed.

The law ministry on December 22 of last year issued the notification transferring the graft cases from the special courts no 6, 7, 8, 9 and 10, set up on Jatiya Sangsad Bhaban premises, to special courts no 1, 2, 3, 4 and 5 at Dhaka judges' court area.

ACC's panel lawyer Advocate Khurshid Alam Khan has told The Daily Star that the government has no jurisdiction to issue such a notification transferring the cases pending with a special court to another special court.

Unless and until the notification is withdrawn by another notification, the proceed-The government has constituted special ings of the cases transferred to other courts may be held illegal and that is why the fate of the cases has become uncertain, he added.

He said all the cases are at the trial stage after framing charges, although proceedings of some cases have been stayed by the High Court.

"I have already informed the ACC authorities to take steps for the withdrawal of the notification by the government, "he said.

As per law concerned, only the Metropolitan Senior Special Judge has the jurisdiction to send the cases pending with any special court to another court for its trial, he said, adding that the High Court can order any subordinate court to transfer any case to another court following any petition.

It has been stated in Section 4(3) of the Criminal Procedure Code (CrPC) Amendment Act-1958 that only the Metropolitan Senior Special Judge may transfer at any stage of the trial, any case from the court of one special judge to the court of another special judge having jurisdiction within the same territorial limits.

Boma Mizan on 7 days' fresh remand for further grilling STAFF CORRESPONDENT

Zahidul Islam alias 'Boma Mizan', explosives expert of banned Islamist outfit Jama'atul Mujahideen Bangladesh (JMB), was placed on a seven-day fresh remand yesterday for further questioning.

Mizan, who was earlier quizzed in the Taskforce for Interrogation (TFI) cell on a seven-day remand, gave some important information about top leaders of JMB, its activities, future plans and explosives in their possession.

Investigation Officer (IO) of the case Sub-Inspector Izazul Islam of Mirpur Police Station produced the militant before the Chief Metropolitan Magistrate's Court with a prayer for a 10-day's fresh remand in the case filed for possessing arms and explosives in his residence.

The court, however, granted him only seven days' remand.

In the forwarding report, the IO said he had gathered important information from Mizan during the grilling which is being verified. So, he needs to be remanded further to glean more information about the clues already disclosed by him.

Rab men arrested Mizan in the city on May 14 and acting on his information, the crime busting force seized firearms and huge amount of explosives after raiding his two hiredhouses.

HC asks govt to allow Aman to go abroad for treatment

The High Court (HC) yesterday directed the government to allow former BNP state minister Amanullah Aman to go abroad for medical treatment.

The HC bench of Justice Tariq-ul Hakim and Justice M Azizul Haque also issued a rule upon the government to explain within two weeks why any government action restricting Aman from going abroad for treatment should not be declared illegal.

The HC bench came up with the rule following a writ petition filed by the BNP leader.

In the writ petition, Aman stated that following a recent newspaper report he is apprehending that he might be restricted to leave the country for treatment.

A medical board formed to diagnose his illness has recommended for his treatment abroad. Earlier, Aman was accused

in total 18 cases and he secured bails in all the cases.

Barrister Mahbub Uddin Khokon appeared for Aman.

BERC chair seeks president's nod to join as ACC boss

Chairman of Bangladesh Energy Regulatory Commission (BERC) Ghulam Rahman yesterday sent a letter to the president seeking to be relieved of the post for joining the Anti-Corruption Commission (ACC) as its chief.

"As I have been appointed as ACC chief, I have sought to be relieved of the current position to join the new post," Ghulam Rahman told The Daily Star yesterday quoting the letter he sent to the president.

In accordance with Bangladesh Energy Regulatory Commission Act 2003, one has to give a 30-day notification before he or she wants to resign or get relieved of the commission.

"If the president accepts my letter, I hope to join the anti-graft body after a month from now on," said Ghulam Rahman.

"Currently I do not have any clear idea about the Anti-Corruption Commission (ACC). At first I will try to have a clear idea about its work after having discussion with fellow colleagues," he added.

The government appointed Ghulam Rahman as ACC chief on April 30, 28 days after Hasan Mashhud Chowdhury stepped down from the post.

After a month-long trip to USA Rahman returned to countrylast week. While appointing Ghulam

Rahman, the government downgraded the status of the ACC chairman to a Supreme Court judge from the status of a minister given during the tenure of the last caretaker government. Former bureaucrat Ghulam Rahman, who retired as ship-

ping ministry secretary in 2004, was appointed as chairman of the Bangladesh Energy Regulatory Commission by the caretaker government. ACC Commissioner M

Habibur Rahman was made acting chairman for the second time in absence of Ghulam Earlier, after the resignation of Hasan Mashhud, Habibur

Rahman was made acting chairman of the commission for a month. Hasan Mashhud resigned all of a sudden on April 2 eight - five

days after the Awami League-led grand alliance assumed power, without showing any reason. There had been widespread

speculations that his resignation followed some awkward situation that created following the formation of the new political government.
