Woes prolong for damaged dam

People in Satkhira village work round the clock to repair it

Survivors of Cyclone Aila in Shyamnagar upazila, one of the worst-hit areas in Satkhira, have no choice but to fight for survival.

Some scared that the damaged embankment can give away at any point are already leaving the area in search of safer shelter.

Others are working round the clock to safeguard whatever little left spared by the cyclone and water.

A group of 30-35 men were busy yesterday trying to repair the destroyed embankment in Khalishabunia village under Gabura union parishad.

They pleaded with The Daily Star correspondents for help to repair the embankment.

"If the embankment is not repaired, our last belongings will be washed away, our children will die. Please do something," pleaded a tearful Abdul Alim.

"Where can we go, there is no place remaining," he cried.

Maksudul Sheikh, another villager is still in search of shelter.

"Repairing the embankment is very urgent, at least we can live on it then," he said.

The embankment, though broken at many points, is already swarming with people who have sought shelter here. Some families are forced to take shelter in separate places because of the lack of space to be together.

"Everything has been washed away, our clothes, cooking pots -- everything," said the visibly helpless Maksudul.

Not a single house in the 20 villages under Gabura union -- which once housed 37,000 people -- has been spared. The embankment has been damaged at 31 points by the tidal surge. Most of the trees were uprooted and washed away.

Many inhabitants of Padmapukur, Burigowalini, Munshiganj, Atulia and Ramzannagar unions under Shyamnagar upazila and some unions of Asshahuni have started leaving the area in fear of being inundated by rising water levels.

At least six unions in the upazila were badly

3 rental plants fail to take off

PDB's final deadline expires today

The Power Development Board's (PDB) final deadline for two local companies that repeatedly failed to install three rental power plants totalling 120 megawatt (MW) capacity expires today.

This means the contracts for installing 20MW Bogra power plant and 50MW Fenchuganj plant by Energy Prima of Hosaf Group and 50MW Ashuganj power plant by Precision Energy will be cancelled.

These companies signed three-year contracts last year claiming they had the power plant equipment in stock, which was actually not the case.

Rauf came to set up Daud's crime network

Says DMP commissioner

Indian fugitive criminal Abdul Rauf Daud Merchant came to Bangladesh with a mission to expand the illegal empire of Daud Ibrahim, head of a organised crime syndicate in Mumbai.

"Detained Rauf came to Bangladesh to set up a network of Daud Ibrahim," Dhaka Metropolitan Police (DMP) Commissioner AKM Shahidul Huq said, adding, "We will launch an investigation and dig out their network and their Bangladeshi agents."

But both Rauf and Zahid denied the allegation and their link to the Chittagong arms haul. They said that they came just to get holed up to escape the grips of Indian law enforcers.

Meanwhile, Rauf, his sidekick Zahid Sheikh and their Bangladeshi host Kamal were taken on an eight-day remand yesterday.

At a press briefing at the office of Detective Branch (DB) of police, the DMP Commissioner said they were trying to find out if Rauf had any link to the smuggling of 10 truckloads of illegal arms and ammunition seized in Chittagong.

Country falls far short of minimum forestland

Leaf-rolled bidi factories emerge under lax watch

A good number of unauthorised 'patar bidi' (leaf-rolled tobacco) factories are operating on the outskirts of the capital and elsewhere in the country taking advantage of lax monitoring by the authorities concerned and poor enforcement of Tobacco Control Act, 2005.

The Bidi Manufacture (Prohibition) Ordinance 1975 doesn't allow bidi manufactures using 'khumbi leaf', 'tendu leaf' or leaf of any other plants. Whoever contravenes any provisions of this ordinance shall be punishable with imprisonment for a term which may extend to two years or with fine which may extend to one thousand taka or both, the ordinance reads.

56 killed in Afghanistan

Kunduz governor injured in bomb attack

A battle in a militant-controlled region of western Afghanistan killed 30 insurgents and nine Afghan soldiers, while a roadside bomb in the country's north wounded an Afghan governor, officials said yesterday.

Violence elsewhere in the country killed 17 others, part of a spate of attacks that killed 56 people over all.
