Outlaw killed in bomb blast

A suspected outlaw was killed while two others received injuries at village Kuchiamora under Ataikula Police Station yesterday. Police said Shipon Mondol, 30, son of Nasim Mondal of village Kuchiamora was carrying a bomb, which suddenly went off, leaving him dead on the spot. Abu Bakar and Hossain Ali were injured in the blast. Police recovered the body and sent it to Pabna General Hospital for autopsy. Officer-in-charge (OC) of Ataikula Police Station said the dead belonged to outlawed Janajudhha faction of the Purbo Banglar Communist Party (PBCP).

Notorious criminal held

Police on Monday night arrested a ringleader and recovered firearms, bullets and swords in Pangsha upazila in Rajbari. Arrestee Mizanur Rahman alias Ripon, 32, was 'second-in-command' of notorious Taijal Bahini. Taijal was rounded up when police raided a den of the gang in Dompara area at about 8.30: pm. Police also recovered one SMG (short machine gun), a foreign made revolver, two local made shutter guns, eight bullets and 11 swords from hidden places of the den. Sources said Taijal and his men fled the upazila soon after takeover of the caretaker government. But they recently returned to the area and started reorganising the gang.

20 jailed for smuggling

A Cox's Bazar court on Sunday afternoon sentenced each of 20 people to seven years in jail on charges of bid to smuggle out fertiliser. The court also fined each Tk 5,000, in default, to suffer one more year in prison. According to the case, members of the Navy on April 15, 2005 seized 3,000 sacks of urea fertiliser from MB Alam fishing boat and 2,500 sacks urea from MB Nasima fishing boat which were being smuggled out to Myanmar through St Martins Coast in Teknaf. Court sources said, the owners of two fishing boats used for smuggling have also been fined Tk 5 lakh each and they were ordered to deposit TR 10 lakh to the Deputy Commissioner within 30 days.

Silk traders demonstrate

Silk weavers yesterday brought out a procession in the town and submitted a memorandum to the Deputy Commissioner (DC) protesting alleged extortion and harassment by members of the law enforcing agencies. They alleged that plainclothes policemen harass them when the silk cloth traders leave for capital or elsewhere to sell their products. The law enforcers often collect illegal toll at Chapainawabganj Mohananda Bridge plaza, Belpukur checkpost of Rajshahi and Natore town, they alleged. The processionists paraded the main streets of the town and held a rally in front of the DC office before submitting the memo.

Woman killed by stepsons

A woman was killed yesterday by stepsons at village Jhoula Para in Domar upazila. Police arrested the husband and the three stepsons on charge of murder. Locals and police said one Mohsin Ali, 50, married three women. His two sons--Abul Kalam of his first wife and Abul Kashem of his second wife locked in a quarrel. When mothers of the two boys joined the quarrel, Tafiza Begum, the third wife of Mohsin Ali came forward to stop them. At one stage, Alam, the adult step son of Tafiza Begum also came out there and all three started beating their step mother with bamboo sticks killing her on the spot.

4 CU students hurt in attack

Four students of Chittagong University (CU) were injured in an attack by an expelled student inside a university shuttle train at Sholoshahar Railway Station yesterday. Sources said Sahil, who was expelled on April 24 this year from the university for one year on charge of stabbing another student, Abu Torab, swooped on the four students who are friends of Torab. All on a sudden, Sahil pulled a machete from his bag and started stabbing the students leaving Rahman, Imran, Zaman and Ashraful injured. Sahil allegedly belongs to 'Ekakar group' while the four are members of rival 'Sixtynine group' at CU.

Gun, bombs recovered

Chandon murder sparks protests in Khagrachhari

Brutally tortured by a few youths in a hotel at Khagrachhari Bazar on Thursday night, a young man died on the way to Chittagong Medical College Hospital (CMCH) early Friday.

The murder sparked protests in the hill town and created a sense of insecurity among the Hindus.

The criminals left the victim, Chandon Chowdhury, 27, on a cart at nearby vegetable market, thinking him dead.

Informed by a night guard, police sent him to Khagrachhari Adhunik Sadar Hospital from where he was referred to CMCH.

Following a case filed by Chandon's wife Jemi Chowdhury on Saturday, police arrested Mohammad Saikat, owner of residential hotel AL Masud, and his manager Mohammad Karim. Jemi, however, alleged that police is showing negligence to arrest rest of the accused.

Narrating the fateful incident with tearful eyes, she said, "Seriously injured in the hand of criminals led by Mohammad Saikat, owner of Hotel AL Masud, on May 28 night, my husband Chandon died."

"Some influential political leaders are creating pressure on me to withdraw the case. Where will I go with my 18-month-old girl Monika? Our condition is not good," she said.

Bid to grab public park

Detained director of National Academy For Computer Tanning and Research (NACTAR) start any construction work without perunder the Ministry of Education, Md Abdul mission from the ministry concerned, he Mannan Sarker had posted several signboards with his name at a 2.5-acre public park at Shakpala village under Shahjahanpur upazila.

In the signboards, he mentioned the land as 'Muktijoddha Square', apparently to cheat traders in the name of allotment of shops in a proposed market there, locals said. Mannan Sarker, also the chairman of NGO

Science and Information Technology (SIT) Foundation, was sent to Bogra jail in connection with a cheating case on May 26.

"Setting signboards by Abdul Mannan Sarker on 2.50 acres of land worth about Tk 8 crore is an attempt to illegally occupy the land under RHD," Md Adul Hossain Pramanik, executive engineer of Roads and Highways Department (RHD) in Bogra, told The Daily Star.

The department sent a letter requesting the local Muktijoddha Sangsad unit chief not to be confused by the signboards or

"I have heard that Abdul Mannan Sarker asked the local traders to have allotment of shops in the planned market," Bogra Pourasava Councillor Mohammad Ali said.

The past four-party alliance government made a public park on the land in 2001, RHD sources said.

Abdul Mannan Sarker earlier told the local journalists that he had no intention to occupy the land or go for any illegal constructions "I have put the signboards only to name the

RHD land as Moktijoddha Square," he said. Mannan Sarker and his accomplices, who allegedly collected more than Tk 12 crore from job seekers of different districts including Bogra through NGO SIT Foundation, are facing nine cases for cheating.

19 more sued for war crimes

Nineteen more alleged collaborators of Pakistani occupation forces have been sued for war crimes in 1971 in Natore and Patuakhali districts.

Khodeja Begam, daughter of Martyred freedom fighter Alai Miah of Razibpur village under Sadar upazila, filed a petition case with the Chief Judicial Magistrate's Court yesterday, according to a correspondent.

The accused are former deputy leader of Muktijoddha Sangsad Natore district unit Nabiruddin Sarkar, Abdul Malek, Sheikh Alauddin, Ramzan Mollah, Ansar Ali, Abdur Razzak, Moksed, Amjad, Anis, Zahurul and

Shahjahan Ali. In the case statement, the complainant said the accused stormed into their house on

him to Fotedanga Harishpur village and killed him, she alleged.

After hearing, Magistrate Sarif Ahmed asked Natore Sadar Police Station to record the case as FIR (first information report).

In Patuakhali, a case was filed with Dashmina Upazila Magistrate's Court yesterday against eight war criminals,
