The poor are burdened with more bribe demands than the rich amid global financial crisis and it appears as a double punishment to the poor, says Transparency International's (TI) Global Corruption Barometer 2009.

"Across the board, lowincome respondents were more likely to be met with bribe demands than the highincome respondents," said the barometer prepared on the basis of responses of 73,000 individuals drawn from 69 countries.

Poor hard-hit by bribes Govt to offer tax relief for banks

Tax on SIM to go down, mobile sets to rise

The government is going to cut taxes on mobile SIM card and industrial raw materials and corporate tax rates of banks and financial institutions in the budget for the-

But it will increase taxes on cars, vehicles, cigarettes and mobile phone sets to collect additional revenue.

The government will not bring any change to the ceiling of individual tax rate, but it will conduct special drives in a good number of places in search of new

the next fiscal year at Tk 61,000 crore, more. which is Tk 8,000 crore more than the probable target in the revised budget for the current fiscal year. The original target was Tk 54,500 crore.

It has been learnt that the supplemen- VAT collection. tary duty is being increased for motor vehicles, the sector that became the second highest revenue earner in the last fiscal year with 9.42 percent revenue.

Based on the vehicles' cylinder capacity, the current supplementary duties are 20 percent, 60 percent, 100 percent, 250 percent and 350 percent. Sources said the The National Board of Revenue (NBR) duty for vehicles with lower and medium

The highest amount of Value Added Tax (VAT) collection comes from the sales of cigarette and bidi. Revenue earning from cigarette is 27.84 percent of the total

The tax on cigarette is imposed on the basis of prices fixed by the NBR. At present, 32 percent supplementary duty is there on cigarette that sells at Tk 6.50 to Tk 7.50 per packet of 10 sticks. The supplementary tax on cigarette priced at Tk 38 and above is 60 percent.

The growth and development of the Construction Industry is an extremely important matter for Bangladesh because of the appalling inadequacy that still persists in respect of housing for our teeming millions and overall infrastructure, the speedy development of which have become very essential. The main ingredient of construction Industry is concrete, 99% of which is still being produced by stationary mixer machines. Apart from the various qualitative inadequacies of this old, conventional method, its use has been restricted / prohibited in the developed countries of the world. Further development and modernization of the conventional method of producing Concrete has become essential.

In recent times a handful of Business Organizations took some initiative to replace this old, conventional method by more modern methods of concrete production. This advanced method of concrete production is expected to flourish with minimum patronization from the Government, leading to revolutionary change in the construction industry, with the environment becoming freer from pollution.

In the backdrop of this scenario, for the last few weeks, those few entrepreneurs are being pressurized from different VAT Offices for paying VAT on ready mix concrete which is basically the same concrete produced by conventional concrete mixer machines, except its production process being much more modern, efficient and environment friendly. If VAT is imposed on concrete produced in the modern method i.e. Ready mix Concrete, its cost is bound to increase substantially over the cost of concrete produced in the conventional method. As a result, clients will lose interest in using Ready Mix Concrete, and this new industry, whose manifold expansion is essential for the development of the nation, will be nipped in the bud. Construction Industry will get a setback and pollution of the environment will continue unabated.

In the circumstances, we would humbly appeal to the Honorable Finance Minister to kindly do the needful to ensure use of Ready Mix Concrete to at least 30-40% out of the total use of concrete in the country and to keep imposition of Vat on Ready Mix Concrete in Abeyance until necessary frame work/infrastructure for the same is achieved, on a national level.

US President Barack Obama launched a Middle East mission yesterday to reach out to Muslims but was greeted by threats from Osama bin Laden who accused him of sowing fresh seeds ofhatred.

"Obama and his administration have sowed

new seeds of hatred against America," said the Saudi-born bin Laden whose network carried out the September 11 attacks in 2001.

"Let the American people prepare to harvest the crops of what the leaders of the White House plant in the next years and decades."

White House spokesman Robert Gibbs said Obama arrived in Riyadh to a red-carpet that the administration had yet to fully analyse the bin Laden tape, but said Al-Qaeda was bent on an "effort to upstage" Obama's speech.

"I don't think it's surprising that Al-Qaeda would want to shift attention away from the president's historic efforts, and continued efforts to reach out and have an open dialogue


Convicted Omar, Zahid get HC bail
