# Pakistan to invite Taliban's victims to fight back

Civilians who lived under the Taliban's harsh rule in Pakistan's Swat Valley may soon be recruited to police the region with preference going to those hit hardest during the militants' two-year campaign of terror, a top official says.

Rebuilding the valley's decimated police force is considered crucial to bringing home more than 2 million people displaced by an army offensive and to keeping the Taliban from coming back. It's a process of great interest to the US, which wants Pakistan to eliminate safe havens for militants fighting in neighbouring Afghanistan.

To fight an insurgency, "the people have to be actively with you," Malik Naveed Khan, inspector general of police for the North West Frontier Province, told The Associated Press in an interview Monday.

He said some 6,000 civilians would be recruited, along with a force of 2,500 ex- targeted police, beheading them, shoot- Taliban, whom they blamed for a military personnel that lend further ingthem, attacking their checkpoints and mosque bombing.

Khan said the plan needs formal approval from the provincial government, but that "everyone is on board." The goal is to have a full force ready by mid-August.

Bashir Bilour, the province's senior minister, said authorities support the idea because of the citizens' "knowledge of the area, people and local customs and traditions. They will also have a feeling of ownership and participation in the process."

Before the violent Taliban campaign took off in earnest in the valley in 2007, Swat was considered a "soft district," with low crime rates and around 2,000 lightly armed police for a population of 1.75 million, Khan said.

The better-equipped militants quickly

even forcing some officers' parents to swear on the Quran that their sons would stop patrolling. At least 120 police were killed and around 700 officers fled the force, Khan said.

Candidates for the new policing jobs need to be "able-bodied, tough people with a clear background, giving some preference to those whose houses have been burned and who have been targeted," Khan said in his office in Peshawar.

He didn't respond when asked whether the program was deliberately tapping into a desire for vengeance, but said he expected recruits to be attracted by the salaries \$125 a month, about the same as a police constable earns.

The government has already had some success in raising militias, known as lashkars, to fend off militants elsewhere in the northwest. Troops backed up a militia that arose in the Dir region this month and fought the

## India to review Pakistan's actions on terror before talks, says Manmohan

India would review Pakistan's actions against anti-India terror outfits before deciding on resuming the composite dialogue mid-July, Prime Minister Manmohan Singh said Wednesday, a day after he met Pakistan President Asif Ali Zardari in Russia.

The prime minister said he would wait for the outcome of the talks between the foreign secretaries of the two countries, who are expected to meet within a month, before taking a deciposite dialogue that stalled Qaeda and the Talihan. after the Mumbai terror "I told him that we will the dialogue process over

"The purpose of this meeting (between foreign secretaries) is to find what Pakistan had done and what it plans to do on terrorist activities against India," Manmohan Singh told reporters on board his special plane while returning home from the Russian city of Yekaterinburg.

Signalling India's willingness to make peace with Pakistan, Manmohan Singh said he had asked Zardari to show the same determination in preventing terrorist attacks against India as it sion on resuming the com- had shown in combating Al Singh said when asked have been rendered home-

### US Senate approves enhanced aid bill for Pakistan

The US Senate Foreign Relations Committee has passed the enhanced aid bill for Pakistan offering 1.5 billion dollars annually over the next five years.

The bill named the Enhanced Partnership with Pakistan Act, commonly known as the Kerry-Lugar bill, is primarily aimed to counter terrorism.

Addressing the Congress, the Foreign Relations Committee Chairman John Kerry highlighted on the need of assisting Pakistan in its drive to quell extremism from its soil, and rehabilitate thousands of people who less due to the on going military operation in Swat


"This is a critical moment for Pakistan," the Daily Times quoted Kerry, as say-

"This bill will help the Pakistanis fighting to turn their country toward a path of moderation and stability,' he added. The aid would come with

#### Pakistan nets 4 men suspected of plotting attacks

Pakistani police said Wednesday they had arrested three men suspected of planning a suicide attack near Islamabad, while a suspect from an al-Qaeda-linked group was held in Karachi.

Pakistan has been hit by a wave of deadly bomb attacks in recent weeks, and security is at unprecedented levels amid fears of more violence from Taliban insurgents avenging a military campaign against them. "Police have arrested three

suspected terrorists with explosives and suicide jackets in Rawalpindi," said a senior police official in the garrison city neighbouring the capital Islamabad. Another police official in

Rawalpindi confirmed the arrests and said the three men were apparently planning to carry out attacks in the city.

Legal experts, however, say as per the constitution and the Members of Parliament (Determination of Dispute) Act 1980, the EC itself has the authority to strip Salauddin of his parliament membership.

Election Commissioner Muhammed Sohul Hussain yesterday said if the speaker asks the EC to do something, the commission will take up next course of action. "If the speaker thinks it is a dispute, then he will refer it to the Election Commission to settle," Sohul told a group of reporters at his office.

However, in Salauddin's case, the EC itself filed a petition with the speaker through the Parliament Secretariat to determine the dispute, triggering a fresh dispute as the EC itself raised the complaint and it will have to settle the dispute itself.

Election Commissioner Sohul Hussain said they sent the letter to the Parliament Secretariat to inform the speaker about the dispute. But officials at the EC Secretariat said the matter is new to the commission and it does not find any such precedence.

Legal experts said the EC itself could take Salauddin's offence into cognisance. Besides, the EC can use its inherent power to take action against Salauddin for violating the electoral laws by concealing information in the affida-

The Appellate Division of the Supreme Court has given a clear statement about the inherent power of the EC in the Noor Hossain versus Nazrul Islam case. The apex court observed that time and again it held that it is the responsibility of the EC to see that the election is conducted justly, honestly and fairly.
