

BARISAL CITY BNP CONVENING BODY First meet foiled amid brawl

A faction of Barisal city BNP yesterday foiled the first meeting of the newly formed convening committee of the city unit and assaulted their party rivals.

The meeting was convened at the residence of Mahmud Golam Salek, convener of the city BNP, at Kali Bari Road in the morning to form an extended 51-member convening committee of the unit.

BNP central committee on June 9 declared a seven-member convening body of Barisal city unit with Golam Salek as convener and six others, including former city BNP general secretary Asaduzzaman Khasru, as joint convenors.

But the party high command later dropped the name of Khasru from the list of convenors and directed the city unit to form an extended 51-member convening committee.

As per directive of the party high command, the new convening committee sat in a

closed-door meeting at around 11:45 with Mahmud Golam Salek in the chair.

When the meeting was going on, the aggrieved BNP men, led by Altaf Mahmud Shikdar, Panel mayor of Barisal City Corporation (BCC), Giasuddin Babul Molla, Mir Zahidul Karim Zahid, ANM Saiful Hassan Azim, BCC councillors ATM Shahidullah Kabir, stormed into the meeting venue demanding inclusion of Khasru in the convening committee. They engaged in altercation with the attending leaders and assaulted them.

In the face of strong resistance by party rivals, new convener Golam Salek cancelled the meeting.

Khasru's supporters then took out a procession in the city demanding cancellation of the new convening committee.

Golam Salek told reporters that the meeting was called to extend the convening committee in presence of six joint convenors but cancelled due to an unexpected situation created by some unruly activists.

SUNDAY'S SATKHIRA INCIDENT Ansar member files counter case

An Ansar member has filed a counter case against eight and many other unnamed people of Puratan Satkhira in the town accusing them of beating up Ansar members and creating obstacles to discharging their duties.

Rafiqul Hasan, complainant of the case filed against the Ansar men on June 22, Anowar Hossain Chandu, Manirul Islam, Alamgir Hossain, Sheikh Firoj Ahmed, Mintu, Chanchal, Rafique Bhuiya besides many other unnamed people were sued by Shah Jalal of 27 Ansar Battalion.

Shah Jalal, also an accused in a case filed by Rafiqul Hasan, filed the counter case with Sadar Police Station on Tuesday night.

He alleged that a group of

villagers led by the eight named accused attacked the Ansar members to grab a portion of land under 27 Ansar Battalion headquarters on June 21.

They beat up the on-duty Ansar members who tried to resist, the complainant added.

Earlier on Monday, Rafiqul Hasan, filed a case with Sadar Police Station against five members of 27 Ansar Battalion including acting Commanding Officer Nurul Afzar Chowdhury and 40 other unnamed Ansar men on charge of beating up locals the day before. Rafiqul said Ansar men beat him up severely as he protested their atrocities on people including women and children.

On contact, Rafiqul Hasan said, "The Ansar member's case is false and motivated. He filed the false case to get rid of the case earlier filed by me."

Torture victim sues 38 JMB operatives

Amir Ali, a JMB torture victim last week lodged a case against 38 JMB militants in Rajshahi.

The complainant, hailing from village Maddha Jhina lodged the case with the third court of judicial magistrate which ordered police for immediate legal action.

The accused include JMB 'advisers' Lutfar Rahman, Abdus Sattar and Mahtab Khamaru and cadres Mostafizur Rahman, Mamunur Rashid, Morshed and Enamul Haque.

According to the case, armed JMB cadres abducted Amir Ali on April 7, 2004 and looted his house. They took him to Hamirkutsa camp and tortured him overnight and demanded Tk 1 lakh for his release.

Although Amir paid Tk 35,000, he was tortured and mimed by the JMB operatives.

One beaten to death

One person was beaten to death on Wednesday in Pir Pukur village of Saidpur upazila. Sources said Shafiar Rahman of Nital Dangapara village of Kishoreganj upazila, came to visit Raihan Mia of Pirpukur as his guest. At dead of night some locals detained Raihan on suspicion of being a cattle lifter. They tied him with a tree on the compound of a nearby primary school and beat up mercilessly. In the morning, members of the village police informed the matter to Saidpur police. Police rushed to the spot and rescued him in a critical condition. Later Raihan was shifted to Saidpur hospital where the attending physicians declared him dead. A case was registered and one villager was arrested.

Rival transport workers clash

Two rival groups of transport workers yesterday evening clashed for control of a bus terminal leaving three persons including general secretary of Lalmonirhat District Truck Tank Lorry Sramik Union Abul Kalam injured. Earlier, a chase and counter-chase between the factions-one led by Kalam-Quader and the other by Rana-Mithun took place over opening of a new office at the bus terminal. The supporters of Kalam-Quader group blocked Lalmonirhat-Burimari highway and obstructed the journalists from performing their duties. They also damaged the motorcycle of Daily Star correspondent as he took photograph of clash. Later, a general dairy was filed with the Sadar police in this regard. Journalists in Lalmonirhat demanded punishment to the culprits.

Two get life term for murder

Feni Additional District and Sessions Judge's Court in a murder case on Wednesday sentenced two persons to life term imprisonment and fined each Tk 5,000, in default, to suffer more six months' rigorous imprisonment (RI). Court sources said Shahidullah Majumder, son of Feroz Ahmed Majumder of Chitola village under Parshuram upazila was strangled on January 8, 1996. His body was later recovered from a water body. The victim's father filed a murder case and CID submitted charge sheet against Abdus Salam's sons Alam and Shah Alam.

Workshop at Sirajganj

13 WAR CRIME CASES IN 75 DAYS

Only one out of 125 accused held in Khulna

Only one out of 125 accused was arrested in connection with 13 cases recorded in the last 75 days with four police stations of Khulna district for killing freedom fighters and looting their houses during Liberation War in 1971.

According to Police Superintendent Md Shamsuddin, investigations into all these 13 cases against war criminals are going on.

Complainants filed petition cases with the courts concerned naming 125 alleged collaborators of Pakistani occupation forces as accused of killing freedom fighters and later dumping their bodies during the war.

After hearing on the petitions, the courts ordered the police stations concerned to record cases after proper investigation into the allegations.

Afterwards, eight cases were recorded with Batiaghata Police Station, two with Dumuria Police Station, two with Dakop Police Station and one was with Phultala Police Station of the district.

Ten of the 13 petition cases were filed with the Court of Senior Judicial Magistrate Rozina Akther while the rest with two other courts.

The arrestee, Gaffar Morol of Birat village under Batiaghata upazila, is now in Khulna jail. He recently gave a statement to the court, confessing to his role as collaborators during the War of Independence.

Meanwhile, Seven alleged rajakars have been sued for killing a freedom fighter in Kashiani of Gopalganj district in 1971.

Sultan Ahmed, Son of a martyred freedom fighter Abdus Salam Miah, filed the case with Gopalganj Judicial Magistrate's Court accusing seven rajakars of killing his father, according to a correspondent.

The accused are Solaiman Miah, Hares Sheikh, Chona Miah, Kheyal Uddin Mollah, Siddiqui Rahman and Moni Miah.

The complainant said the accused picked up his father at gunpoint from in front of Kashiani Ramdia post office, took him to Gopalganj camp of Pakistani occupation forces and killed him.

RU hall raided for outsider Shibir cadres

Law enforcers raided Shaheed Ziaur Rahman Hall of Rajshahi University (RU) on Wednesday night to arrest outsider Shibir cadres who equipped with firearms took shelter in the hall.

Being informed by some resident students, the hall authorities sought help from police who raided the hall at around 11.00 pm. Sensing the presence of the law enforcers, the Shibir cadres fled the hall scaling its boundary wall.

Assistant Proctor Mushtaque Ahmed told newsmen that they along with police raided the hall as they were earlier informed that outsider Shibir cadres were staying in the dormitory for creating untoward incident.

Provost Prof Rezaul Karim said no outsiders will be allowed to stay in the dormitory. "We will take action against those who don't have identity cards," said the provost.

Bail prayers of 34 BDR men rejected

District and Sessions Judge's Court of Kurigram on Wednesday rejected the bail prayers of 34 arrested rebel BDR men of 27 Rifles Battalion.

All the jawans including Subedar Moysheer were produced in the court. Lawyers of the BDR men appealed for bail but the court rejected the prayers.

Public Prosecutor (PP) Abraham Lincoln conducted the case on behalf of the state while advocates Zakaria, Rehana Begum Beauty, Fakhrul Islam, Yasin Ali, Monwarul Haque and Mokheer Rahman stood for the accused. The court later fixed the next date of hearing on July 08, 2009.

One killed, 50 hurt in clash

One person was killed and at least 50 people were injured in a clash yesterday between two rival groups at Shimrail village under Mahari union of Kasba upazila.

Bachchu Mia, 45, of Sarker Bari at Shimrail village died when Alam group and Mustafiz group locked in a clash following an altercation between Karim Mia and Nannu Mia of the two groups.

The rivals used lethal weapons including spear. Bachchu died on the spot while condition of Kuddus Mia, 30, Piar Ahmed, 32, Salina Akter, 35, and Razia Begum, 55, was stated to be critical.

Police later arrested Mehari Union Parishad chairman Md Alam in connection with the incident.
