Forgotten JS pledges

BNP, Jamaat remain absent from House for 38 out of 59 working days already; Khaleda attends only 3 sittings; no effective initiative of ruling party to make JS functional

in four-party alliance Jamaat-e-Islami remain absent from joining the House proceedings, paying no attention to their electoral pledges made to the people before the December 29 parliamentary election.

In their election manifesto, both BNP and Jamaat promised that if voted to power, they will take strong stance including the ones for bringing amendment to the constitution, if required, to bring an end to the pervasive culture of boycotting

Though the four-party alliance failed The main opposition BNP and its key ally to return to power in the polls, they got around 38 percent of the total vote cast in the elections.

> Ignoring their electoral pledges, the opposition lawmakers remained absent from the current budget session without taking the opportunity of reviewing the government's policy through participating in the ongoing general discussion on proposed budget for the new fiscal year.

It is uncertain whether the opposition lawmakers will join the current session that already have passed 20 working days as

BNP's top leaders are divided over joining the House proceedings "in the current situation," a policymaker of BNP said.

The national budget for 2009-10 fiscal year was passed in parliament on Tuesday in absence of the main opposition party.

A lawmaker of BNP said Chairperson Khaleda Zia is not much interested in joining the House since she feels the government is not respectful to her. But many of its lawmakers want to join the session, the lawmaker said, adding seating arrangement in the parliament is not that big a problem right now.

Pinak 'might have broken' Probe report on BNP trio to be placed in JS

All-party body to ask House to recover the money from them

The all-party parliamentary probe committee yesterday decided to submit its report to the House on corruption by former speaker Jamiruddin Sircar, his deputy Akhtar Hamid Siddiqui and former chief whip Khandaker Delwar Hossain on July 7.

The probe body found evidence and proofs of the trio's "misappropriation" of Tk. 1.71 crore. They took the money as medical expenses and additional fuel allowances ignoring the law, sources in the committee claimed.

In a set of recommendations in the report,

the parliamentary body will ask the House to recover the money from Sircar, Akhtar and Delwar and file criminal cases in this connection against them if they fail to return the money, a member of the committee said.

"We decided to place the probe report in parliament on July 7. We want to read out the findings of our investigation in the House so that people can know what happened in the Parliament Secretariat in the past," Shajahan Khan, a member of the probe body, told The Daily Star.

RMG wheels move amid strict security

The government doubled security in and around Ashulia yesterday as garment factories resumed production in full swing to end three days of violent labour unrest in the industrial area.

Meanwhile, police revealed that Jubo League members joined the labourers and caused most of the damage during the unrest to establish control over the jhoot (garment rejects) business.

An additional 4,000 personnel from police, Rapid Action : Battalion (Rab) and armed police battalion watched over the area as garment factories opened their doors to let thousands of workers get back to work.

Meanwhile, factory owners were scrambling to fix the damaged factories in order to meet their export deadlines.
