Stepmother beaten to death

A woman was beaten to death by her step sons during a dispute over share of land property of her deceased husband. Sources said one Rahmat Ali of Chhoto Khata Suparipara village of Dimla, who died last month, left behind two wives and several sons and daughters. On June 17, during an altercation between the sons of two wives, the sons of first wife mercilessly beat up their step mother Hasina Bewa, 55, leaving her seriously injured. Locals rushed her to Dimla Upazila Health Complex in a critical condition where she died Tuesday night. A son of the deceased filed a murder case accusing his step brothers.

Two get life for murder

Sylhet divisional Speedy Trial Tribunal yesterday awarded life term imprisonment to two persons on charge of killing a housewife. Convicts Roziullah and Taj Uddin hail from village Mainpur in Chhatak upazila of Sunamganj distict. The court, however, acquitted eight others of the charges. According to the prosecution story, on February 7, 2006, the accused attacked the house of Manik Miah, a grocer at Mainpur bazar as he refused to pay toll. They beat him up and at one stage swooped on Manik's wife Rokeya Begum, who tried to rescue her husband. Critically injured Rokeya later died at a private hospital in Dhaka.

BCL men block road

BCL activists yesterday blocked road at Barthi point under Gournadi upazila on Barisal-Dhaka highway protesting attack on one of their leaders by a local goon. Sources said Monir Bepari was handed over to police by Sagor Peyada, a member of upazila BCL convening committee for teasing a girl at Barthi last month. Police said, Monir who was freed on bail on Monday along with his gang men attacked Sagor at Torki Bandar and injured him seriously. On hearing the news, agitated BCL activists blocked Barisal-Dhaka highway at noon. Police brought the situation under control with the help of local AL leaders. The blockade was withdrawn at about 11:00 am.

Schoolteacher murdered

Criminals yesterday stabbed to death Akhil Chandra Saha, 35, a school teacher in Charghat upazila. Police said, Akhil was an assistant teacher at Raotha School and College. He was attacked when he was returning home from his workplace. Informed by locals, police rushed to the spot and recovered the body bearing marks of several stab injuries. Police also found a mobile phone and a wallet. Akhil's body was later sent to Rajshahi Medical College Hospital for autopsy. Officer-in-charge of Charghat police station said they are yet to find the motive behind the murder.

Our Sirajganj correspondent reports: With the rise of water level in the Jamuna due to downpour and onrush of water from upstream, erosion has taken a serious turn in Chowhali and Shahzadpur upazilas of Sirajganj district.

About 400 dwelling houses, two educational institutions, 300 km roads and five bazaars of the two upazilas have gone into Vast areas of Madan and Atpara the riverbed in last one month. The worst affected raeas are Gudibari, Jogtola, Bhatpara, Hatkora, Benutia and Kaizuri villages in Shahzadpur upazila and Jalalpur, Umorpur, Kaskawlia villages and upazila headquarters in Chowhali upazila.

Around 2500 homesteads, four educational institutions, three bazaars, 488 hectares of croplands, 90 hectares of land of dwelling houses and 2025 km roads in the areas are now under threat of erosion in this season, said a survey report placed by Centre for Environmental and Road communication between the Geographic Information Services

(CEGIS), an NGO.

Marking Gudibari, Chackzamirta, Bhatpara, Jogtola, Purbokherua, Kayanthai, Kashipur, Mowkuri, Garzan, Gala, Benutia, Jalalpur, Umorpur and Chowhali villages as vulnerable, the NGO men put 'red flags and 'yellow flags' at risky places and suggested villagers to shift to safer places as soon as possible.

During a visit to Kaizuri, Gudhibari, Bhatpara and Jogtola areas in Shahzadpur upazila yesterday, this correspondent found that many people, rendered homeless due to the erosion, have taken shelter on different roads and embankments.

Many people, who are preparing to shift their homesteads to safer places, expressed frustration over the authorities' failure to take proper initiatives to prevent erosion in Chowhali and Shahzadpur upazilas.

WDB officials in Sirajganj said they have written to the higher authorities asking for necessary funds to save the areas from the current erosion.

A correspondent adds from Feni: The embankment on Kahua River breached at two places of Teteswar village in Parshuram of Feni district yesterday noon due to the impact of the incessant rain and flash flood from hills of India, said WDB Feni official Md Nur Nabi.

Fulgazi Bazar in Fulgazi upazila has gone under two feet water as Muhuri River has overflowed.

Muhuri, Kahua and Selonia rivers are flowing 50 centimetres above the danger level at places.
