



Burnt oil, dyeing chemicals dumped into Buriganga

Apart from untreated industrial and household wastes, burnt motor oil, lubricant and dyeing chemicals are also contributing greatly to the pollution of the already moribund river Buriganga.

Motor oil traders collect burnt oil from muddy and pitch-black remnants are mind- Buriganga. lessly dumped into the river.

Manual dyers who dye mainly cloth of garment factories, especially jeans, are also no less. responsible for river pollution. After dyeing they also rampantly throw their leftover toxic chemical into river water.

refining burnt oil of launches while about 10 floating businessmen are involved in dyeing cloth on the riverbank, traders on the Buriganga riverbank said.

"Launch operators sell the burnt oil every two to three months. By the time each launch has around 20 litres of burnt oil," said Hafizur Rahman, driver of Sharnadip launch of Dhaka-Shariatpur route.

"The remains after the refinement of used oil is dumped into the river," said Dulal who once worked with a motor oil refiner.

During a visit to the riverbank at Telghat in Keraniganj on June 26 this correspondent saw a thick layer of black oil, which did not appear to be water at all.

Not only that, engine boats also release burnt oil into the river thus contributing to the pollution, said Abu Naser Khan, Chairman of Save Environment Movement.

University of Engineering and Technology (BUET) said any kind of oil pollutes water and increases the level of pollution, which affects the eco-system of the water body.

"No life in the Buriganga is alive because of endless pollution," he said.

Money-whitening scope to benefit the same people

Businessmen were 73pc of those who availed the earlier chance to whiten Tk 9,681 crore

The group of businessmen who comprised 73 percent of the beneficiaries of money whitening scope given by the last caretaker government will again get the larger slice of the cake as the government has decided to continue the provision for

About 57,000 persons availed themundisclosed money during the last caretaker government's tenure. The scope has been given again to benefit businessmen government. and politicians who are close to the pres-

ent government but did not get the chance then as they were either in jail or absconding abroad.

However, in the face of severe criticism of the provision, the government has added some conditions at the last moment, which have caused discomfort about how much benefit can be achieved from the scope.

JCD infighting comes to fore

Protests against newly formed central committee

Jatiyatabadi Chhatra Dal (JCD) is now grappling with internal conflict as a large faction of leaders at a protest rally yesterday declared its newly announced central committee unwanted on Dhaka University campus.

At the rally held in front of Ducsu Bhaban, the protesters said new committee leaders would not be allowed on the campus. They also urged the BNP high command to form a new committee comprising acceptable student leaders.

Main opposition party BNP on Wednesday midnight announced names of five leaders of the 101-member central committee of JCD with Sultan Salahuddin Tuku and Amirul Islam Khan Alim as president and general secretary respectively

Terming it as 'midnight committee', aggrieved leaders alleged that it has been formed with some 'controversial leaders' who have link with militancy and conspiracy against BNP during its critical time adding that no new leader has the studentship.

Pakistani security forces said yesterday that troops had killed more than 50 militants while ground and air forces battled against Islamist insurgents in parts of the northwest.
