# with Selim for joining militancy

Before joining banned Islamist militant outfit Jama'atul Mujahideen Bangladesh (JMB) about five years ago, Selim worked as a mason in Mumbai in India.

He became an expert in light weaponry, started collecting arms for JMB, and later rose to second in command and military affairs commander of Islam and Muslim, a new offshoot of JMB. Law enforcers arrested him from bordering Belpara Johorpur village of Chapainawabganj Sadar upazila on

Tuesday. Selim's father Durul Huda married Serina Begum around 28 years ago and Selim and Bedana were born to them, locals and family sources said.

When Serina came to know that Durul Huda was involved in robbery in Tanore of Rajshahi, she with her two children went to her parents' house at Charmohonpur in Chapainawabganj town and discontinued relationship with him.

With her small income from sewing nakshi kantha, Serina arranged schooling for her two children. Selim, however, could not come out successful in the SSC

He went to Mumbai to work as a mason. After one and a half years he returned to the country and worked in Dhaka and other places as a mason. During this time he came in contact with JMB member Jasim alias Rafiqul Islam of Nilphamari.

He persuaded her mother to arrange marriage of his sister Bedana, then a BA honours student in Nawabganj Government College, with Jasim.

When law enforcers at Shibganj caught Bedana's husband a year later, Bedana and Serina came to know that Selim and Jasim were involved with JMB.

Selim, who married Nuresha at Johorpur of Chapainawabganj Sadar upazila, at one stage stopped keeping contact with his mother and sister. He also married another girl in India.

"I am very unhappy and ashamed as my son and son-inlaw are JMB activists," said Serina Begum, now living with her daughter amid poverty and anxiety.

# Mother snaps link Villages in Sirajganj, Bogra flooded as Jamuna swells

With rise in water levels in the river Jamuna and its tributaries, fresh areas in three upazila of Sirajganj and a village in Bogra have been inundated.

Upazila.

In Sirajganj, about 50 villages in Kazipur, Shahzadpur and Chowhali upazilas have been submerged as the river Jamuna and its tributaries --Ichhamoti, Dharla, Karotoa, Bangal and Hurasagorswelled further due to downpour and onrush of water from upstream, according to our correspondent.

The badly affected villages are Maizbari, Monsurnagar, Chargrish, Khasrajbari, Natuarpara, Tekani, Nishchintapur, Shubhogachha, Polashpur, Sreepur, Ghorachora, Rangagari and Raghunathpur in Kazipur upazila; Kaizuri, Sonatola, Gudhibari, Jamirta, Beltail and Charkaizuri in Shahzadpur upazila; and Umorpur, Ghorzan, Khaskawlia, Jalalpur and a large portion of Chowhali upazila headquarters.

The affected families of these villages have taken shelter on high land, roads and embankments and at educational institutions.

Local administrations have closed at least 30 educational institutions, including primary and high schools, in the affected upazilas for an indefinite period.

Water Development Board (WDB) officials said water levels in the Jamuna and its tributaries will rise further in the next three or four days if rain continues. However, the Jamuna was flowing under the danger mark near Sirajganj town point yesterday afternoon.

The officials said if the newly built dam from Ranigram to Shimla is not protected from river erosion, the entire district will go under water.

## Probe into allegations of graft at HSTU begins

A five-member probe committee yesterday started investigation into alleged corruption in Hajee Danesh Science and Technology University (HSTU) since 2001.

Following a directive from the Ministry of Education, HSTU authorities formed the committee led by Prof Md Anis Khan, chairman of HRT, at the end of last June.

Other members of the committee are Saidul Haque Chowdhury, academic councillor of Bangladesh Agriculture University and member of HSTU regent board, Dr Boloram Roy, chairman of biochemistry and director of Information Technology, Shahidul Islam, former director general of Bangladesh Agriculture Research Institute, and Dr Fahima Khanom, director of Finance and Banking at HSTU.

On the first day, the probe team summoned 22 staffs of HSTU and 15 of them attended and spoke with team members.

Md Mosharraf Hossain Miah, who served as vice chancellor of HSTU from 2001 to 2006, later took charge as VC of Bangladesh Agriculture University at Mymensingh but was removed after an investigation by University Grants Commission in the end of cell phone.

2007 found several corruption allegations against him to be true.

Major allegations during the tenure of the former HSTU vice chancellor are embezzlement of huge funds, political appointments and nepotism, HSTU sources said. During that period, Tk 1.3cr was allegedly

misappropriated from Tk 10 crore construction work of Zia Hall. Tk 6 lakh was also embezzled in the name of installing V-SAT at the HSTU. According to the findings of the UGC inves-

tigation conducted in late 2007, the HSTU authorities during the tenure of former VC Mosharraf Hossain awarded printing work worth about Tk 2 crore to a printing press without any tender.

The probe report also held the former HSTU VC responsible for embezzling Tk 300,000 as house rent, telephone bills and fuels for vehicles.

At several meetings of HSTU Regent Board, board member former army chief Lt Gen (rtd) Mahbubur Rahman talked about the irregularities but to no effect.

Finally he resigned from the regent board on June 31 in 2006 in protest.

### Return of relief angers AL men

Awami League (AL) activists yesterday ransacked the offices of upazila chairman and Sadar union parishad in Amtali upazila town under Barguna district protesting return of relief items meant for the victims of cyclone Aila.

was sanctioned as relief for the Alia-affected families of ten unions in Amtali upazila, but it was returned as the UP chairmen did not receive it before the fiscal year ended on June 30 last, said Amtali Upazila Nirbahi Officer Md Nasiruddowlah.

Chairman of ten unions under the upazila were served notice on Monday to show cause for not receiving and distributing the government sanctioned relief items, he said.

"A few Awami League leaders came to my office at about 11:00am and asked me about return of the undistributed

relief items," said Amtali upazila Chairman Salahuddin Ahmed Talukdar.

After they left, a group of AL cadres entered the office and ransacked furniture and documents there, he said. Then the AL men went to

the Sadar union parishad office and damaged three motorcycles, computer, fan, About 220.5 tonnes of rice steel almirah, furniture, documents and other items at the office and looted Tk 5.2 lakh from the almirah, said UF Chairman Jalal Ahmed Fakir.

He said union parishad chairmen did not receive and distribute government sanctioned relief rice protesting AL men's unwanted interference in distribution work.

Amtali upazila Al President GM Delwar Hossain denied his party men' involvement with the attacks on the offices of upazila chair man and union parishad.

Distressed people deprived of the relief, may have done it, he said.

#### 4 get life for killing boy

A Faridpur court yesterday sentenced four people to life imprisonment for killing a teenage boy. Convicts Md Sayed, 25, Delwar Hossen ,30,Ismail ,32,of Radhanagar village under Nagarkanda upazila and Habib, 20, of Doyarampur village under Sadar upazila were also fined Tk 10,000 each, in default, to suffer six months more in jail. According to the prosecution story, Asaduzzaman Rony, 16, son of Mobarak Molla of Radhanagar village under Nagarkanda upazila went missing on April 14, 2006. He was going to his private tutor's house. Three days later his body was recovered from a field at Debinagar village. Arshad Ali, grandfather of Rony three days later lodged a case accusing four people of murder.

#### Six arrested for gangrape

Patuakhali Sadar police arrested six people yesterday on charge of raping a teenage girl in a room of Patuakhali General Hospital. The arrestees are identified as Ananda, 20, Sohag, 27, Pabel, 27, Munna Kumar Das, 20, Sajib, 25, and Sohag, 29. Police said one of the arrestees forcibly brought the 13-year-old girl from Alauddin children's park area to a room of the blood bank in the hospital and gangraped her. On a tip-off, a Sadar police team rescued the girl and arrested all six from the spot.
