Move to pay shady RPC contractor Tk 300cr

Ministry now pushes for paying LIPPS ousted in 2005 for sabotaging power plant; RPC to fight back pressure

The Rural Power Company (RPC) in August 2005 cancelled a plant operation and maintenance contract with Lahmayer International Pally Power Mymensingh plant, he won a verdict from Services (LIPPS) as it illegally shut down and "sabotaged" two 70-megawatt units LIPPS Tk 200 crore penalty for terminaof a Mymensingh plant.

The RPC also filed several cases against officials including the LIPPS chief who fled from the country not only for sabotaging the plant but also for committing a host of serious financial corruption.

The corruption charges include attempts to take over the RPC management. Their corruption affected RPC so much that the German government had cancelled 70 million euro grant marked for two power projects.

The LIPPS chief, a retired army official, then turned to a Singapore arbitration court in late 2006.

By showing a yet-to-be-effective contract for the third 70 MW unit of the that court which says RPC should pay tion of the contract.

Delay in paying this compensation adds other penalties, the verdict says.

The RPC however obtained a stay order from the High Court against effectiveness of the verdict made in Singapore.

Two separate investigation committees looked into the matter and pinpointed a host of irregularities committed by the LIPPS chief and several high officials of RPC to milk out as much money as possible from RPC.

The committees recommended taking actions against the accused including the LIPPS chief.

However, the committees' recommendations were in vain as no action was taken till date.

As it was the affair of a limited company, except the Rural Electrification Board (REB) which owns some RPC shares, neither the power ministry nor any other government organs have any business or role in this regard.

Surprisingly, after four years the power ministry in May suddenly initiated a move to make RPC pay LIPPS the Tk 300 crore as per the Singapore verdict.

More intriguingly, the ministry made the move on receiving a report sent by a top intelligence agency in Bangladesh in

### KCC councillor gunned down

Stance against canal encroachment might be behind the killing

Unidentified criminals shot dead Shahid Iqbal Bithar, ward councillor of Khulna City Corporation and presidium member of Jubo League, near his residence at Musalmanpara in Khulna early yesterday.

Sources said Shahid's tough stance against canal encroachers or intra-party conflict could be the motives behind the murder.

He was the convener of the 19-Shahid Iqbal Bithar member committee formed by the KCC to conduct eviction drives against encroachers of 22 canals

in Khulna city and its suburbs. Shahid reportedly received threats after the eviction drive was launched on July 2. Witnesses told the police that two persons riding a motorbike fired two shots at Shahid, 48, while he was returning home on a

motorcycle with his relative Mantu Shikder at around 12:45am. Mantu escaped unharmed.

The criminals fled the scene immediately.


#### Minister blames WDB for damage of embankment OUR CORRESPONDENT,

Communications Minister Syed Abul Hossain yesterday blamed the negligence of Water Development Board for the partial damage to Sirajganj town protection embankment by river erosion within 10 years of its construction.

He said the construction was affected by erosion due to lack of proper monitoring and maintenance by the officials of Water Development Board.

During his visit to the embankment site at noon, the minister told the journalists that unplanned lifting of sand from the riverbed and lack of supervision by the district administration possibly caused the collapse of the protection embankment.

# Rules defied in sand lifting near Buriganga bank

A group of people have been extracting sand on a large scale from the bank and adjacent shallow river bed of the Buriganga at Basila although they have permission for extracting sand from the middle of the river.

The activity allegedly backed by activists of the ruling Awami League is exposing the residential area to erosion and threatening to change the very course of the river. These people are also defying the permis-

sion given by Bangladesh Inland Water Transport Authority by using 14 powerful dredgers while they have permission for only

The whole activity is being overseen by armed men in at least three engine boats patrolling the river.

A number of residents of Basila said they had filed complaints in writing with Hazaribagh Police Station about the plundering of the bank and the adjacent river bed in the last 10 days but

police have remained mysteriously silent. Every day these hoodlums are extracting sand worth more than Tk 5 lakh.

BIWTA Deputy Director (Port) Golam Kabir admitted that their highest authority issued permission for three dredgers for 30 days. "But we never permitted anyone to extract sand in a way that may threaten a township and the course of the river," he said.

BIWTA Chairman Abdul Mannan Howlader said as per rules these dredgers are supposed to extract sand from the middle of the river, not from the bank.

A team of three Detective Branch policemen, led by Assistant Sub-Inspector Ahsan Habib, was patrolling the shore adjacent to ZH Sikder Women's Medical College and Hospital near the dredging site.

The law enforcers said they could not intervene in the matter despite their full knowledge that it was an illegal act.

### Banks must report stock portfolios every month

BB strengthens monitoring amid stock market scandal

The central bank has asked all banks to submit monthly reports on their stock portfolios, following unearthing of irregularities in share business by a Dhaka Stock Exchange investigation.

Banks from now on must submit detailed information about their stock portfolios by categories of purchase, mortgage, and deposit, sources said.

The monthly reports must be submitted within seven days of the next month to the Department of Off-sight Supervision of Bangladesh Bank on a regular basis.

For the month of June 2009, the report must be submitted by the 15th of this month.
