Ex-minister Aminul gets bail in 2 cases

The deep tub-well of BADC started operation at the village in 1982 but after supplying water for four years, it remained inoperative for 20 years. The BMDA in 2005 arranged connection of electricity with the water pump after necessary repair in the tub-well and about 80 bighas of land was brought under set up, BMDA Executive

For 240 to 300 families in Rahman said. The villagers, who had the village, an overhead water tank with 25,000-litre capacity drinking water supply has been set up at a cost of Tk 10 lakh, BMDA office sources said. Woman stabbed to death by son

A woman was stabbed to death by her son at village Bathil in Kahalu upazila yesterday. Rowshan Ara was stabbed to death by her son Raihan for not giving share of land to him. Raihan used to live at his father-in-law's house at nearby Kazipara, police said. He came to his father's house at about 9 in the morning and demanded share of land from his father Abdur Rahman Bachchu. On refusal, he beat up his father. At this stage, his mother tried to resist him. But he repeatedly stabbed on chest and back of his mother. His mother died on way to hospital. He also stabbed his father, younger sister Rabeya Khatun and aunt Masuma Khatun injuring them all who were admitted to Kahalu Health Complex for treatment. Later, Rabeya filed a murder case against her elder brother.

Physically challenged want reserved seats in trains

An 11-member delegation of physically challenged people yesterday met Rajshahi Railway West Zone general manager (GM) Musfigur Rahman at his office and handed over their 11-point demand to him.

After narrating plight of physically challenged people, the delegation led by Rajshahi unit coordinator of Action on Disability and Development (ADD) Sarkar Helaluzzaman Liton submitted their demands to the GM.

The demands include reserve seat for them at every compartment of train, their separate ticket counters at railway stations, separate charges in Feni, Sylhet restrooms and toilets for them, reservation of 10 percent recruitment quota at railway sector for them, providing wheel chairs for pregnant and elderly women, providing food to them at half the price at trains, half tickets for them and protection from all sorts of harassment at railway stations.

Later, the ADD coordinator told newsmen that the GM assured immediate fulfillment of their demands.
