## DEFIANCE OF GAZETTE NOTIFICATION Many river ports still under dist admin

Different district administrations in defiance of a gazette notification have evaded handing over of a number of declared river ports and foreshores to BIWTA for decades, causing anarchy in the conservation of rivers.

Bangladesh Inland Water Transport Authority (BIWTA) is the legal conservator of river ports and adjoining foreshore areas, but it lacks authority over them, leading to encroachments by leaseholders, anarchy in port management and loss of river navigability, said officials.

The concerned district administrations, on the other hand, lease out foreshore lands to private parties on permanent (99 years) basis letting in river grabbers and obstructions in normal commercial activities in the designated port areas.

They also permit sand extraction from river channels. As BIWTA is not involved in the process, sand trading goes at will virtually damaging the channels, said BIWTA officials.

Efficiency of a river port goes down if the foreshore within port limit is leased out for commercial uses with permanent structures.

BIWTA is enfeebled with lack of administrative power and manpower to take effective measures in view of river protection.

BIWTA Chairman Md Abdul Mannan Howlader said out of a total of 22 declared river ports in the country, half are yet to be handed over either fully or partially.

"We have written several times to the land ministry in this regard but to no avail," he said, adding, "BIWTA simply cannot assert itself on the port limit and foreshore unless and until it is handed over."

BIWTA Director Mahabubul Alam said until and unless a river port is handed over to BIWTA, the river authorities neither could develop port facilities nor earn revenues.

According to the Port Act of 1908, BIWTA is the

conservator of river ports, foreshore and port limit.

According to the Port Rules of 1966, river foreshore is defined as the submerged land lying between high-water mark and low-water mark of a river during ordinary spring.

The port limit extends 50 metres up from the high-water mark.

As per the port rules, no person can excavate and make any construction of any kind on the bed or foreshore of navigable waterways without any licence from the conservator.

Most of the foreshore lands, let alone port limit, are occupied by leaseholders with various permanent structures, said BIWTA officials.

BIWTA Joint Director Abul Bashar said the port rules specify required vertical and horizontal clearance in the river channel for smooth navigation.

The concerned authorities have written to the concerned district administrations time and again but to little avail.

Tongi on the Turag river was declared a port in 2004 but none of the Dhaka and Gazipur district administrations have yet handed over the port area, said Deputy Director of BIWTA Alamgir Kabir.

Foreshore of Chandpur river port has been out of BIWTA's control since 2003, as Chandpur district administration has not renewed the lease with BIWTA over a dispute of area, he said, adding that a joint survey was conducted during the caretaker government and the port area was ascertained as 80 acres.

Katolia foreshore of the port has been leased out indiscriminately on permanent basis to private parties, he mentioned.

The authorities have not yet handed over Meghna and Bhola river ports to the water transport authorities.

Narsingdi port was declared in 1960 and is yet to be handed over, said Kabir, adding that Barguna river port was declared in 1975 but is yet to be handed over.

Mirkadam and Ashuganj-Bhairab river ports were declared in 2004 but are yet to be handed over. Chhatak river port was declared in 2006 but it is still facing the fate. Charjanja port is not handed over to BIWTA.

Development of those ports has been uncertain and the government as a result is incurring a huge amount of revenues for years. River trading and management are also being hampered, said the BIWTA deputy.

Deputy Commissioner of Gazipur Md Kamaluddin Talukder said he was not aware of the matter, but adding, "I will look into it."

As per the law, khas (fallow) land of foreshore remains at the disposal of the district administration, he said.

Additional Deputy Commissioner (ADC revenue) of Dhaka Masud Karim said, "I am not supposed to talk to the media." The DC may respond to the issue.

Narayanganj ADC (revenue) ABM Aminul Nuri said the district administration used to lease out the port area until 1998. "We do not do it any longer."

He said the administration manages land under Tenancy Act of 1950 and Port Act and Eviction Ordinance of 1973. BIWTA is allowed as a lessee to use land of a port area on a contract between land and shipping ministries.

As per the tenancy act, land ministry is the owner of all lands, he said, "But I agree that port area should be under the authority of BIWTA."

Dr Kamal Abdul Naser Chowdhury, additional secretary to the information ministry, who headed a government-instituted committee on river pollution during the interim regime, said, "Obviously, district administrations cannot lease out the foreshore of a declared river port."

But the problem lies in lack of coordination among the agencies, he said.

"A dedicated river authority with enforcement authority under the Prime Minister's Office is imperative to protect the rivers," he said.
