High earthquake risk

In the zoning map of 1993, which was included in the BNBC, 26 percent of the country was high risk, 38 percent moderate and 36 percent low in terms of earthquake vulnerability.

ASM Maksud Kamal, an expert on earthquake and tsunami preparedness, said four sources of earthquake in the Bay of Bengal are active and can generate tsunami.

He said one of the sources generated an earthquake of 7.8 magnitude in 1762 which generated Fiche, waves caused by earthquakes in rivers and other closed water bodies, and around 100 people were killed in boat capsizes at that time in the Buriganga.

Kamal said all the four sources in the Bay called F1, F2, F3 and F4 have a capability of generating earthquakes of over 7 magnitude creating tsunami which will affect Bangladesh.

In that case the sea level will rise by 4-5 metres at Nijhum Dwip. The water level will rise 2-3 metres at the Sundarbans, Cox's Bazar and the estuary of the Meghna.

Kamal said seven major earthquakes struck Bangladesh during the last 150 years and only two had the epicentre within the country.

The Srimangal earthquake on July 8, 1918 was recorded at 7.6 on the Richter scale and its epicentre was in Balisera valley near Srimangal. Although there was damage, the intensity rapidly decreased due to the shallow focal depth and only minor effects were felt in Dhaka, he said.

The Bengal earthquake of July 14, 1885 caused considerable damage in the Sirajganj-Bogra region and perhaps more severe destruction in Jamalpur-Sherpur-Mymensingh region. The magnitude of the earthquake was more than 7.0 on the Richter scale and the epi-cenergy, he said he are centre was at Manikganj, he added.

The great Indian earthquake of June 12, 1897 that had a magnitude of 8.7 with the epicentre in the central part of the Shillong plateau was recalled as one of the world's worst.

Based on the epicentres of earlier earthquakes, Dhaka has crossed 130 years, Chittagong has crossed 250 years and Sylhet about 100 years, which now raises the prospect of a major earthquake striking Bangladesh, said Kamal.

He observed that fault zones like Dauki fault zone, Shahjibazar fault zone and Tripura to Assam fault zone are very active and have been generating energy for quite a long time but as no earthquake occurred in those areas, it is a matter of time before the big one strikes.

Prof Ansary said eight fault zones are active in Bangladesh. They are Bogra fault zone, Tanore fault zone in Rajshahi, Tripura fault zone, Sitakunda-Teknaf fault zone, Dauki fault zone (Haluaghat Fault), Dhubri fault zone, Chittagong fault zone, Shahjibazar fault zone (sub-Dauki fault) and Rangamati fault zone

He said any minor earthquake might be due to the activity in the local small fault zones, thus increasing the chances of a major jolt happening. Besides, Ansary felt a strong earthquake could occur in the plate boundaries as the 100-year alarm bells have passed.

Bangladesh is close to the meeting point of the Indian, Eurasian and Burma (Myanmar) plates. The movement of Indian and Eurasian plates has been locked at the foot of the Himalayas for many years, storing strain

Ansary explained. Three strong earthquakes were recorded from the Indian-Eurasian plate, which jolted Bangladesh within 150 years, said Ansary.

reported anywhere. But the Mandelay earthquake that struck in 1858 with a magnitude of 7.9 did affected Chittagong division, he added.

2 Bangladeshis die in Malaysia after inhaling poisonous gas

Six people including two Bangladeshi workers died yesterday after they accidentally inhaled poisonous gas produced by a container of rotten fish, Malaysian police

A senior officer said the incident happened early Tuesday at a remote fishing village in Tanjung Karang, north of the capital Kuala Lumpur, when the workers were unloading the container.

"Two Bangladeshi workers were taking out the rotten fish meant to be used as fertiliser from a container when they inhaled the (toxic) gas," acting district police chief Zulkifli Jonit told AFP.

"They suffered breathing difficulties and then collapsed. Four others who tried to offer help also inhaled the it will let out the strain gas and died," he added.

Children's textbooks

Most of the books, especially Bangla of class III and IV, Paribesh Parichiti (Samaj) of the same classes have smaller front cover illustration.

Besides, pictures and texts in some books, especially mathematics of class II and I, are so crowded that they give headaches to students rather than creating a relaxed mood.

Which is why, the government has recently formed a five-member committee to bring changes in the cover designs and illustrations of the textbooks so that they appear to be engaging to students, said NCTB Chairman Mostofa Kamal Uddin.

Headed by Prof Rafiqun Nabi, dean of the fine arts department of Dhaka University, the committee will look into the matter, he said.

The academics say illustrations give children a fuller understanding of the book's contents and these should be crafted carefully so that they go with the story and give the children a clear conception of what the story is telling about.

When multi-colours are being used in textbooks across the globe to make it appear more gripping and intriguing to children, most of the textbooks of NCTB, except the books in class I and II, have only black and white colour illustrations.

Sources said NCTB hires some inept artists for the illustrations of the textbooks responsible for the poor quality of pictures and sketches.

Experienced and competent artists are not interested in doing illustrations of NCTB's textbooks as the board offers a negligible amount of money for the job, they said.

Talking to The Daily Star, noted artist Prof Hashem Khan said illustration is as important as the texts, because children learn mostly through visual entertainment, but the authorities concerned don't seem to give proper attention to it.

"Children get flabbergasted at the very early stage if they do not find pleasure in their books and school," he said, adding that it is unfortunate that the illustrations in most of the

haphazardly, which are not

appropriate for the children. Prof Hashem who used to do illustrations for NCTB books, said apart from illustrations, designs of books meaning that the proportionate presentation of texts and pictures, and bookbinding are also

very poor. "Crafting illustration for the children is not an easy work as it needs proper merit, training and expertise," he added.

"It is believed that two kinds of writers are there for children's book -- ones who write books while the others are illustrators. The latter is neglected in our country," Hashem lamented.

Eminent educationist and writer Prof Muhammad Zafar Iqbal told The Daily Star that the illustrations at the primarylevel books are not at all appropriate for the children.

"Most of the pictures seem to have been done insincerely and in some cases it is hard to find consistency between the texts and pictures," he said.

Though four colours have been used in the pictures of some books, they are not vivid, he said, adding that the condi-

tions of Madrasa books are extremely bad. "Illustration is one of the important mediums for teach-

ing children," he said, adding: Books for the children, especially the younger ones, should be picture based and they should have large, beautiful, colourful and eye-catching illustrations and simpler texts. M Siddiqur Rahman, a

professor at the Institute of Education and Research of Dhaka University, said proper language and attractive illustration are equally important while giving any idea to the children as they can memorise a topic easily through pictures.

"The cover page along with other pages and the bindings also cannot be considered as good-looking and durable," he

"I think NCTB crammed too many smaller pictures and texts together in a single page only to reduce the cost," he

Prof Rahman, also a member of National Education Policy Formulation textbooks have been designed Committee, said the quality of

the textbooks will not be changed if non-professional

people do the job. NCTB Chairman Mostofa Kamal Uddin, however, claimed that the prominent artists do the complicated

illustration works. "Multi colours have never been used in the illustration at primary level as it is a huge task," he said, adding that they will do their best to make the books attractive to children.

Power plant workers go on strike

The workers of Barapukuria 250MW power plant went on an indefinite strike yesterday to realise their 11-point demand including festival bonus and increment.

They also demanded cancellation of the ongoing process to recruit manpower through a recruiting agency, Zahir Traders.

Sources said around 300 workers started the strike at 8:30am yesterday as the plant authorities and the agency did not heed to their demands despite repeated appeal. Md Khairul Islam, presi-

dent of Barapukuria Power Plant Workers Association, said that they got their appointment through Zahir Traders. According to the agreement between the workers and the agency, workers would get wage increment every year, but they are being deprived of it. When contacted, Chief

Engineer of the Power Plant Bishwa Nath Haldar confirmed the incident and said that the strike will hamper smooth power generation. However, the workers

agreed to lift the strike for an hour from 7:30pm following a meeting. Sources said the workers
