

## BAIL TO TWO HUJI MEMBERS

## Hearings adjourned until Sept 9

Two Dhaka courts yesterday adjourned the hearings till

September 9 on the government petitions seeking cancellation of bails granted earlier to two Harkatul Jihad

(Huji) members in connection with the August 21 grenade attack cases. The hearings were

adjourned as the detained accused Munshi Mohibullah, brother of Huji chief Mufti Abdul Hannan, and one of his accomplices Arif Hassan Sumon were not produced before the courts due to heavy rainfall.

Meantime, the two Huji members yesterday submitted written statements against the show cause notice issued by the court asking them why their bails shall not be cancelled.

Judge ANM Bashir Ullah of the Metropolitan Sessions Judge's Court adjourned the hearings of the murder case while Judge Fozila Begum of the Second Additional Metropolitan Sessions Judge's Court adjourned the case filed under the Explosive Substances Act.

The grisly grenade attack was on an Awami League rally at Bangabandhu Avenue on August 21, 2004 that left 23 people including AL leader Ivy Rahman dead and 300 others injured.

The next day, two cases were filed -- one for murder and the other for blasting grenades on the rally.

Earlier on August 12, Judge Masdar Hossain of the Speedy Trial Tribunal-1 granted bails to them on grounds that they didn't have direct involvement.

Following the orders, Chief Prosecution Counsel Advocate Syed Rezaur Rahman submitted two petitions seeking cancellation of their bails.

## Karwan Bazar Triple Murder: 4 BNP leaders sent to jail

A Dhaka court yesterday sent four accused to jail after they surrendered before it and sought bail in the Karwan Bazar triple murder case.

The accused are Nabi Solaiman, former religious affairs secretary of Juba Dal central committee, and city BNP leaders Sayeed, Nurul Islam and Lutfur Rahman.

Judge ANM Bashir Ullah of the Metropolitan Sessions Judge's Court passed the order after they along with their lawyers appeared before it and sought bails in the case.

In his order, the judge said if they get bail they would create obstructions in investigating the case. So, their bails have been rejected and sent to jail.

Moving the bail petitions, lawyers told the court that their clients had earlier on July 13 surrendered before the High Court (HC) and sought anticipatory bail. But the HC, without granting bail, directed them to appear before the lower court within eight weeks.

In the meantime, the law enforcement agencies were directed not to harass or arrest them within the period, the HC said.

On the other hand, the prosecution told the court that six accused had earlier given confessional statements to magistrates implicating the four accused. Moreover, the four are FIR (first information report) named accused. So, the prosecution prayed for sending them to jail.

After hearing both the sides, the judge rejected their bails and ordered to send them to jail.

Faruque Mollah, Ashraf Miah and Nuruddin Sarkar Jewel were gunned down at Karwan Bazar on June 26.

Mobarok Hossain Mollah, brother of Faruque Mollah, filed a case with Tejgaon Police Station the same day against the accused and seven other unknown persons in this regard.

## 2090 more held

Police arrested 2,090 people on various charges in separate drives across the country in 24 hours as of 6:00am yesterday.

Twenty firearms, six cock-tails and 46 bullets were also seized during the countrywide drive, said a release of police headquarters.

Besides, 23 motorbikes were seized during the drive for not having valid documents and 306 cases filed in this connection.
