## Robbers loot Tk 1.62cr from Natore bank

Robbers took away Tk 1.62 crore from National Bank Kanaikhali bus stand branch in the town sweeper as he found a new lock at the collapsearly yesterday.

Police arrested night guards Khattab Ali and tacted with bank manager and other staff. Zufikar Hossain, suspecting their involvement in the robbery. They also picked up senior officer Belaluddin, senior officer (cash) Shahadat Hossain and second officer Rabiul Islam for interrogation.

Police and bank sources said the robbers entered the bank, breaking open the lock of the collapsible gate on the first floor of a threestorey building early yesterday. The gang then broke the vault of the bank and looted Tk 1.62 crore, they added.

#### AL leader killed in Another RU Shibir Netrakona clash leader held

An Awami League leader was killed and 25 others were injured in a clash over land dispute at Nayakpur village under Madan upazila of the district yesterday morning.

The dead, Menu Mia, 45, was the vice president of Awami League Nayakpur union unit.

Locals and police said Menu Mia and Nuruddin Haji of Nayakpur village had a long-standing dispute over the ownership of a land at the village. When Nuruddin and his men tried to capture the land in the morning, the supporters of Menu Mia counter-attacked them.

Both sides used lethal weapons during the clash that continued for three hours. Menu Mia was killed on the spot and 25 others from the clashing groups were injured.

Of the injured, Sayedur Rahman, Bakki Khan, Abu Mia, Mostafa Khan, Rukan Khan, Habi Khan, Humayan Kabir, Mazharul Islam were admitted to Mymensingh Medical College Hospital while the rest to Madan Upazila Health Complex.

On information, police rushed to the spot, dispersed the clashing groups and brought the situation under control. Police have been deployed at the village as a tens situation is prevailing there.

A murder case was filed Madan Police Station at noon. Police arrested eight people, including Nuruddin Haji, in the afternoon.

#### Transport strike called off

Road communications in six districts of Barisal division resumed yesterday morning after the bus owners and workers called off an indefinite strike. The wildcat strike was called on Sunday protesting seizure of two buses by police for plying without valid certificate and route permit on Natunbazar-Babuganj road. Aftab Hossain, city Sramik League convener and Barisal Road Transport Workers Union president said, the strike was called off as the authorities released the two detained buses and promised to take steps to stop harassments.

#### Bail prayer rejected

A Rajshahi court yesterday rejected the bail prayer of district BNP's former general secretary Shish Mohammad in the Anti-Corruption Commission's (ACC) case accusing him of illegally amassing wealth worth over Tk 89 lakh. Abdul Karim, deputy director of Rajshahi ACC pressed charges against Shish Mohammad in April this year in connection with a case with Tanore police station. In the charges pressed under Section 27 (1) of the ACC Act of 2004, Karim alleged that Shish owns wealth around Tk 95 lakh, out of which Tk 89,47,607 were amassed beyond his legal sources of income. A close aide to former BNP minister Barrister Aminul Haque, Shish is now in jail. Both Aminul and Shish were convicted in a case for abetting militancy and given 31 and a half years imprisonment.

#### JCD leader gets 10 yrs RI

Additional District and Sessions Judge-III, Sylhet, also Special Tribunal Judge Md Belayet Ullah yesterday sentenced a JCD leader to 10 years RI in an arms case. Convict Imranul Karim Chowdhury is joint convener of Fenchuganj Degree College unit of JCD. According to the prosecution story, Rab men arrested Imranul following recovery of a pipe gun from his house at Karimpur village in Fenchugnaj on November 16, 2008. Rab also filed a case against him. Police later filed charge sheet against the arrestee. The judge pronounced the verdict following testimony of eight witnesses.

#### Abducted child rescued, 6 held

Judge of Children and Women Repression Prevention Court Md Shamsul Huda handed down the verdict in a crowded courtroom after examining the witnesses.

#### Memo to Khulna DC

Mayor went to the office of the DC on foot and without any police protection. When asked, Khaleque said he went there as president of Khulna City Awami League, not as mayor. Bithar, also a ward councillor, was shot dead by extremists on July 11 in front of his residence at Musalmanpara.

The affected people have taken shelter in the cyclone centres where they are staying in sub-human condition amid accommodation problem and want of food and drinking water.

Those who have somehow managed to stay in their flooded houses are also in urgent need of food.

Clay-made houses of all inundated villages have collapsed due to onrush of water flowing over the rivers in Dakope and Koira upazilas.

Road transport in inundated roads has remained suspended since Saturday.

Terming the situation as quite alarming, upazila nirbahi officers (UNO) of Dakope and Koita upazilas said they are not in a position to provide any help in cash or kind to the affected people until fresh fund is provided for the purpose.

Our Satkhira correspondent reports: Over 50,000 people in 67 villages under ten unions in Tala upazila have become marooned as silted The recent natural calam- Kabodak River, fed by rainwa-

ter during three days' downpour, overflowed its bank and flooded the area.

The road link between Satkhira and Khulna remained suspended since Sunday as Satkhira-Khulna road at Noapara in Tala upazila has gone under two to four feet water.

The affected people have taken shelter on high roads or educational institutions.

Vast tracts of submerged land under Sarulia, Islamkati, Kumira, Tentulia, Dhandia, Jalalpur, Nagarghata, Islamkati, Magura and Khalishkhali unions see water logging as silted up Kobadak River cannot absorb the water, sources said.

The recent floods have destroyed newly transplanted Aman plants on about 5000 hectares of land, 245 shrimp enclosures, 1674 ponds used for fish cultivation and betel leaf worth over Tk 5 lakh in the area, sources in the agriculture and fisheries department said.

### Elephants destroy four houses in Rangamati

Wild elephants Sunday night destroyed four houses at Amchharimukh, some 20-kilometre away from the district headquarters.

Locals said, 12 elephants entered the localities at Amchhari and Rangapani in search of food. They destroyed four thatched and tin-shed houses at Amchharimukh village under Sapchhari union of Sadar upazila.

The destroyed houses belonged to Harbo Chakma, Kayilya Chakma, Kanchan Mala Chakma, a widow and Posuram

Later, the herd entered the forests of Rangapani. However, they neither attacked the villagers nor their orchards there.

"These elephants most probably came to Rangapani from Pablakhali Reserve Forests," said Moeen Uddin Khan, divisional forest officer (DFO) of CHT North Forest Division.

The wild elephants rarely harm anybody if they are not harmed by people, Moeen added.

Wild elephants nowadays often come to localities in Rangamati in search of food as most forest areas have been denuded by the loggers in connivance with a section of dishonest forest officials in Chittagong Hill Tracts (CHT), sources said.

### Transfer of teacher. triggers protest

Aggrieved at transfer of a teacher, students of Jhenidah Technical School and College yesterday ransacked the college including the principal's room.

Police arrested computer science teacher Jamiul Islam on charge of instigating the students.

Agitation spread among students after hearing that Technical Education Department had transferred Jamiul to Bhola, said Jhenidah Sadar Police Station Officer-in-Charge Motiar Rahman.

A group of 20/25 students entered the principal's room yesterday noon and damaged a laptop, printer, fax machine, almirah, chairs and tables, he said.

The agitating students said Principal Mahbub Haider recently issued a show cause notice on Jamiul on charge of neglecting his class but the teacher takes classes regularly and he was present on the day mentioned in the notice.

To solve the problem, arbitrations were arranged and the students submitted a memorandum to the deputy commis-

But Jamiul was transferred to Bhola following investigation by a one-member probe committee of the Technical Education Department.

Students alleged that the principal 'arranged' the teacher's transfer without any reason. Asked about the matter, Principal Mahbub Haider said,

When I was monitoring the school on July 30, Jamiul Islam was not in his class. Being instigated by the teacher, students got involved in destructive activities."
