# Future bleak as 'nation' builders' in bad health

All 202 students of a school found unwell

All the 202 students of Balagram UC Government Primary School in povertystricken Balagram union of Jaldhaka upazila are suffering from different diseases due to malnutrition, lack of medical facilities and unawareness of

The alarming situation came to light after Jaldhaka Upazila Nirbahi Officer (UNO) and Upazila Health and Family Planning officer (UHFPO) visited the school with a medical team to test the students' health condition last week.

At first test on 65 selected students showed that all are suffering from various diseases. Twenty-five of them were found seriously sick.

Being curious, the team tested all the remaining students and found them suffering from some common diseases.

Many of them were found suffering from anaemia, intestine disease, malnutrition, scabies, weight loss, undevel-

oped mental growth etc. members that they come to school everyday without having meal and there is also no certainty of getting any food even after returning home from school. They feel pain in the stomach during school

#### Stepfather kills boy

A 6-year-old boy was killed yesterday allegedly by his stepfather at Kristapur in the town. Police said, victim Ripon's mother Renu Begum, a domestic help was married to one Swapan of Kristapur a few years ago. Yesterday Renu went out of house in the early morning leaving Ripon with his stepfather. As Ripon did not find his mother after waking up from sleep, he started crying and that angered Swapan much. At one stage, Swapan beat up Ripon mercilessly injuring him critically. The boy died on the spot after sometime. The body was sent to Mymensingh Medical College and Hospital (MMCH) morgue for autopsy. Police arrested Swapan after Renu Begum filed a case with Kotwali police station.

#### Traffickers held, 15 rescued

Locals and police said at dead of night, the robbers numbering about 15 entered the house of Soab Ali at Noarai village. They gave the inmates a good beating and chopped some of them with cleavers. Soab Ali, his sons Saleh Ahmed and Shahed, daughter in-law Razia Begum and daughter Zabeda sustained serious wounds. The robbers took away Saleh Ahmed's passport, gold ornaments and other valuables worth about Tk 3 lakh from the house at arms point. Saleh was scheduled to return to Saudi Arabia on the day.



# Villagers attacked for speaking out against chairman's son

At least 25 people were injured as miscreants, led by a son of Jaldhaka Upazila Chairman Sayed Ali, attacked Chengmari village on Wednesday night.

Five of the injured were admitted to Jaldhaka Upazila Health Complex while the rest to private clinics.

The villagers came under attack as they gave their statements to the police in connection with a case filed against Shaful Islam Babu, son of Sayed Ali, also a rokan of Jamaat, on the day.

Babu was sued on September 8 on charge of assaulting Imrul Haque, 42, son of Ehsan Uddin of the same village over a trivial matter at Baro Ghat village of Jaldhaka upazila on September 7.

Seriously injured Imrul was admitted to Jaldhaka Upazila Health Complex. He filed the case with Jaldhaka Police Station, accusing Babu and some of his associates of assaulting him in front of a cold storage owned by Babu's father Sayed Ali. The attackers on Wednesday night also

detained a villager named Tofizuddin at the cold storage and beat him up for giving statement against Babu. He was later rescued by police.

Tofizuddin yesterday filed a case against Babu and 20 others for torturing him at the cold storage, police said.

Protesting the attack on the villagers by upazila chairman's son, several hundred people took out a procession at Jaldhaka upazila headquarters yesterday demanding immediate arrest of the attackers.
