Dhaka to seek UN tribunal

Decides to refer sea limit row with India, Myanmar to the world forum; decision taken as bilateral talks failed

Bangladesh will go to the United Nations arbitration for a resolution of its long-standing dispute with India and Myanmar over maritime boundary.

Announcing the decision at a press briefing yesterday, Foreign Minister Dipu Moni said the government has decided to take the matter up with the UN, as talks over the last 35 years could not settle it.

"We are submitting the issue to compulsory arbitration under the United Nations Convention on the Law of the Sea (UNCLOS) to ensure our sovereign rights to the natural resources in the Bay," Moni noted.

She, however, said bilateral discussions will go on.

Earlier in the day, her ministry called in the Indian high commissioner and Myanmarese ambassador in Dhaka and gave them



MYANMAR BORDER Govt mobilises troops

Bangladesh has reinforced its troops along the border with Myanmar as tension went high following repeated provocative acts by the latter's military forces including violation of international border and illegal construction of barbed-wire fences along the frontier.

Highly-placed sources in the government said the reinforcement was required as the Myanmar military junta deployed huge troops with heavy weapons within five kilometres of the border and many of them frequently intruded into Bangladesh territory, added the sources.

Bangladesh in the past always resolved all disputes with its neighbours through bilateral discussion but this time the authorities had taken it seriously and they are taking steps accordingly, said the sources.

The tension ran high as Myanmar troops fired several shots towards Bangladesh territory, witnesses said.

ACC probing 'graft' by 5 political bigwigs

The Anti-Corruption Commission (ACC) has initiated enquiries into the charges of misuse of power and amassing wealth by illegal means against five former and incumbent lawmakers of Awami League and BNP including Amir Hossain Amu and Khaleda Zia's younger brother Sayeed Eskander.

The other politicians are AL lawmaker MA Mannan, and former BNP ministers Mirza Abbas and MKA Anwar.

Of them, enquiry is being conducted

on charge of amassing wealth illegally by Amu, Mannan, and Sayeed Eskander while for misuse of power against MK Anwar and Mirza Abbas.

"We have started enquiry into the allegations of misuse of power and illegally amassing wealth by them," ACC Chairman Ghulam Rahman told reporters yesterday.

If enquiry finds the allegation substantiated, legal actions will be taken against them. The commission would not backtrack on taking action against anyone whether they are from the ruling

party or the opposition," he added.

Sources in ACC said the enquiries have been initiated following allegations from individuals. The committee scrutinising allegations at the commission has found the allegations worthy of enquiry.

This is the first mentionable effort made by the anti-corruption body since Ghulam Rahman took over office over three months back.

The allegation brought against MK Anwar is misusing his power in selecting his daughter in BCS examination. BNP's

DMP lets 3,800 unfit vehicles off the hook

The Dhaka Metropolitan Police (DMP) has let off 3,800 of the 4,300 unfit vehicles, seized in a month-long drive before Eid-ul-Fitr, on condition that they would not be run on city roads.

However, most of those outdated vehicles including buses and pick-ups have returned to city streets in violation of the agreement.

DMP had launched the special drive as part of the present government's bid to ease nagging traffic congestion in the capital. But the drive seems to go in vain as the city residents continue to experience severe traffic jam in city streets.

The traffic department pointed out running of huge number of private vehicles on roads as one main cause of tailbacks.

Sources said many of the seized buses have already made their way back to city roads with faulty signal system and engines after being coated with paint.

Traffic department personnel along with members of the crime division, Ansar and community police have already been engaged in the move to deal with increased traffic congestion, DMP Commissioner AKM Shahidul Hoque said on Wednesday.

"We are trying our best. But the situation has gone out of control as the number of motor vehicles has gone beyond the capacity of city roads," he said.

The DMP Commissioner said they had returned 3,800 of the 4,300 unfit vehicles to their owners taking bonds that those

Protect Turag, Buriganga HC directs authorities again; asks 4 govt high-ups to visit grabbed areas in 7 days

The High Court yesterday issued further directives upon the authorities concerned to protect the Turag and Buriganga rivers from grabbers as construction of illegal structures and earth-filling continue at some points despite several similar directives.

The HC directed four government high

officials to stop all kinds of encroachment and earth-filling on these rivers.

The court ordered them to visit in seven days the areas on the Turag and Buriganga where land grabbers are continuing earth-filling.

The officials are the chairman of Bangladesh Inland Water Transport Authority (BIWTA), the director general of the Directorate of Environment, the

deputy commissioner of Dhaka and the commissioner of Dhaka Metropolitan Police (DMP).

The division bench of Justice Syed Mahmud Hossain and Justice Quamrul Islam Siddiqui also directed them to submit a report to the HC through its registrar within seven days after visiting the areas.
