

## Stop Turag encroachers

*Admin must swing into action*

THE grabbers have become desperate in their ravenous greed to take hold of as much of the land as possible from the different rivers surrounding the capital city. It has again become glaringly evident from the way they have given a damn about the High Court (HC) verdict of June 24 last as well as government warnings to that effect against encroachments on the rivers surrounding the capital city.

To all appearances, during the last three and half months since the HC order was issued, nothing of substance has been done by the executive branch of the government to act and stop the grabbers from continuing with their wicked activities. Otherwise where does these grabbers get the audacity to defy HC and the government? The land grabbers, whoever they may be, are certainly not from another planet so that they do not understand the message of court or government orders!

If truth be told, it is not for the first time that the land grabbers are at work to eat up a river, in the present case, the Turag. All quarters are fully aware of how some vested quarters are out to gobble up government lands everywhere. During the successive governments in the past as well as after the incumbent one took office, a number of operations were launched to free the Buriganga river from the grip of encroachers. Oddly enough, in every case it was observed that as soon as the magistrates and the members of the law-enforcing agency left the scene, the grabbers would return and start carrying on with their business as usual.

In fact, the government's apparent lack of action to discipline the vested quarters in question has only emboldened them further to go on with their grabbing spree. Unfortunately, such a situation has forced the well-meaning ones to bring the case to court for the second time to issue rule on the government so that it may swing into action to discipline the Turag grabbers.

This is an unacceptable situation. It is time for the government to put its foot down and bring those behind encroachment of Turag and other rivers to justice.

## Commandeering land in Sitakunda

*Those who have done it must be penalized*

IT makes disconcerting reading because the incident militates against values and the social principles we have always held dear. News reports relating to what the son of a ruling party lawmaker has been doing in Sitakunda --- he and his associates have simply laid claim to land belonging to four ship-breaking yards along the coast --- are once more proof of the impunity with which the powerful disregard the law. As if recent reports of intimidation and grabbing of property in various parts of the country were not enough, this latest incident of a commandeering of land can only push us again into asking questions neither we nor anyone else can be comfortable with. Suffice it to say for now that what the lawmaker's child has done is a clear and unabashed violation of not only the law but of moral principles as well.

The young man and his goons have only compounded matters for themselves. They have even assaulted newsmen who, as part of their professional duties, tried to unearth the truth behind their act. One was beaten up, while the other had his camera snatched away. Now, such behaviour certainly reflects badly on the one indulging in it. But when it is an individual or a group of individuals who, taking advantage of their links with an influential politician, try give short shrift to the law, it is a whole society which is threatened with disorder, perhaps even anarchy. We have written earlier, and especially since the present government took over in January this year, of the need for the ruling Awami League leadership to rein in its followers and others engaged in deriving advantages through being close to it or working in its 'protective' shade. From time to time, we have heard of the prime minister and her cabinet colleagues sounding notes of warning to the more raucous ones among their camp followers. Despite all such warnings, sometimes exhortations, not much seems to have worked. And it is not just the younger elements in or around the ruling party who have been giving everyone a headache. It now appears that there are MPs and their families who have not stayed far behind those others in casting their disturbing shadows on life.

In the Sitakunda affair, claims and counter-claims have been made about who owns the land in question. That is beside the point. What clearly has happened is an attempt on the part of an individual to grab property not his. Which is why the law must come in. Those who have committed the misdeed must face the full force of the law. There can be no alternative here.

THIS government seems to be more focused on providing security to the political elites who are otherwise fortunate and powerful enough in this country to take care of their security, both physical and financial. Supposing the babies who died before they could blossom into full-grown men and women had been the children of our ministers and lawmakers, would not the government have moved heaven and earth on this issue? Would not the minister of health have been sacked? Nothing of this sort has happened because it concerns the health of the common people of this country.

A much-prized possession of a girl or a young woman is her chastity. It leaves a girl virtually dead and traumatised, and her family devastated, when she is raped. In our society, a girl or a woman raped by criminals is looked down upon and condemned as an object of shame and pity, while rapists move about freely. In a country where Islam is the religion of the overwhelming majority of the people, it is a pity that women are being raped and degraded on a scale never seen before. Thanks to the revolutionary advancement in the media, we now get to know all that is happening around us and even in the remote countryside.

There is hardly a day when rape is not committed in this country. But not a single voice has been raised in the parliament condemning rape and rapists. Why this is so is not difficult to understand. It is because the victims of rape belong to families of poor people, the working class. It is also because the rapists happen to have a political tag attached to them, the tag being that of an activist of the ruling political party.

No wonder the police and the local administration behave as if they see no

Emboldened by the partisan and loyalist attitude of the local police, these political thugs have not only raped the poor girls but have also made video films of their sinful acts with the help of mobile phone. Leave aside public lashing of the rapists, not a single rapist has been arrested by the police and put on trial. Ah! In one bizarre case of gang rape, the local AL leaders punished the rapists in vigilante style.

As the story goes, as many as 16 local activists of the ruling party in Kalapara (DS front page of October 6) abducted a class V11 school girl, raped her one by one and then left her, which created a sensation because on that day the local MP and state minister for water resources was present in Kalapara. Two days later, the

local AL leaders sought to settle the matter through arbitration. They fined the rapists Tk.10,000 each and beat them up. Tk 1,60,000 realised as fine was handed over to the parents of the victim. The police looked on as spectators as the arbitration was going on.

The family of the victim, including the victim herself, is under constant vigilance by the rapists. Later on, the deputy commissioner and the superintendent of police of Patuakhali visited Kalapara and quoted the victim as saying that she was not raped. The DC and the SP did not feel the necessity of having the girl medically tested to ascertain whether the girl was telling the truth. The matter ended there.

The government and the local administration failed to provide security to the poor family of this victim of rape in the first instance. Now they have also denied the family justice for the wrongs suffered. Who will these poor people of this country turn to for security and justice?
