## Tamim gives Premier T20 a kick-start

Tamim, who joined Mohammedan this year from Abahani with a record-equalling transfer fee, was arguably the chief entertainer on the opening day of the season's curtain-raiser, hammering 13 fours.

And it was Rahman's wrong judgement on a single that drew the curtains on a thoroughly entertaining knock from Tamim. Mohammad Ashraful strode in and played some innovative shots and gave

good company to Rahman who played a sedate yet effective knock of 42 runs off 48 deliveries. Ashraful lasted 23 runs and all-rounder Aftab Ahmed scored 30. Power hitting in the last five overs yielded 54 runs and lifted the score to 174 for the loss of four wickets after 20 overs.

The score proved more than enough for Mohammedan as their opponents never kept in pace with the run rate after a very cautious first five overs where they scored only 29 runs. Captain Mohammad Sharif's 42 and Ashraful Aziz's 26 were the only notable contributions in a lost cause. Mohammedan spinner Nabil Samad took two wickets conceding only 16 runs. Tamim Iqbal, for his extravagant batting, was adjudged man-of-the-match.

Abahani, without their inspirational captain Mashrafe Bin Mortaza and world's best allrounder Shakib Al Hasan, laboured to a threewicket win against Kalabagan Krira Chakra under lights at the Sher-e-Bangla National Stadium.

National captain Mashrafe and his deputy Shakib sat out the match, nursing injuries.

#### 'It's an Indian propaganda'

Pakistan National Assembly's Standing Committee on Sports has rejected all matchfixing allegations levelled against captain Younus Khan and coach Intikhab Alam, saying it was all Indian propaganda to tarnish Pakistan cricket's image. The committee, which had summoned Khan and Alam along with the Pakistan Cricket Board chairman Ijaz Butt to explain the reason behind the team's defeat in the ICC Champions Trophy, said there was no authenticity in the matchfixing allegations.

It blamed the Indian media for fanning the issue and said it was an Indian propaganda to tarnish Pakistan cricket's

The committee pointed out that that the level of umpiring in the Pakistan New Zealand was poor, and blamed umpire Simon Taufel for

Pakistan's defeat in the match. The members of the committee decided to report the issue to the International Cricket Council (ICC), by asking it to take appropriate action against Taufel, The Daily Times reports.

## Younus resigned due to fixing claims

Disgruntled Pakistan captain Younus Khan said Wednesday that match-fixing claims were behind his shocking offer to resign and that he was hurt by an investigation into his team's Champions Trophy defeats.

Younus tendered his resignation on Tuesday at a meeting of the parliamentary sport's committee, which summoned him to explain why Pakistan lost to Australia and New Zealand in the September-October Trophy in South Africa.

allegations hurt me no end," Younus told AFP. "Ever since we returned from South Africa, I was hiding from people as if I have committed a crime. It was painful because I played my cricket

for pride, for my country and not for money."

Pakistan's narrow defeat against Australia in a group match and upset loss to New Zealand in the semifinal sparked allegations that the team had thrown the matches, in part to knock archrival India out of the tournament.
