Six of a pvt clinic arrested while luring patients

Detective Branch (DB) of police yesterday arrested four brokers along with the owner and the manager of an 'illegal' mental clinic on charge of misleading the patients coming to Pabna Mental Hospital.

The arrestees are Motiur Rahman, Fakrul Hasan and Bazlu Sheikh of village Hemayetpur, Omar Ali of village Kismatpratappur, Mojibar Rahman of village Chatiani and Majnu Pramanik of village Chatiani in Pabna Sadar upazila.

Motiur Rahman is the owner of 'Rudra Mental Clinic' situated near Pabna Mental Hospital, Fakrul Hassan is manager of the clinic while the four others are brokers engaged in trapping patients coming to Pabna Mental Hospital to divert them to the private mental

As a mobile court led by Additional Deputy Magistrate (ADM) Md Emam Uddin Kabir along with DB policemen went to Pabna Mental Hospital premises under the guise of patients, Bazlu, Omar, Mojibar and Majnu


The team members then went to the clinic and arrested the four brokers, the owner and the manager.

The arrestees were handed over to Pabna Sadar Police Station.

"After being sure that the brokers were misleading the patients we arrested them along with the clinic owner and the manager," said the acting officer-in -charge of Pabna DB police.

Mental patients coming from different places of the country are often misled and cheated as brokers allure them to get admitted to a few illegal mental clinics set up around Pabna Mental Hospital, the only specialised mental hospital in the country.

"Four mental clinics are running without permission. They do not have any specialist doctors. Mental patients are often cheated by them. Earlier law and order meeting of the district administration took decision to stop activities of the illegal mental clinics," said Pabna ADM Md Emam Uddin Kabir.

Criminals strangled a CNGrun auto-rickshaw driver on Gohira-Heyako Road under Fatikchhari upazila of Chittagong district on Wednesday night, while police arrested the ringleader of a gang of pirates in Hathazari upazila of the district yester-

day morning. Police sources said a gang of criminals hired an autorickshaw from Kazir Hat area under Fatikchhari upazila at around 10:00pm on Wednesday and attacked its driver Zakir Hossain, 40, when the vehicle reached Joginighat on Gohira-Heyanko Road, according to our staff corre-

spondent from Chittagong. The gang strangled driver Zakir, son of late Musa of Bhujpur village under the upazila, and took away his vehicle, sources added.

Extortionists on Wednesday attacked and injured two staff of a local non-government organisation (NGO) failing to realise illegal toll from them. They, however, snatched away a mobile set and Tk 12,000 from the NGO staff, sources said. Injured Zahangir Alam and Utpal Dutta, staff of Tala-based NGO Uttaran, posted at Assassuni upazila headquarters, were admitted to the upazila health complex. Quoting local people police said local extortionists Yasin Ali, Pintu and Shahidul Islam attacked the NGO staff while they were preparing a list of the landless people near former Assassuni union chairman's house. Zahangir Alam filed a case with Assassuni police station accusing the three. Police later arrested Yasin Ali.

Thief electrocuted

An alleged thief was electrocuted at Gonka Moholla in Chapainawabganj municipal area early yesterday. Locals and officer in-charge (OC) of Sadar police station said Saptam Chowdhury was electrocuted as he climbed an electric pole to steal wire at midnight. Locals found his body hanging from the pole in the morning. Police recovered the body and sent it to Sadar hospital morgue for autopsy. An unnatural death case was filed.

Smugglers arrested

Police on Wednesday arrested a man who is an accused in a case filed with Kalaroa police station by BDR authorities allegedly for launching attack on BDR jawans in a bid to snatch away the smuggled goods seized from a boat in the Sonai River at village Madra in Kalaroa upazila on October 8. Arrestee Abdul Latif, 28, is son of Wasihar Rahman of village Bhadiali in Kalaroa. He was rounded up from Bhadiali village. The BDR jawans seized 275 kilograms of powdered milk and a bagful of polythene from an Indian boat while being smuggled in on October 8. At this, the smugglers attacked the BDR jawans and pelted brickbats on them in a bid to snatch away the seized goods. The BDR jawans opened fire at the smugglers to disperse them.

College teacher attacked

Criminals on Tuesday attacked and injured a teacher of Comilla Victoria College as he protested the teasing of college girls. Sources said members of local Setu Bahini attacked AKM Shahab Uddin, lecturer of Accounting department, with lethal weapons near a cycle stand of the college at noon, leaving him seriously injured. He was rushed to Comilla General Hospital. A case was filed with Kotwali police station. Students of the college later brought out processions in the town demanding arrest and punishment to the culprits. The gang used to tease the girls on the campus, the students said.
