COURT CORRESPONDENT

The Anti-Corruption Commission yesterday submitted final report clearing Prime Minister Sheikh Hasina and three others of charges in a corruption case saying the charge of "misuse of power" against them could not be

proved. The case was filed against them for embezzling Tk 41.84 lakh in the construction of a grave complex of Bangabandhu Sheikh Mujibur Rahman at

Tungipara in Gopalganj. ACC Deputy Director Mohammad Moniruzzaman Khan, also investigation officer in the case, submitted the final report to the Dhaka Chief Metropolitan Magistrate's Court citing no instance of "misuse of power" by any of the accused.

PM asks to watch polluting industries; tells top bureaucrats not to bother about influences; demands sincerity, honesty, skill from them

Prime Minister Sheikh Hasina yesterday directed the administration to free rivers and wetlands from the grabbers' clutches and take legal actions no matter how influential the encroachers are.

Addressing secretaries of different ministries and divisions, she also said, "Stay vigilant so the grabbers cannot reoccupy the rivers, canals and wetlands to be retrieved."

She observed that land-grabbing was encouraged in the past because the authorities took no action against the offenders.

"The narrowing of rivers, canals and beels not only hampers the livelihood of the people but also leave adverse effects on the environment."

The prime minister instructed the officials to bring legal proceedings against the industries that dump waste

into the rivers and canals and contribute to water pollution.

Noting that the subsoil water level has been going down alarmingly across the country, especially in the capital, she asked them to pay close attention to the issue. Hasina warned the

officials who would fail to deliver would face the axe. "Some of you may consider

yourselves very close to the government high-ups and may think you can do anything. If that is so, you are living in a fool's paradise."

She said, "As a chief executive of the country, I must keep watch on all matters. I observe what you are doing too. And I demand sincerity, honesty

and skills."

Reiterating her commitment to rewards for good work and rebukes for bad, she said stern measures would be taken if anyone is found involved in attempts to sabotage the government's development campaigns.

The prime minister asked the bureaucrats

to formulate a five-year plan, implement development projects in time, fight graft and money-laundering, improve law and order and work to ease power and gas crises.

She also directed them to fully appreciate the government policy and help implement Awami League's electoral pledges, which are among

other things to strengthen rural economy, generate employment opportunities, eradicate poverty, increase the purchase capacity of the people and

raise domestic production. Forty secretaries were present at the meeting at the secretariat. Of them, 16 apprised the prime minister of their ministries' activities.

Afterwards, Cabinet Secretary Abdul Aziz briefed the newsmen about the three-hour long meeting.

He said the prime minister asked them to step up the pace of work and ensure transparency and accountability.

Referring to the government's priorities that include containing the prices of essentials, establishing good governance and developing the power sector, she directed the officials to work sincerely, rising above fear and temptation.

SC asks EC to hold by-polls in Bhola-3

The Supreme Court yesterday upheld the High Court verdict that declared illegal the parliament membership of Maj (retd) Jasim Uddin, who was elected from Bhola-3 constituency on Awami League nomination.

Jasim Uddin had participated in the December 29 parliamentary election before completion of five years of

his compulsory retirement from the defence service. A five-member bench of the Appellate Division headed by Chief Justice MM Ruhul Amin passed the verdict, dismissing Jasim's appeal against the HC verdict.

The court asked the Election Commission to hold a byelection to the constituency.

Officials at the Parliament Secretariat said on receiving the copy of the verdict they would publish a gazette vacating Jasim's membership in parliament. The EC will have to hold the byelection within 90 days of publication of the gazette.

TAX DODGING CASE Jalil gets HC bail

The High Court (HC) yesterday granted anticipatory bail for three months to former Awami League general secretary Abdul Jalil MP in a tax evasion case.

The HC bench of Justice Syed Muhammad Dastagir Husain and Justice Md Rais Uddin also issued a rule upon the government to explain why Jalil should not be granted regular bail in the case.

The AL leader yesterday appeared before the HC bench and filed a petition with the court for bail in this case. Barrister Rokanuddin Mahmud stood for him.

Huda managed 10 coffins, bodies

Barrister Abdullah-al Mamun, counsel for convicts Bazlul Huda and AKM Mohiuddin in Bangabandhu murder case, yesterday claimed before the

Supreme Court that Bazlul was innocent and had not been involved in the killings of Bangabandhu and his family members.

Mamun quoted the statement of prosecution witness Abdul Quddus that Bazlul took Bangabandhu's body to the airport after killing him. Besides, he had earlier gone to Mohammadpur to buy ten coffins and also took the rest nine bodies to Banani graveyard, said the counsel.

It is not humanly possible to do so many tasks in cool head after committing murders because a person usually acts quite abnormally after killing someone, Mamun told the apex court while placing arguments during the 10th day's hearing on the appeals of the five convicts.

Mamun said the then Air Force Chief AK Khandaker had sent a helicopter to carry Bangabandhu's body to his village home at Tungipara, on August 16, 1975, the day after the killings took place.

He questioned why AK Khandaker had not taken any initiative to resist the killers and rescue Bangabandhu and his family members on August 15, 1975.

Suicide attack on Iran's elite guards

30 killed; Tehran points finger at US; Sunni group claims responsibility



A suicide bomber blew himself up at a meeting of the elite Revolutionary Guards in southeastern Iran yesterday, killing at least 30 people including top commanders and tribal leaders, a senior official said. The attack took place in the city of Pisheen near the border

with Pakistan in restive Sistan-Baluchestan province, which hosts a substantial Sunni population, local news agencies said. Iran's parliament speaker said the United States was behind

the attack while the Guards accused Western powers of carrying out the assault, the deadliest against them since a bombing in February 2007 in the same province killed 13 people.


