Atwary UNO sues 150 including UZ chairman

Atwary upazila nirbahi officer (UNO) Rashedul Hasan on Friday night sued 150 people identifying 21 of them, including the upazila (UZ) chairman, for Thursday's untoward incident in his

In the case filed with Panchagarh police station, the UNO accused them of ransacking his office, assaulting him and confining him to his office room on Thursday.

Besides, Atwary UZ chairman Touhidul Islam, he brought charges against his two brothers, three union parishad (UP) chairmen of the upazila and a few Awami League (AL), Jubo League and Chhatra League (BCL) leaders.

The 21 accused include the elder brother of the upazila chairman who is also headmaster of Atwary Pilot High School Khademul Islam, another brother and headmaster of Torea High School, organising secretary of upazila unit Awami League Fazlul Karim, chairman of Balarampur UP and also acting president of upazila unit AL Saidur Rahaman, Radhanagar UP chairman and also general secretary of upazila Krishak League Rashidul Islam, convener of upazila BCL Mokhlesur Rahaman, joint secretary of upazila AL, also headmaster of Atwary Pilot Girls' High School Mizanur Rahman, joint secretary of upazila AL Sajjat Selim, headmaster of Radhanagar Girls'High School MdWazed Ali, general secretary of upazila Jubo League Nahid Pervez Zahid,

general secretary of upazila Sramik League Md Alamgir, organising secretary of upazila AL Abdul Quddus, Mokbul, Fahim, Shahidul of Selim, Taher and Nasir of BCL and driver of upazila chair-

He alleged that the supporters of the upazila chairman also harassed upazila livestock officer, education officer and other upazila officials who were at work on the day.

On Thursday, several hundred supporters of upazila chairman Touhidul Islam besieged the UNO's office as the UNO locked the upazila chairman's office and motor garage on Wednesday night. The agitators also confined the UNO to his office room for about four and a half hours.

10 Patuakhali journalists intimidated, harassed

Series of protests go unheeded

At least 10 journalists of Patuakhali district have faced intimidation and harassment including false cases by the ruling party men during the last one and a half months.

Demanding arrest and punishment of the perpetrators, local journalists have continued their programmes including submission of memorandum, human chain, protest procession and breaking pen but no action has been taken against the offenders.

Following filing of 'false' cases against Israt Hossain Lipton, Galachipa upazila correspondent of the daily Prothom Alo, and his brother Saimoon Rahman Alit, upazila correspondent of the daily Amar Desh, they are on the run as with Galachipa police is looking for them to arrest.

The cases were filed to avenge their reports on grabbing river and land by local lawmaker Golam Maula Roni in the name of building markets, said the journalists' family members, adding that police and ruling party cadres are threatening them too.

On September 8, Moslem Bayati, a caretaker in Galachipa, filed an extortion case against Lipton and Alit with Galachipa Police Station.

On September 10 night, Nilufa Begum, wife of Selim of Chotoshiba village under Charkazal union in the upazila, filed a case against Lipton claiming that he raped her on the day in a local hotel. Laizu Begum, another

Charge framing date deferred

A Chapainawabganj court on Thursday deferred the date for charge framing against 30 BDR men. The court also rejected their bail prayers and sent them to jail. Additional District and Sessions Judge Arup Kumar Goswami deferred the date when the prosecution lawyer prayed for extension of time. After hearing the prosecution, the court deferred the time and fixed the next date for charge hearing on November 11. The court rejected the bail prayers of 30 BDR men when defence lawyers sought bail. Officer in-charge of Sadar police station Ahsanul Haque on May 17 filed a sedition case against the jawans for their alleged involvement in the February 25-26 mutiny at Chapainawabganj battalion headquarters.

Hartal called in Bagaichhari

11 hurt in Madaripur clash

Chhatra League and Jubo League workers yesterday attacked the leaders and workers of Chhatra Dal injuring 11 people in the municipality area under Shibchar upazila. The ruling party men allegedly swooped on an orientation meeting of upazila Chhatra Dal being held at the BNP office and beat up the rival party activists. The injured include Shahid Khan, 32, Mohin Bepari, 22, Shahin Madbar, 21, Enamul, 21, Shaon Chowdhury, 20, Rasu, 28, Amir Morol, 26, Azad, 34, Dulal Mina, 32, Rubel Madbar, 34 and William, 32. They were first admitted to Shibchar hospital. Later, four of them were shifted to Dhaka Medical College and Hospital (DMCH) in a critical condition. Additional police have been deployed to avoid further clash.

Over 100 families have become homeless in different villages of Sadar upazila due to erosion by the Padma.

Locals said the erosion affected the families of Chandranarayanpur, Alimnagar, Monnapara, Delpara, Chhuchkipara, Bakhorali, Maharajnagar villages under Charbagdanga, Sundarpur and Narayanpur unions in last one month.

They said over 250 acres of correspondent found many farmland and a huge number of mango orchards and bamboo clusters went into the gorge of river Padma. People are trying to shift their houses from these areas as the river is
