

# PM assures harassment-free airports for expatriates

UNB, Doha

Prime Minister (PM) Sheikh Hasina said her government would take necessary steps to stop harassment of expatriate Bangladeshis at airports in the country.

She remarked yesterday while addressing a reception programme arranged by Bangladesh expatriates in Doha.

The PM said the government has already taken several steps after which the service delivery system in Bangladesh's airports has improved.

"But due to relentless corruption and irregularities in the last seven years, the situation worsened and it will take

time to improve it," she told the function.

Hasina also said the government sincerely wants to improve the service quality of Biman Bangladesh Airlines Limited.

She also assured the expatriates of looking into the problem of their children's curriculum-related difficulties for getting admission into the universities in Bangladesh.

Calling upon the expatriates for making more investment in the country, the PM informed them the government is planning to set up an Expatriate Bank for their welfare.

On education facilities, she said her government would set up at least one high school in

every upazila with vocational education training facilities. "We want to create a job-oriented education system in our country,"

Sheikh Hasina also asked the expatriate Bangladeshis to make constructive suggestions about the country's education policy, a draft of which is available on the Education Ministry website.

She said the previous Awami League-government sponsored project of 18,000 community health clinics, which was shut by the last BNP-Jamaat government, will be started again to ensure quality and cheap medical facilities.

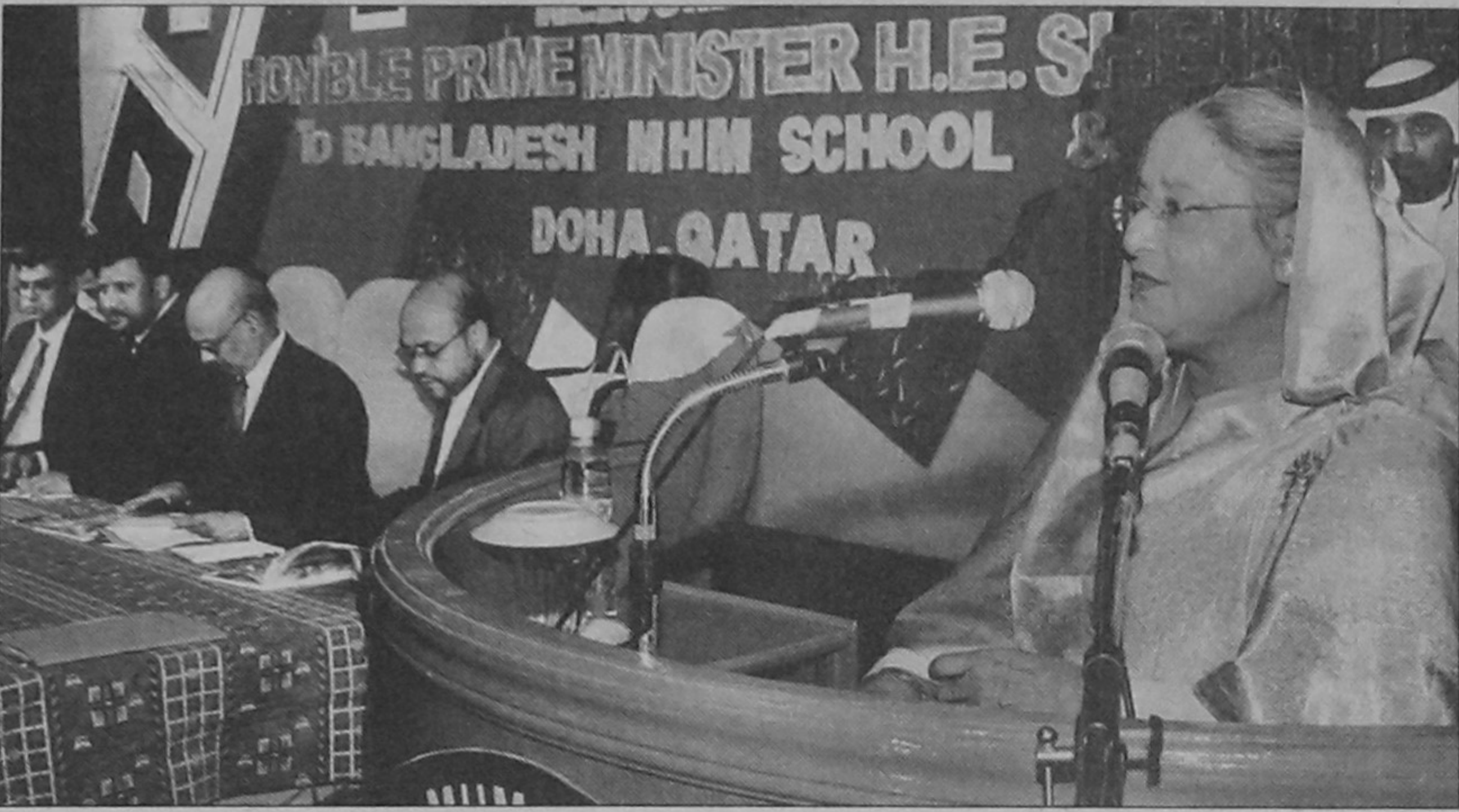
Hasina said the people of the country have got their own

government through the free, fair, neutral and acceptable parliamentary polls of December 29 last year.

She also expressed her commitment to build Bangladesh as the most peaceful nation in South Asia by uprooting militancy and all other types of crimes from the country.

She hoped Bangladesh will be able to solve all its bilateral problems with the neighbouring countries through discussion.

Foreign Minister Dr Dipu Moni, State Minister for Environment and Forests Dr Hasan Mahmud and a Bangladeshi expatriate, Prof. M Abu Hena, also addressed the function.

## Court hearing on remand prayer for Babar today

A Dhaka court will hear today a 10-day prayer for interrogation of detained former state minister for home Lutfozzaman Babar in connection with the August 21 grenade attack case.

On Monday, Additional Superintendent of Police of Criminal Investigation Department (CID) Abdul Kahar Akond, also the investigation officer (IO) of the case, submitted a petition to show Babar arrested in the case.

The IO also submitted another petition seeking a 10-day remand for Babar to interrogate him about the suppliers of grenades and their whereabouts.

First Additional Chief Metropolitan Magistrate Mohammad Ehsanul Haque granted the petition to show Babar arrested in the case and also fixed today for hearing on the remand prayer in his (Babar) presence.

The court also directed the jail authorities to produce Babar before it on the scheduled date.

Twenty-three people were killed and 300 others injured in the grenade attack on an Awami League rally at Bangabandhu Avenue on August 21, 2004.

Police filed two cases -- one for murder and another under the Explosive Substances Act -- with Motijheel Police Station a day after the grenade attack.

On August 3, a speedy trial tribunal ordered further probe into the cases following petitions filed by the prosecution seeking fresh investigation.

Following order for further investigation, former deputy minister Abdus Salam Pintu and a Harkatul Jihad (Hujji) member Abu Taher were remanded several times in connection with the case and sent to jail afterwards.

On March 5 this year, a Dhaka court sent Babar to jail for the second time on his surrender seeking bail in an arms case in which he was sentenced to 17 years' rigorous imprisonment.

## Fire drill for students

## SC upholds stay on bail to sugar traders

The Supreme Court yesterday upheld its chamber judge's orders that stayed the High Court orders granting bail to 14 sugar traders of Khulna and Jessore in two cases.

Following two leave-to-appeal petitions filed by the government, a five-member bench of the Appellate Division headed by Chief Justice MM Ruhul Amin yesterday also directed both the parties to take steps for the hearing and disposal of rules issued earlier by the HC.

On October 6, the High Court upon two separate bail petitions granted anticipatory bail to the sugar traders and a also issued separate rules

asking the government to explain why the traders should not be granted regular bail in the cases.

The traders are Abdul Wahab, Anisur Rahman alias Boro Anis, Anisur Rahman alias Chhoto Anis, Abdul Wadud, Modhusudan Saha, Raju Ahmed, Mohammad Amin, Chitta Ranjan Kundu, Hafizur Rahman Babu, Safer Rahman, Rafiqul Islam, Alok Kumar Kundu, Sirajul Islam and Sarwar Hossain.

On October 7, following two government petitions, the chamber judge of the Appellate Division stayed the HC orders and asked the government to file separate leave-to-appeal petitions with the Supreme Court against the High Court orders.

## Bangladesh elected ECOSOC member

Bangladesh elected member of the United Nations Economic and Social Council (ECOSOC) for a three-year term beginning from January 1, 2010.

In the election to elect four countries from Asia region, a total of 188 countries cast their votes and Bangladesh got elected securing 185 votes, highest secured by any country, says a press release of Bangladesh's mission in New York.

The election was held in the General Assembly hall at the 25th plenary meeting of the 64th UNGA when the delegates from the member states voted to elect 18 members of the 54-member ECOSOC from different geographical regions.

The other countries elected to the ECOSOC are: Ghana, Comoros, Zambia, Rwanda and Egypt (from Africa), Ukraine and Slovakia (from Eastern Europe), Chile, Bahamas and Argentina (from GRULAC Group of Latin American and Caribbean Countries), and Italy, Belgium, Canada and USA (from WEOG Group of Western European Countries and Others).

Bangladesh earlier served the ECOSOC in 1976-78, 1981-83, 1985-87, 1992-94, 1996-98 and 2004-06 terms.

## DEFAMATION SUIT Moeen's vokalatnama legal: HC

A Dhaka court yesterday declared legal a vokalatnama (power of attorney) submitted by a counsel of former army chief Gen (retd) Moeen U Ahmed on August 5 in a Tk 100 crore defamation case.

Judge SM Saiful Islam of the Third Joint District Judge's Court passed the order dismissing a petition submitted by former state minister for power Iqbal Hasan Mahmood Tuku challenging the legality of the vokalatnama.

The court fixed November 17 as the date for the next hearing of the suit.

Both the counsels of the plaintiff and the defendant yesterday took part in the hearing on the petition and made their submissions.

In his order, the judge said the vokalatnama submitted to the court by lawyers of Moeen was legal and there was no legal bar to accept it.

On October 1, former state minister Tuku submitted the petition challenging the legality of the power of attorney. Moeen's lawyer submitted a written objection against the petition on October 20.

Tuku had filed the defamation suit on July 12, accusing the former army chief of making derogatory remarks damaging his (Tuku's) reputation.

On a petition filed by Tuku the same day, the court asked Moeen to explain within three weeks why his property should not be attached.

On March 27 in 2007, Gen Moeen, then army chief, said at a tea party at the National Parade Square that corrupt politicians had siphoned off at least Tk 20,000 crore from the energy sector during the four-party rule, reads the complaint.

The party was held in honour of the freedom fighters.

## 12 BDR men appeal to retract confessional statements

Twelve Bangladesh Rifles (BDR) members yesterday appealed to a Dhaka court to retract their confessional statements given earlier in the BDR mutiny case.

The carnage took place at the BDR headquarters on February 25-26 leaving a number of BDR high officials, including its director general (DG), dead.

Metropolitan Magistrate Rashed Kabir put the petitions in the file of the carnage case.

In the petitions, the BDR jawans told the court that they were tortured mercilessly to give the confessional statements.

Meanwhile, 16 BDR jawans were shown arrested in the case yesterday and taken on a five-day remand each.

All of the border guard men were arrested from Palkhona headquarters after the February 25-26 bloodshed.

has been suffering from bone cancer, says a press release.

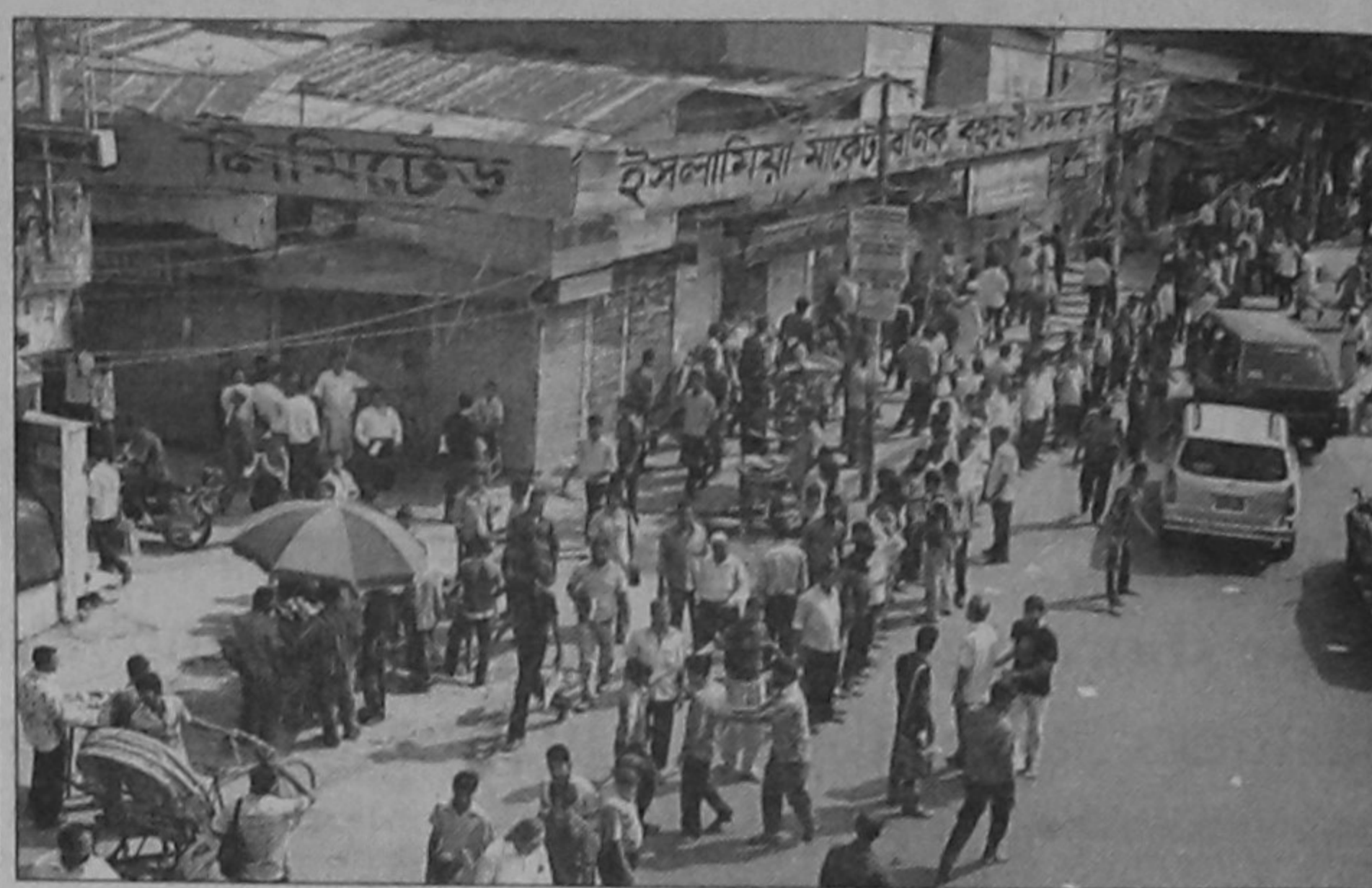
The girl is now undergoing treatment at the National Institute of Cancer and Hospital (NICRH) at Mahakhali.

## Dhaka to build capacity to fight climate change: IUCN

International Union for Conservation of Nature (IUCN) wants Bangladesh to enhance its capacity to negotiate a long-term cooperative action to manage the adverse impacts of climate change, says an IUCN release.

"Bangladesh is already experiencing the impacts of a changing climate. We must take an active role in building Bangladesh's capacity to negotiate a long-term cooperative action to manage the adverse impacts of climate change," said IUCN Asia's Senior Adviser on Climate Change Dr Ainun Nishat yesterday.

The famed environmentalist was speaking at a consultative meeting at Biam auditorium in the city where experts from across the country gathered in the lead up to the December global climate change negotiations in Copenhagen, Denmark.

The environment ministry organised the meeting in association with IUCN Bangladesh where representatives from various environmental organisations shared their recent experiences to help build a strategic position for the national delegation.

IUCN Bangladesh is coordinating a national envoy of almost 200 delegates, including members of parliament, government and non-government organisations, civil society members and journalists.

Providing an overview of the current situation of Bangladesh's preparation, Ainun said, "We have already prepared a national climate change strategy and action

plan, the first of its kind in Bangladesh. So, it is a very exciting and pivotal time for us to be involved in an international level."

IUCN Bangladesh Country Representative Dr Niaz Ahmed Khan emphasised the need for a united and practical strategy to mitigate the impacts of climate change.

Speaking as the chief guest, Environment and Forests Secretary Dr Mihir Kanti Majumder discussed the key issues under debate at the global level and the importance of Bangladesh's participation in the international discussions.

Dr Zafar Ahmed Khan, director general of the department of environment, facilitated the technical session on preparations for effective participation in the climate change negotiation process.

## Cases against Tarique filed to refrain him from politics

### BNP secy general tells JCD rally

Terming the money laundering case against Tarique Rahman politically motivated, BNP Secretary General Khandaker Delwar Hossain yesterday said cases are being filed as part of the conspiracy of the immediate past caretaker government to refrain Tarique from doing politics.

"The government has filed the money laundering case against Tarique Rahman to smear him politically, but all the cases must be withdrawn," he said at a protest rally organised by Jatayatbadi Chhatra Dal in front of the party's central office in Naya Paltan in the city.

Meanwhile, an official cross-party delegation of the United Kingdom met the BNP secretary general at the central office the same day.

Anti-Corruption Commission on Monday filed the case against Tarique and Giasuddin Al Mamun for laundering Tk 20.4 crore from Bangladesh by several routes to Singapore that violated the Money Laundering Act.

Earlier, Delwar also talked to reporters after placing a wreath at the grave of the party's founder late president Ziaur Rahman at Sher-e-Bangla Nagar on the occasion of the founding anniversary of Juba Dal.

"Please don't force us to wage a movement. You [government] would be forced to withdraw the case if we are

forced to go to the street and people will bring an end to this misrule through movement," he said at both the places.

The secretary general said repressive measures such as filing cases and launching assaults cannot divert people's reaction to other issues, adding that the recent case filed against Tarique is just another ploy to harass him.

"The government was framing charges against the BNP leaders to hide its failure in all sectors. It is now hatching a deep-seated conspiracy against BNP. It is withdrawing the cases filed against its leaders and activists and filing cases filed against our leaders. Now it began framing fresh charges," he said.

Delwar said the government was taking steps against the country one after another as per the will of the forces that put them in power.

"The government is now plotting to allow corridor to India to make it easier for India to contain the dissidents in north-eastern seven sisters," BRITISH DELEGATION MET DELWAR

The official cross-party delegation comprising representatives from Conservative Party, Labour Party and Liberal Democratic Party met Delwar at the party's central office.

The delegation exchanged their views with the BNP leaders and discussed about the latest development of local politics.
