CHILAHATI LAND CUSTOMS STATION

Flag hoisted every morning although shut for 7 years

Chilahati land customs station in Nilphamari district has been lying inoperative for over seven years following closure of Holdibari land customs station by India, much to the sufferings of both Indian and Bangladeshi travellers and businessmen.

The Chilahati-Holdibari route between Bangladesh and India was closed down after Indian authorities decided to shut the Holdibari land customs station in Cooch Behar district of West Bengal

in June 2002. Following repeated requests from the people in Nilphamari and adjoining areas, the authority of Chilahati land customs station situated at Bhogdaburi of Domar upazila in Nilphamari formally requested the Indian land port customs authority to take necessary steps to reopen the station considering its utility to the travellers of both the

countries. But the Indian authorities are yet to make any positive response in this regard, station

sources said. The people of Nilphamari and other adjoining districts have been demanding reopening of the route through bilateral talks. A large number of Bangladeshi citizens from the district and adjacent areas go to India to meet their relatives and for business, treatment and other purposes every day.

Besides, about one lakh Urdu-speaking people now living in Syedpur town in Nilphamari, mostly descendents of the refugees who came to the then East Pakistan from Bihar in India, travel to India frequently to

meet their relatives. But after closure of the

Holdibari customs station,

these people need to detour a long way to use Burimari checkpoint in Lalmonirhat, opposite to Indian Chengrabanda checkpoint, to go to India, adding to their travel cost.

"During my visit to India last year, the business community of Jalpaiguri in West Bengal requested me to persuade Bangladesh government for negotiating with India to reopen the Chilahati-Holdibari transit route," said Mostofa Azad Chowdhury Babu, president of Rangpur Chamber of Commerce and Industries.

Re-opening of this route will help a large number of people

of Panchagarh, Thakurgaon along with Nilphamari district who make frequent visits to India for business and other purposes, said Abdul Wahed Sarker, president of Nilphamari Chamber of Commerce and Industries.

ALLEGED CORRUPTION BY PRESIDENT, SECY 11 Rajshahi Bar members resign in protest

Eleven executives of Rajshahi Bar Association yesterday resigned protesting alleged corruption by association's president and general secretary.

They are vice-president AKM Mizanur Rahman, third joint secretary Habibur Rahman, audit secretary Shamsul Haque, Library secretary Mahmudur Rahman, press and information secretary Masud Sarder, accounts secretary Nazmul Haque Mintu, magazine and cultural secretary Rajab Ali and members Abdul Matin Chowdhury, Parvez Towfik Zahedi, Aftabur Rahman and SM Mofazzal Haque.

The announcement of en masse resignation came from a press conference at Rajshahi Metropolitan Press Club at noon.

Some 50 other senior lawyers under the banner of 'Rajshahi Ainjibi Oikya Parishad' were present at the press conference.

The lawyers alleged that Bar Association President Muhammad Yahiya and General Secretary Lokman Ali were engaged in distributing forged vokalatnama (power of attorney) among the lawyers and in this way they misappropriated around Tk 26 lakh between report on vokalatnama forgery.

November 23, 2008 and September 6, 2009. They said forged stickers of Bangladesh Bar

Council and forged signature of relevant officials were used in the vokalatnama. The bar association did not take any action

This angered Jamal most and he along with his aide Zahiruddin Babar swooped on Nabi. Hearing Nabi's cry for help, locals rushed to the spot to save him. But Jamal stabbed Yunus indiscriminately, leaving him critically injured. Yunus was rushed to Noakhali General Hospital where he succumbed to his injury at about 11pm.

Death threat to JP man

Khulna city president of Jatiya Party (Ershad) and exlawmaker Abdul Gaffar Biswas allegedly received death threats twice on Wednesday evening from extremists over cell phone. They threatened him as he refused to pay Tk 1,50,000 illegal toll as demanded by the callers. Biswas said, the callers identified themselves as armed cadres of Janajuddho faction of outlawed Purbo Banglar Communist Party (PBCP). The JP leader filed a general diary (GD) with Khalishpur police station in this connection at 10 pm on the same day seeking security of his life. According to the GD, the callers who gave him death threats demanded the money for medical treatment and bail expenses of their cadres.

Buruj discloses to police

Two senior Awami League leaders, a Jubo League leader and a businessman had a hand in the killing of KCC ward councillor Shahid Iqbal Bithar. Central Jubo League

leader Mesbah Hossain Buruj, arrested in the capital in connection with Bithar muder on October 26, disclosed this to the law enforcers during interrogation on remand.

Police produced Buruj in the Additional Chief Metropolitan Magistrate's Court on Thursday, seeking fresh remand. Magistrate Abu Shamim Azad granted four days'remand that

expires today. Four of the six professional killers hired to execute the plan are now in jail. They are Akash, Raju, Shab-e-Kadir and Hiru. The remaining two--Arman and AL Amin--are still at large. According to investigation

officer (IO) Inspector Mamun Khan, major headway in the investigation has been achieved with statements made by Buruj and all other murder suspects arrested recently.

"We will nab some other murder suspects soon to complete our investigation into the case", said AC Abu Sayem of KMP's Detective Branch (DB).

Investigation officer Mamun Khan said statements of Buruj and all other arrestees were recorded under Section 161 of CrPC.

Ferdaus Hossain Hiru and Rajiv alias Tony, arrested in Natore recently, would be brought face-toface with Buruj to get confirmation about involvement of two senior AL leaders in the killing plan, the IO said.
