were rushed to Dhaka Medical College and Hospital while others were taken to local hospitals and clinics.

The home ministry will hold an emergency meeting with officials of Bangladesh Garment Manufacturers and Exporters Association at 11:00am at the ministry to find out the causes behind yesterday's clash.

Witnesses said the clash erupted at about 8:00am when several hundred workers of Nippon garment factory tried to enter the factory, defying police barricade at the entrance.

The factory authority had hung on the main gate a notice of closure of the factory from October 31 to November 29 because of "global recession and some unwanted incidents".

The notice also asked workers to collect their dues from the factory office on November 10.

When the agitating workers, mostly females, tussled with police personnel to enter the factory yesterday, the law enforcers resisted them and at one stage charged truncheons to disperse the protesters.

The angry workers along with locals of Ershadnagar area blocked the highway and torched the bus and vandalised several vehicles.

Ali Asgar, driver of the torched bus, told The Daily Star that the agitating workers intercepted the bus in front of the factory and set it on fire.

The police charged truncheons on them again, which prompted the protesters to retaliate with brickbats.

A team of police then fired rubber bullets and teargas canisters. At one stage, they entered the Ershadnagar area and clashes ensued.

Locals alleged that the police ransacked their houses and shops and tortured many innocent people who had no involvement in the incident.

Aworker told The Daily Star that they wanted to enter the factory to know from the authority why they closed the factory without paying their arrears. "But the police barred us and charged truncheons on us which caused the clashes," he said.

Mohammad Akter, a class III student, sustained bullets in the abdomen and arms during the clash when he went out of his house to look for his mother who is a worker of the

"Hearing gunshots, I came out of the house to find my mother but all of a sudden I received the bullets," he told The Daily Star at DMCH.

A few family members of the workers tried to enter the factory in the afternoon in search of their missing relatives who, they said, had not returned home or made any contact since going to the tactory.

Police kept around 15 locals and male workers tied to pillars of a nearby foot-

bridge. Many people claimed that the police killed several workers and locals. The law enforcers either took the dead bodies to another place secretly or hid those inside the factory, they said.

Rajab, a resident of Ershadnagar slum, said, "The law enforcers killed those who got trapped inside the factory compound."

However, none could specify identities of the alleged dead ones.

Awami League leader Zahid Hasan Russell visited the three-storey factory building along with 10 workers to look for dead bodies but found

During the gunfight, two police constables -- Nurul Islan and Zakir Hossain -were also injured.

Police Super M Mizanur Rahman said 6-7 armed pirates started firing on police around 5:30am while they were conducting a special drive in the Sundarbans following the Raash Mela at Dublar Char.

Retaliatory firing by police left two pirates dead on the spot. Their accomplices, however, managed to flee.

Police sent the bodies to Sadar hospital morgue for autopsy and recovered two rifles, 14 bullets, 8 cartridges and a mobile phone set from

Talking to reporters later, she said, "We will form a probe committee to ensure trial of the culprits behind the incident.

Inspector General of Police Nur Mohammad and Director General of Rapid Action Battalion Hassan Mahmood Khandaker visited the spot yesterday around 1:30pm.

Talking to the reporters in front of the factory, the IGP said they did not receive any confirmation of death.

He said three policemen were admitted to Rajarbagh Police Line Hospital in a critical condition.

Asked if there could be any instigation behind the incident, he said they had often observed instigations behind such incidents for the last couple of years.

Garment worker Kamruzzaman said the volume of work in the factory decreased in the last one month while payment of salaries had become irregular for several months.

He said the factory authority paid the salary for the month of September on October 22 and the overtime arrears for three months even later although it was supposed to be paid on October 24. "The workers became

aggrieved as the arrears were not disbursed in time," he said. Against this backdrop, the factory authorities held a meeting with about 100 workers on Friday evening, he added.

At the meeting, Manjur Morshed, one of the directors of the factory, told the workers that the factory has been receiving fewer work orders and that the situation would continue for some time.

Kamruzzaman told The Daily Star that Manjur had asked the workers not to cause any unrest in the factory and assured them of paying the

A number of workers, who were present at the meeting, alleged that the authorities deceived them by not informing them about the closure. The authorities suddenly closed the factory to deprive them of their dues, they added.

The Daily Star could not reach the authorities after repeated attempts.

Superintended of Police SM Mahfuzul Haque said the unwanted incident erupted because of the sudden closure of the factory.

He said the workers forcefully entered the factory and started hurling brickbats at the police. The law enforcers opened fired on the workers to save themselves.

The SP claimed that the incident left 16 of both the sides injured.

He said the factory authorities had sent a letter to Tongi Police Station about the closure but they could not make proper preparations.

Tongi police are preparing to file a case in connection with the clashes.

US President Barack Obama has asked the Pentagon for more options on troop levels in Afghanistan including Lawmaker of the area sendingless than the roughly 40,000 new soldiers requested, The Washington Post said yesterday.

The military chiefs have been largely supportive of a Indian intelligence agency, resource request by General Stanley McChrystal, the top US and Nato commander in Afghanistan, that would by one Pentagon estimate require the deployment of

44,000 extra troops, it said. But opinion among members of Obama's national security team is divided, and he now appears to be seeking a compromise solution that would satisfy both his military and civilian advisers, the paper said.

Obama is expected to receive several options from the Pentagon about troop levels next week, The Post noted.

Before determining troop levels, Obama must decide whether to embrace a strategy focused heavily on counterinsurgency, which would require additional forces to protect population centres, or one that makes counterterrorism the main focus of US efforts in the country, the paper said.

"part" of its stockpile. President Mahmoud Ahmadinejad said yesterday it is still difficult for Iran to trust Western powers when it comes to negotiations, but he hopes the nuclear dialogue between the two will continue.

His comments came as the White House warned that US President Barack Obama will not wait for ever for Tehran's response to a UN-drafted deal to supply Iran with nuclear fuel in exchange for its low-enriched uranium (LEU).

Western powers are awaiting a clear response from Tehran over the nuclear fuel deal brokered by UN atomic watchdog the International Atomic Energy Agency (IAEA).

France has said the deal aims to ship out 1,200 kilos of Iran's LEU -- enriched at a facility in Natanz in defiance of three sets of UN sanctions -- for further higher processing abroad and converting into fuel for a Tehran research reactor.

Western powers are backing the deal as the Tehran reactor is an internationally supervised

The deal is a aimed at removing from the country Tehran's stock of LEU, a major concern in the West which suspects the enriched material could be further enriched for use in nuclearweapons.

Israel, which maintains that world powers must keep all options on table to halt Tehran's nuclear drive, including a military strike, has also backed the UN-drafted deal.

The Jewish state is the Middle East's sole -- if unde-

clared -- nuclear-armed power. Israeli Prime Minister Benjamin Netanyahu on Friday called the deal "a positive first step," as it supports efforts "to unite the international community to address the challenge of Iran's attempts to become a nuclear military power."

The IAEA has confirmed that Tehran has given an "initial" response to the deal, but late on Friday IRNA reported saying Iran's response was "not an answer" to the deal and that it wanted more talks.

On Friday, White House spokesman Robert Gibbs warned that Obama will not wait for ever for a formal reply
