Tongi reels from fright

Another death raises toll to 3; up to 3,000 people sued for violence

Another man died from wounds in hospital yesterday raising the death toll to three in Saturday's labour unrest at Nippon Garment Industries Ltd

in Tongi. Police filed a case against 2,000 to 3,000 unidentified people along with eight others, detained on Saturday with ties to the clashes between police and workers. Two persons died on the spot and 100 others were injured in the inci-

Tajul Islam, 50, a resident of Ershad Nagar in Tongi, who was admitted to Dhaka Medical College Hospital with head injuries on Saturday, died early in the morning.

The bodies of the two others -- Bablu Sheikh, 32, a rickshaw-van puller, and Shafique, a construction worker from Ershad Nagar -- were taken to Gazipur Sadar Hospital morgue for autopsy on Saturday night.

A correspondent from Gazipur reported that both bodies bore bullet marks.

Later, the bodies of Bablu and Shafique were sent to their village homes in Jamalpur and Bhola, said police.

Tapan Saha, officer-in-charge of Tongi Police Station, told The Daily Star that he had filed the case on charges of assault on law enforcers, vandalism and torching vehicles.

Law enforcers were deployed in and around the garment factory that remained closed following the violent clashes.

Several hundred workers of the factory demanded a fair probe into the incident and trial of the factory owners at a protest rally near Majida High School in Ershad Nagar.

They also demanded punishment to the law enforcers involved in what they said was indiscriminate firing on garment workers and locals.

Steps to lay off not followed

Garment factory owners are violating labour and industrial laws by closing down factories on the excuse of a slump in work orders from international buyers, labour ; ways to introduce trade leaders and legal experts said yesterday.

The decision to close a factory temporarily requires a consensus of workers, but owners are not following this standard procedure and shutting down factories even without giving workers any time.

Supreme Court lawyer barrister Tanjib-ul Alam told The Daily Star that a company must follow three steps before it declares a lay off: giving its workers at least one month's notice, publishing that notice in newspapers, and sending it to the inspector of labour.

He said Nippon Garments Industries Ltd followed none of the steps.

Moshrefa Mishu, president of Garment Sramik Oikya Forum, a platform of garment workers, told The Daily Star that Nippon Garments was shut down without following the industry laws.

She said according to the rules, factory authorities must talk with workers and their representatives before closing a factory, but the authorities of Nippon Garments closed the factory all of a sudden. She said owners often announce closure of their facto-

ries under the excuse of shortfall in orders from international buyers, which is not right.

A compliance officer of an internationally renowned garment factory, who deals with the legal affairs of the company, said, "A notice of closure of factory should be given in time so that workers are not deprived."

Prime Minister Sheikh Hasina, meanwhile, expressed ; bitter disappointment at police firing on garment workers' demonstration that left three people dead. The PM said she could not understand why the law enforcers had to open fire on the demonstra-

Western diplomats remain concerned that unless the government further amends the International Crimes (Tribunals) Act 1973, the trials of war criminals may not meet the minimum international standards of due process and fairness.

Bill seeks to drop experience clause



16,100 Bangladeshi workers in Maldives to be regularised

The Maldives government is going to permit 16,100 undocumented Bangladeshi workers to stay and work there, Expatriates' Welfare and Overseas Employment Minister Khandaker Mosharraf Hossain said on his return from the country yesterday.

"Maldives authorities assured us that they would not deport any Bangladeshi workers. Rather, the country will try to employ them from January next," the minister told journalists at his office.

Earlier, the Maldives deported several hundred irregular workers after the global recession hit its economy. Thinking another 16,100 workers could face the same fate, the Bangladesh mission initiated a dialogue with Maldives authorities that was


