Accident sparks protest

Vehicular movement on the Jessore-Magura highway came to a halt for three hours yesterday as locals protested death of a schoolboy in an accident at Hashimpur Bazar. Victim Mostafa, 7, was son of Mofizuddin of Hasimpur village under Sadar upazila and a class two student of a local school. Locals and police said, the accident took place when Mostafa was crossing the highway on his way to school. A Jessore-bound truck crushed him under its wheels at about 10:00am. Agitated people put up barricade on the Jessore-Magura highway at Hashimpur Bazar resulting in a 10-kilometer long tailback on the road. The barricade was withdrawn at about 1:00 pm after local MP Khalidur Rahman Tito and district administration assured them of taking punitive action against the culprits.

Kidnapped girl rescued

Youth gets life for rape

A Jessore court on Sunday sentenced a youth to life term rigorous imprisonment for raping a schoolgirl. The court also fined him 20 thousand taka, in default, to suffer more 5 years in jail. Convict Hakim alias Sagor, 24, is son of Sheikh Abdur Rahman of Dharmapur village under Keshabpur upazila. According to prosecution story, Sagor raped the class nine student of Chingra Secondary School several times on false promise of marriage. When she got pregnant, Sagor refused to marry her. The victim's father later filed a case with Keshabpur police station on 2001.

The accused appeared before the judicial magistrate court in Habiganj on Sunday and prayed for bail. The magistrate granted bail to nine while rejected Azad's paryer and sent him to the jail hajat.

Six coastguards finally closed, probe ordered

Sister of deceased Saudi expatriate Zakir Hossain has lodged a murder case against seven coastguard men including the commander of Patharghata contingent on charge of beating his brother to death.

Six members of Patharghata coastguard contingent have been closed to the regional station and a three-member probe committee has been formed to probe the incident, said Lt Musfiqur Bhola region.

The probe committee headed by coastguard Commander Saidul Islam and comprising Lt Com Kibria and Lt Mushfigur Rahman have been asked to submit report within a week, he added.

Zahid have been made accused in the murder case filed on Sunday by Zakir's sister Taslima.

Police found the body hanging from a ceiling fan and sent it to Barguna mortem examination.

BCL rivals at BAU lock in fierce clash

At least 10 activists of Bangladesh Chhatra League (BCL) were injured in a factional clash at Bangladesh Agricultural University (BAU)

here yesterday. Two BCL factions--one is led by BAU unit President Sarwar Morshed Akand and the other by Atiquzzaman Royal clashed over taking control of the campus, leaving 10 activists from both sides injured.

Two of the injured, identified as Rubel and Ananta Sarker, were admitted to Mymensingh Medical College Hospital (MMCH) while the rest given first aid.

Law enforcers from Kotwali Police Station went to the campus, fired 17 rounds of rubber bullets and teargas shells to disperse the clashing groups.

They also arrested nine BCL activists from the spot. They are Bappi, Joynal Abedin, Marfudul Haque, Tanvir Ahmed, Faruq Hossain, Shyamol Chandra, Golam Mustafa, Abu Horaira and Sumon.

Later, the law enforcers raided four dormitories of the university ---Bangabandhu Hall, Shamsul Haque Hall, Fazlul Haque Hall, and Nazmul Ahsan Hall and recovered sharp weapons. Campus sources said no one was arrested during the

> Contacted, BAU Proctor Prof Shamsuddin said the university authorities will investigate the incident and take necessary actions against those involved.

Additional police have been deployed on the campus to avert any further incident.

The authorities of Darshana Carew's and Co in Chuadanga have filed a case against its head clerk Nasir Uddin for misappropriatingTk1.13 crore.

The cases, filed on September 14 and October 31, were based on findings of an investigation committee formed to probe the allegations.

Process is on to file another case another case against Nasir, as the latest report of the investigation committee, submitted on October 30, also found the allegation of misappropriating the money true and recommended legal

action against Nasir. The company has 16 distilleries across the country -- 13 for selling local product and three for foreign liquors -- and the lakh from Nasir's house.

distilleries send their monthly income to the company's managing director (MD) investigation report to company MD Ali through distillery section by demand draft (DD), said Carew's sources.

The money is finally deposited to bank in the name of the company.

Nasir Uddin, who looked after the matter, did not deposit Tk 1.13 crore sent by three distilleries at Srimangal, Santahar and Parbotipur during January to April and misappropriated the money, said company sources.

To probe the incident, a threemember committee headed by Additional Deputy Manager Abdul Matin was formed On August 28.

The probe body members examined documents, interrogated Nasir and recovered several DDs worth about Tk 63

After the committee submitted its Ashraf on October 30, Nasir gave a written deposition to the MD.

Crop production has already reduced in the district due to application of the spurious fertilisers, shattering hopes of the growers, they

However, sale of these adulterated fertilisers have been going on openly due to indifference of the authorities concerned, sources said.

Lebu Miah, a farmer of Elenga in Kalihati upazila of the district, said he has already applied 25kg urea, 10kg gypsum and 1kg zinc sulphate in his 40 decimal amon paddy field in two phases.

"Amon plants have turned reddish while the grains are vet to be matured because of spurious and substandard fertilisers," he lamented.

Kazimuddin, Mozammel Hossain, Abul Miah, Siraj Miah, Haji Shamsul, Abul Kashem and other farmers of Delduar and Sadar upazilas have also

Gopalpur upazila recently seized 12 sacks of China TSP fertiliser from a fertiliser shop at Mahmudpur Bazar and sent samples to Dhaka for examination. The test found

that the fertilisers were substandard, sources said.

Jahangir Hossain, a subdealer at Putiajani Bazar in Delduar upazila, said farmers often complain of poor effect or no effect of the fertilisers. They have already informed this to the local agriculture officials, he added.

"We have little to do as we sell the fertilisers after buying it from the dealers," he said.

Agriculture officials in Sadar upazila said they were directed by higher authorities to send five samples of fertilisers to Dhaka for examinations. And we are working as per the directive, they said.

A few traders, however, claimed that the farmers are not getting satisfactory result from the fertilisers as they cannot use them properly.

Contacted, deputy director of Tangail DAE Haripada Ghosh told The Daily Star that at least 57 samples of different fertilisers from 12 upazilas in the district were sent to Dhaka for examina-
