

Indian NH Group keen to set up 1000-bed hospital

Narayana Hrudayalaya (NH) Group of India will set up a 1000-bed cardiac and multi specialty hospital on five lakh square feet of land in the port city involving an estimated cost of Rs 243 crore.

Renowned Cardiac Surgeon Dr Devi Shetty has taken the initiative to set up the world class healthcare institution.

NH Group has already sent a proposal to Chittagong Port Authority (CPA) for land to construct the hospital. A CPA team is likely to visit two NH Group institutions in Kolkata and Bangalore of India within a week, sources said.

The proposed 1000-bed hospital with specialised treatment facilities to the patients would have 180 Intensive Therapy Units, 100 Intensive Cardiac Care Units, 530 ward beds, 40 dialysis beds for treating chronic kidney patients and 150 specialised oncology department.

There would be 15 cardiac operation theatres, 15 multi-specialty operation theatres and five fully equipped latest cardiac catheterization labs.

The other salient features of the hospital would include a fully operational out patient department and diagnostic facilities offering ECG, Echo, Treadmill test, CT, MRI, ultrasonography and radiological services.

Besides, there would be a digitally equipped fully automated pathological lab and blood bank, a special unit offering comprehensive heart/health check up programmes and a radiotherapy room for treatment of oncology patients.

CPA formed a seven-member committee with representatives from CPA, Chittagong

Medical College and Hospital and the district Civil Surgeon office in this regard.

After examining and study of the proposed project, the committee made a few more queries, including those regarding mode of investment and returns, said the committee Member Secretary Jillur Rahman.

CPA on November 1 in a letter to Dr Kunal Sarker, a senior consultant cardiac surgeon and vice-president of NH Group, to furnish at the earliest convenience some information about the proposed healthcare centre to be set up following Bangladesh Private Sector Infrastructure Guidelines (BPSIG).

The information CPA sought about the project included brief description, feasibility study of reasonable depth, technical specification, estimated cost, performance parameters and the nature of output. It also wanted to know economic, financial and environmental sustainability, rights and obligations of the investor and the government, qualifications, financial capability and experience of the investors.

In the letter CPA also made it clear that government subsidy or existing assets, equity participation or direct loan guarantee may be granted.

When contacted CPA chairman said, "CPA responded to the proposal very positively and a detailed study is now going on to get it materialise. We have already sent a letter to NH Group asking them to send us a concrete proposal to go ahead with it."

"We have received an invitation from NH group to visit its institutions in India and a team is getting prepared to go there within a few days," he said while talking to this correspondent on Sunday.

Agar plantation on indigenous people's land

50 indigenous families fear eviction in Rangamati

Department of Forest (FD) has taken an agar plantation programme in the name of creating social forestation on 25 hectares of land in Rangamati, threatening livelihood of 50 indigenous poor families.

The locals alleged that the programme has been taken to evict the local indigenous people from their lands in the remote Tarachhari areas at Farua union under Bilaichhari upazila of the district where they have been living for decades.

Chittagong Hill Tracts (CHT) South Forest Division created an 'Agar Bagan' on the land to create social forestation on the participatory basis with the local people, sources said.

But the forest department did not sign any agreement with the locals or involve them with the work, indigenous villagers said.

Under the countrywide Agar Project, Tk 45 lakh was spent in

plantation of agar trees in Rangamati Forest Circle last year. Same amount will also be spent in this regard this year, sources at forest department said.

Agar saplings have been planted on the land where local indigenous people cultivate.

Indigenous people said the forest officials neither informed them nor discussed before plantation of agar trees on their lands.

Amar Kumar Tangchangya, vice-chairman of Bilaichhari upazila, said according to social forestation rules an agreement must be completed with participation of locals in the work before plantation. But the forest officials planted agar trees without any agreement and involving the locals with the works. "I think an ill motive worked behind the project or the foresters did it for embezzlement of the project money," he added.

Bangala Tangchangya said he has been cultivating four acres of land for the last 34 years. He has planted banana, papaya, turmeric and ginger on the land this year. Bangala said unfortunately, the officials have also planted agar trees on the land without his permission.

He said the officials identified as Farid and Abdur Rashid planted trees on his land as per the directive of Amir Hossain Chowdhury, divisional forest officer (DFO) of CHT South Forest Division. The officials often threaten them of filing cases against the indigenous people when they protest, he added.

Dilip Kumar Tangchangya, a UP member of Farua union and also a headman, said he has been living on 40 acres of land for about 45 years. He said he is disappointed at the attitude of the forest officials towards the indigenous people.

He said though the DFO discussed with them about the social forestation on participatory basis but he has violated his commitment, creating an 'Agar Bagan'.

There are 50 indigenous families under 13 households in Farua union,

sources said.

When contacted, Amir said the indigenous people have been residing on reserve forestlands illegally for long. He said they have an order to evict them from government land, which they have not done yet.

Amir said concerned 50 indigenous families are involved with the agar forestation as per the rules of social forestation. Accordingly, they will get 45 per cent as benefit, government 45 percent and a fund will be created with 10 per cent of the benefits for further creation of social forestation, he said.

Ratan Kumar Majumder, conservator of forest (CF), Rangamati circle, said they have no plan to evict the villagers as they have been living on the land for about 50 years. They never tried to evict them despite government orders, Ratan said, adding that they (indigenous people) are the main beneficiaries of the project while a vested quarter is trying to foil the project.
