

Thousands pay tributes to Bangabandhu Special prayers held

Thousands of people yesterday gathered at Dhanmondi Road-32 in the city to pay tributes to Father of the Nation, a day after the final verdict in Bangabandhu murder case was pronounced.

People from all walks of life including political leaders and activists placed wreaths at the portrait of Bangabandhu Sheikh Mujibur Rahman in front of Bangabandhu Memorial Museum.

Prime Minister Sheikh Hasina also visited the museum in the evening and offered magrib prayer there.

Bangabandhu was assassinated along with his family members on August 15 in 1975 in this house, which was later turned into a museum.

People also placed wreaths and offered special prayers at the grave of Bangabandhu in Tungipara.

Meanwhile, leaders and workers of Awami League (AL) and its associate bodies yesterday offered special prayers at all mosques and other houses of worship across the country. Senior party leaders

Jail killing case govt's next priority

Plans to go for legal battle against HC judgement; seeks to defend verdict against 5th amendment

The government plans to go for legal battle with the Supreme Court to rescind the High Court verdict that acquitted six former military personnel of the killing of four national leaders in jail on November 3, 1975.

It will also fight to defend the HC verdict on August 29, 2005, that declared the fifth amendment to the constitution illegal and unconstitutional for endorsing power takeover by late president Ziaur Rahman and all the activities since August 15, 1975.

After the SC gave verdict in the Bangabandhu murder case on Thursday, the government now even plans to complete the hearing on its five appeals against the August 28, 2008, HC verdict in the jail killing case within December.

The attorney general's office filed the leave-to-appeal petitions on behalf of the government with the apex court on September 14 this year; four of the appeals against the acquittal of four army personnel with life term and another against the acquittal of two sentenced to death.

Attorney General Mahbubey Alam yesterday told The Daily Star that his next target is to get the HC verdict in the jail killing

RENTAL POWER PROJECTS

PDB's bid to protect defaulter companies

Instead of cancelling contracts for failing to commercially launch power plants even after more than a year, the Power Development Board is seeking the power ministry's nod for an "amicable solution" for six rental power projects of four local companies.

In a letter to the ministry, the PDB sought this nod as all of these companies have resorted to the court to obtain stay order on payment of penalties for their failure to launch their plants even after

the PDB had grossly extended the deadlines as a favour.

Of these six contracts, five deal with three-year rental power agreements while the other deals with a 15-year agreement.

The three-year contracts dictated that they would pay penalty of \$500 per megawatt capacity for up to two months of delay.

Other terms of the contracts dictate when and how these contracts should be cancelled in case of failure. The PDB had served these defaulter companies with the intent of notice for cancellation of

their contracts. But it never actually cancelled them.

The PDB now feels that these companies' resorting to legal courses is a delay tactic to do away with the three-year contract period without paying any liquefied damage.

Of the five three-year projects, only two have finally managed to begin commercial operation beyond their deadlines.

Three of the five projects are being implemented by Energy Prima of the

Tarique coming back to politics

BNP Chairperson Khaleda Zia yesterday said her son Tarique Rahman would take part in active politics on his return from abroad after completing treatment.

Tarique has been away from active politics since he left the country for London during Fakhruddin-led caretaker government.

"Pray for him [Tarique] so that he can come back to you," she said while addressing a street gathering in Sirajganj on her way to Bogra.

She alleged that the last caretaker government lodged false cases against Tarique and tortured and sent him abroad to make her party lose in the general elections.

In another meeting at Sultanganj High School ground in Bogra, Khaleda said conspiracy snatched two constituencies from BNP. She urged people to stay alert so that such incident

Train tickets for Eid trips sold out

7 special trains not enough for home-bound people

Train tickets for the homebound people on the occasion of Eid-ul-Azha have already been sold out only leaving scopes for travelling standing in the compartments or on the roofs risking lives and limbs.

Bangladesh Railway (BR) and other sources said the short vacation of Eid-ul-Azha caused the ticket crisis as a large portion of people choose government-run railway for cheaper travel and lesser risk.

The BR authorities started selling tickets in advance from November 18. They sold tickets for November 23 on November 17 while November 24 on 18th, November 25 on 19th and November 25 yesterday.

Tickets for November 26 will be available today while November 27 tomorrow.

Though the BR authorities have arranged seven special trains and added a number of compartments with almost all the trains, hundreds of people were found standing in long queues for hours yesterday.

20 lakh sit today for primary final exams

Primary Education Terminal Examination, the newly introduced public exam, begins today for the first time in the country with the participation of around 20 lakh students of class V.

The examination, which is considered the largest public examination, will start around 10:00am at 5,343 centres across the country and another five overseas.

Examinations of six subjects will be held in three days on November 21, 22 and 24. A total of 1,98,01,80 students -- 9,09,984 boys and 10,70,196 girls -- will take the examination.

Rare animals on sale

Endangered birds also sold illegally at a weekly market in Tongi

It is a weekly pet market. Bird lovers gather here to buy pigeons and other species of birds and animals on Sundays.

Except traders of pigeon and poultry, huntsmen also gather here to make a profit with birds held from different villages. Some of those birds are sold as pet, while others are meant for meat.

Even wild birds and animals, trade of which is forbidden by the law, are available in this market located just beside the Tongi Bridge.

Endangered hilly myna, Alexandrian parakeet, blossom headed parakeet, rhesus monkey, kalim, pond heron, cattle egret, spotted dove, mongoose and many other species of birds were found during a recent visit.

According to the Wildlife (Preserva-

tion) Act, 1974, it is prohibited to kill, trap, capture and trade wild birds and animal and the act is a punishable offence.

The Department of Forest is now working on formulating even a stricter law to conserve the country's wildlife. According to the law, anyone will face a fine of Tk 1,000 and six months in prison for capturing, killing, possessing and trading of wildlife.
