PM's INDIA VISIT Deals likely on power, railway infrastructure

Bangladesh and India may sign two deals on the purchase of electricity from India and developing Bangladesh's railway and roads with Indian funding when Prime Minister Sheikh Hasina visits New Delhi this month.

Bangladesh foreign ministry officials said Dhaka would emphasise signing a deal on sharing the water of the Teesta during Hasina'a visit. Bangladesh is also expected to put forward a draft of the deal. But it is still not sure whether any deal will be inked during the visit since the matter is to be settled at the highest politicallevel.

On Wednesday, the two countries at the end of home secretary-level talks in New Delhi finalised the drafts of three deals--Agreement on Mutual Legal Assistance on Criminal Matters, Transfer of Sentenced Persons and Combating International Terrorism, Organised Crime and Illicit Drug Trafficking.

Arrested Ulfa chief 'taken to Delhi'

Indian separatist group United Liberation Front of Asom (Ulfa) chairman Arabinda Rajkhowa has been taken to Delhi from Tripura where he surrendered to the security forces, report BBC News and Indian media.

Rajkhowa's wife Kaberi Kachari and their two sons were put under house arrest in Dhaka, the media reports add.

Indian daily the Hindustan Times reports that the Ulfa chief was pushed back on Wednesday by the Bangladesh authorities into Tripura and later flown to New Delhi yes-

terday evening. Two other top Ulfa leaders -Chitrabon Hazarika and Sasha Choudhury -- were detained in Bangladesh last month and subsequently handed over to India, while Ulfa general secretary Anup Chetia is confined in

SAFF football championship Huji founder makes startling confession

Details his role to magistrate; reveals involvement of top politicians, officials in Aug 21 grenade attack

Founder of banned Islamist outfit Harkat-ul-Jihad al Islami (Huji) Sheikh Abdus Salam yesterday confessed to his involvement in the August 21, 2004 grenade attack on an Awami League rally.

In a statement given to a Dhaka court, Salam also disclosed the names of a number of top administrative officials and politicians as involved in the gruesome attack.

After his statement was recorded by Metropolitan Magistrate Moazzem Hossain,

Salam, also chief of Islamic Democratic Party, was sent to jail.

Another metropolitan magistrate's court yesterday sent Pakistan-based Lashkar-e-Taiba (LeT) member Abdul Majid Butt alias Abu Yusuf Button a two-day fresh remand.

In his confessional statement, which came after 15 days' remand by the Criminal Investigation Department in phases, Salam narrated the planning and implementation of the grenade attack that left 24 persons killed and 300 injured.

Govt issues gazette on new pay scale

AL asked to amend its charter again

EC declines to compromise on RPO violation

The ruling Awami League (AL) will have to further amend its constitution in line with the Representation of the People Order (RPO) as the Election Commission (EC) has declined to compromise on the issue with any political party.

The EC at a meeting with an AL delegation yesterday asked them to amend the party constitution again to drop provisions which run counter to the RPO, meeting sources said.

AL constitution does not allow amending any of its provisions without holding council. The party delegation informed the EC about this difficulty.

The AL held its council on July 24, ratified the provisional changes in its constitution to get registered with the EC before the ninth parliamentary election, and submitted a copy of those to it.

The EC found two provisions in the ratified AL constitution inconsistent with the RPO, and asked the party on November 22 to further amend it.

"We asked Awami League to amend its constitution and submit it to the commission as soon as possible," Election Commissioner Muhammed Sohul Hussain told journalists following yesterday's meeting with the twomember AL delegation.

2 outlaws killed in 'shootout'
