1. This invitation for bids follows the General Procurement Notice for this project that appeared in Development Business, Issue Nos 652, dated April 16, 2005.

2. The People's Republic of Bangladesh has applied for a credit from the International Development Association (IDA) toward the cost of Health, Nutrition and Population Sector Programme (HNPS), and it intends to apply part of the proceeds of this credit to payments under the contract for procurement of 125000 pieces of Lungi under Contract Package No. GFP-09/09.

3. The Director (Logistics and Supply) and Line Director (Procurement, Storage and Supply Management), Directorate General of Family Planning of the Ministry of Health and Family Welfare now invites sealed bids from eligible and qualified bidders for procurement of 125000 pieces of Lungi from eligible bidders who have manufactured and/or supplied similar goods for three years and specific goods (Lungi) for at least last two years under this invitation for procurement of:

A bidder may bid for one or more sub-packages, if bidding for more than one sub-package, each sub-package should be bid separately. For each separate bid, bidders must submit separate bid submission form, price schedule and bid security. Bidder must bid for entire quantity of goods requested in each sub-package. Evaluation and comparison of bids will be carried out simultaneously to determine the bid or combination of bids offering the lowest price to the purchaser for each sub-package. Price reductions or cross discounts will be considered in the evaluation and comparison of bids for more than one sub-package.

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004 and is open to all bidders from eligible source countries as defined in the Guidelines.

5. Interested eligible bidders may obtain further information from the address mentioned below and inspect the bidding documents from 09:00am to 5.00pm in the working days.

6. A complete set of bidding documents in English may be purchased by the interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of Taka 6,500 (six thousand and five hundred only) or US\$ 100 (US dollar one hundred) only. The method of payment will be Pay Order or Bank Draft from any schedule bank in Bangladesh or Certified Check from reputable foreign bank acceptable to the purchaser. The bidding documents may be sent by courier service/by air mail or may be collected through authorized representatives.

7. Qualifications requirements include: (for each sub-packages)

Financial Capacity:
The bidder shall furnish documentary evidence that it meets the following financial requirement(s): The minimum amount of average annual turnover is: BDT 30,000,000.00 (thirty million) or 430,000.00 (four hundred thirty thousand) US dollar during the last three years which will be supported by audited financial report prepared by any independent Chartered Accountant firm.

Experience and Technical Capacity:

(a) The bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s): i) documentary evidence of having Annual Production Capacity of at least twice the required quantity specified in the schedule of requirements. ii) certificate of incorporation/certificate of registration/trade licence (which one is applicable) in the country of manufacture of the goods. iii) manufacturing licence by regulatory authority in the country of manufacture. iv) at least two (2) years experience in manufacturing and marketing of specific goods and three (3) years experience in similar goods for which the IFB is issued.

(b) If the bidder is a supplier then it should have, (i) certificate of incorporation/certificate of registration/trade licence (which one is applicable); (ii) at least two (2) years supply experience in specific goods and three (3) years supply experience in similar goods for which the IFB is issued; (iii) the bidder should provide evidence of being duly authorized by the manufacturer, meeting the criteria under ((a) i,ii,iii,iv,) above, to supply the goods in the purchasers country, as per manufacturer authorization form under section IV, bidding forms.

Supply Experience:

The bidder should have satisfactorily completed at least 1 (one) contracts of the size of the subject procurement within the last five years.

8. Bids must be delivered to the address below at or before 12.00 noon of Bangladesh Standard Time (BST) on 20/01/2010. Electronic bidding will not be permitted. Late bids will be rejected and shall be returned unopened. Bids will be opened in presence of the bidders' representatives who choose to attend in person at the address below at 12:30pm on 20/01/2010. The bids must be accompanied by a bid security of Bangladesh Tk 125,000.00 or US\$ 1800 or equivalent amount in freely convertible currency for each sub-package. The bid security shall be given in the form and manner detailed in the instruction to bidders.

9. A pre-bid conference will be held on 21/12/2009 in the office room of undersigned at 11:30am BST. All prospective bidders' representatives are requested to attend the conference in time.
