"A no-confidence motion will be rejected if it fails to get support of two-thirds of the councillors," Goyeshwar told The Daily Star yesterday over telephone.

However, the document does not have this provision.

It shows a new provision was brought to the provision on holding any national council meeting. The provision says any demand raised in such meetings will be rejected if it fails to obtain support of twothirds councillors.

Within moments of deletion and inclusion of the provisions in the council session, BNP Senior Joint Secretary General Tarique Rahman was elected the party's senior vicechairman unopposed.

The new provision gave more sweeping power to both the party chief and the senior vice-chairman.

It says the senior vicechairman will assist the party chief in discharging his or her duties and will perform any responsibility assigned to him by the party chief. The senior vice-chairman will be the acting party chairman in temporary absence of the party

"If the post of chairman falls vacant on any ground, senior vice-chairman will fill the vacuum and discharge the responsibilities of the chairman for the rest of the tenure," the new provision says.

empowers the BNP chairman to appoint special assistants, if necessary, to assist him/her to run party activities. The party chairman himself/herself will specify the number of these special assistants and determine their organisational status, it says.

Another provision empowers the party chairman to fill up the vacuum in the party's national standing and executive committees.

Earlier, a provision was included in BNP's constitution to make it compliant with the Representation of the People Order (RPO), empowering the party national council to hold election to the posts of office bearers and members of the two committees.

Another amendment to the party charter empowers the BNP chairman to continue his/her duties as party chief after expiry of tenure until a new chairman is elected and assumes office.

Amending the constitution, the tenure of the chairman was increased to three years from two years. The tenure of the national executive committee was also increased to three years from two years and it will continue functioning until a new committee assumes charges after election.

Regarding taking disciplinary actions against party members, an amendment to the constitution provides more authority to the party chief, aggrieved by a disciplinary action can file an appeal with chief.

the chairman against the decision. The party chief will make the final decision, it says.

According to the existing provisions in BNP's charter, the party chief is empowered to take disciplinary actions against party leaders and members on an urgent basis.

In exercise of this authority, BNP Chairperson Khaleda Zia on September 3, 2007 expelled the then secretary general Abdul Mannan Bhuiyan and joint secretary general Ashraf Hossain who moved to bring reforms in the party to ensure democracy within it. Their reform proposals were also aimed at excluding Khaleda, who has been holding the post since 1983, from the party

For registering with the Election Commission ahead of the ninth parliamentary polls, a provision was included for election to the posts of office bearers and members of the party's national standing and executive committees, literally curtailing the party chief's exercising power to make appointments to those posts.

But, Tuesday's national council, which was held after a gap of 16 years, empowered Khaleda to nominate office bearers and members of the two bodies including party's secretary general as she did in

According to the new provision, Khaleda, who was re-Another new provision elected the chairperson on December 4, Tarique Rahman, who was elected the senior vice-chairman on Tuesday, and the person to be made the secretary general will also be considered as elected members of the committee.

> The existing provisions in the BNP charter still empower the BNP chairperson to dissolve the two committees and any other committee nominated by her if she thinks necessary and the party chief does not require consulting with the national council to do so.

> As the chief of both the committees, the party chairperson will determine the jurisdiction and functions of the office bearers and members of the two committees.

But changes were made in the party charter regarding the timeframe for holding meetings of the party forums.

The national standing committee will now sit at least once in three months instead of one month while the national executive committee will sit at least once in six months instead of the previous three months.

Instead of holding the council meeting once a year the national council itself will be held once a year, if possible.

The secretary general will convene the meeting of the national council upon the party chief's suggestion in writing, says the amended provision. In the past, the saying a party member secretary general could do so on consultation with the party

Dhanmondi Club had occupied the playground illegally for five decades and rented it out for commercial purposes under the very nose of DCC, Khoka said, "I don't know about it."

Barrister Sheikh Fazle Noor Taposh, a lawmaker of the area, said the playground is a breathing space for the locals and said if locals approached him he would remain in favour of the open space.
