

2001 POST-ELECTION VIOLENCE

Committee to probe atrocities soon: PM

BSS, Dhaka

Prime Minister Sheikh Hasina yesterday said her government is going to constitute a committee in line with the verdict of the High Court to probe the atrocities carried out on the innocent people across the country immediately after the 2001 general election.

Hasina, also ruling Awami League president, called upon leaders and workers of her party to gather necessary data and information on the atrocities and give those to the commission to expedite the investigation process.

She also reaffirmed her government's firm commitment to hold trial of war criminals, killers of intellectuals and perpetrators of all inhuman acts during the War of Liberation to establish rule of law in the country.

"The trial of the war criminals, killers of intellectuals, and others who were involved in

inhuman acts must be held on this soil," she said while taking part in a discussion organised by Awami League at Bangabandhu International Conference Centre in the city marking the Martyred Intellectuals' Day.

She said Father of the Nation Bangabandhu Sheikh Mujibur Rahman had started the process to hold trial of war criminals and killers of intellectuals after the War of Liberation through promulgating an act in 1973.

"After that many were arrested and remained absconding," she said, adding that after the assassination of Bangabandhu along with most of his family members the process remained stalled.

Even, she said, Ziaur Rahman, former president and founder of BNP, set them free and made many of them ministers and leaders of his party paving the way for them to be politically rehabilitated.

Hasina said trial of the killers of Bangabandhu was held in the normal course of law. "We maintained patience and got the result," she added.

Hasina said after the brutal assassination of Bangabandhu, the killers were given jobs in different important positions even in Bangladesh missions abroad.

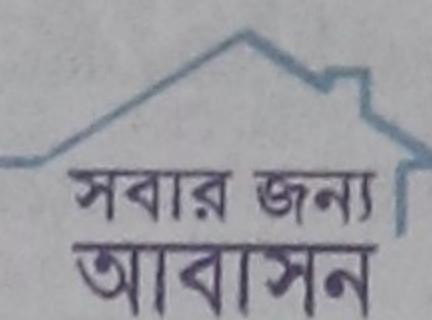
"Now I am leaving the responsibility to the people to hold trial of those who have awarded the killers of Bangabandhu and even who tried to politically rehabilitate them through the February 15 farical election," she added.

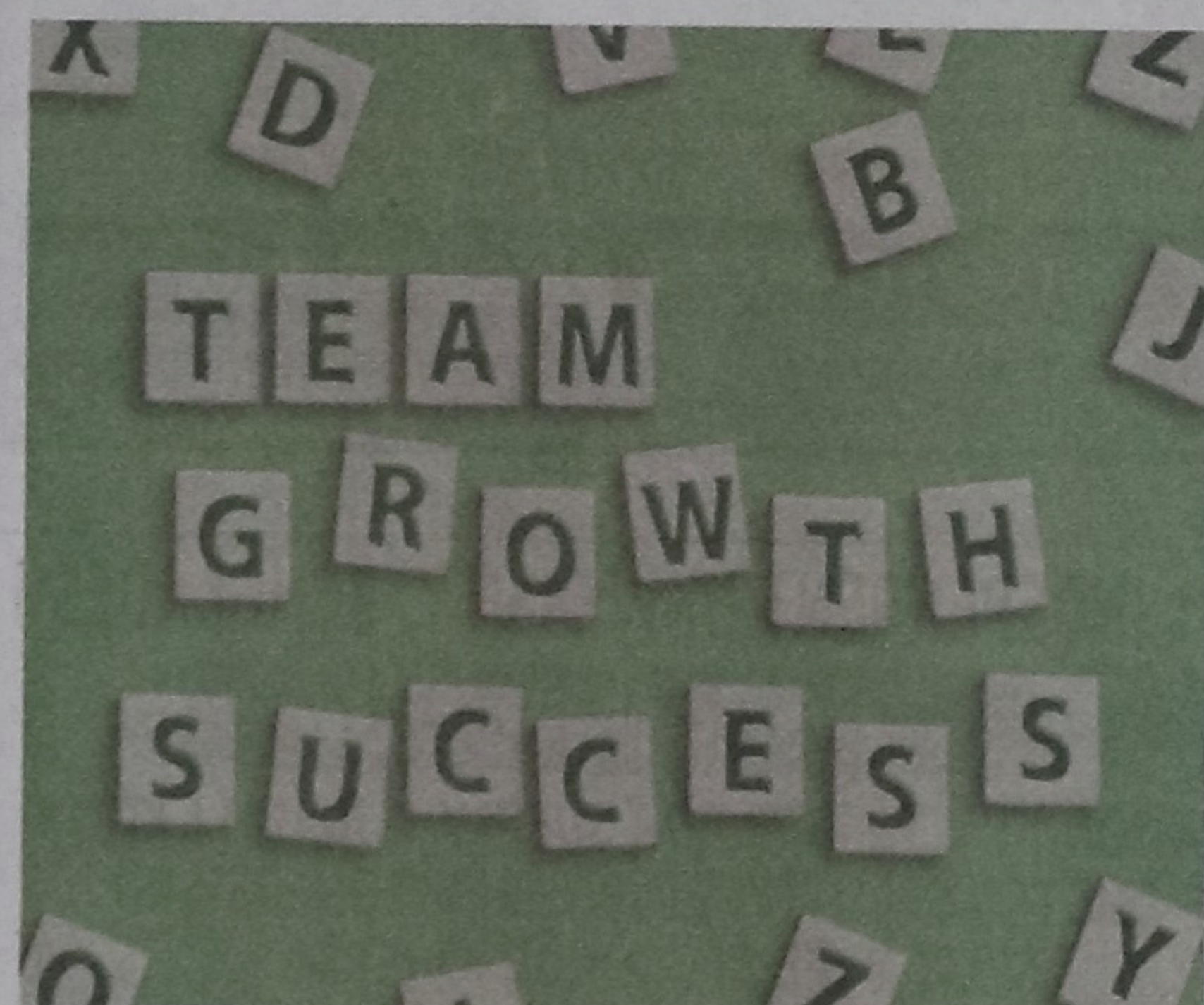
