Major rivers in Sylhet dying for siltation

Major rivers and their tributaries in greater Sylhet region see gradual decrease in their flow due to massive siltation in absence of planned dredging, causing a serious threat to the environment in the region.

Hundreds of shoals have emerged in Surma, Kushiyara, Khowai, Dholai, Monu, Kalni and Piain rivers and their tributaries as their flow reduced drastically, said experts and officials of Bangladesh Water Development Board (BWDB). Most of the rivers flowing through Sunamganj, Habiganj, Moulvibazar and Sylhet districts have virtually turned into Bangladesh and Indian state of narrow streams.

at its starting point across the border, BWDB officials said.

It gets only 20 percent while the Kushiayara gets 80 percent of the poor water flow, said Prof Zahir Bin Alam of civil and environmental engineering department at Shahjalal University of Science and

Technology.

In 2005, officials of Assam at several regional level meetings had agreed to impledredging the Surma in Sylhet and the Barak in Assam to increase their flow. But the work is yet to The Surma is being silted up start, BWDB officials said.

In absence of planned dredging, the other rivers and streams of the region are also facing the same fate while organised groups are engaged in illegal extraction of sand from the water bodies, causing harm to them.

"It is not possible for us to take any dredging project

locally. The plan will have to be taken at the central level as dredging is very expensive," said Shafiqul Islam, BWDB executive engineer in Sylhet.

"The underground water level also sees gradual falling in the region. If the situation continues, a desertification process will begin in the northeastern region," he said.

Against this backdrop, India's plan to construct the proposed Tipaimukh Dam on the Barak River for implementing a hydro-electric project in Manipur state has become a cause of concern for the people of Sylhet region.

ABDUCTION CASE Indigenous youth held in Bandarban

Police on Sunday arrested an indigenous youth in connection with the abduction of a businessman and a deputy assistant engineer from Roangchhari upazila.

The arrestee was identified as Najang Hla Kheyang.

Criminals abducted the two from Baro Para area of the upazila on December 27 morning and demanded Tk 6 lakh ransom.

Police said, the arrested youth bargained for the criminals and on receipt of Tk 6 lakh as ransom the abductors released the businessman and the engineer at 10:45 pm, about 14 hours after the incident.

In Satkhira, five fishermen, who were abducted by Indian pirates bought freedom on Sunday, reports UNB.

One of the victims, A Sattar Sheikh, 45, of Harin Nagar village in Shyamnagar upazila said he along with four fishermen went to catch fish in the Sundarbans on December 31.

Indian pirates belonging to Khora Shaukat gang kid-napped them while they were fishing in Kasikata area of the Raimongal River, he said.

The victims said the abductors set them free near Badurjhuri canal at Kalagasia on payment of ransom for each Tk5000 on Sunday morning.

Robbery in Cox's Bazar

Armed robbers looted valuables from four vehicles injuring 15 people on Cox's Bazar-Teknaf highway at Thainkhali Dhala in Ukhia upazila on Sunday morning.

Witnesses said a gang numbering 15/20 swooped on the vehicles, including a night coach, two goods-laden trucks and a microbus putting barricade on the road early in the morning.

Later, they took away cash taka, gold ornaments and mobile phone sets after beating the passengers mercilessly.

Pesticides may also kill ignorant farmers

Farmers and workers spraying pesticides in crop fields are highly vulnerable to various diseases as the job, often done without any safety measures, make them absorb the toxic item in different ways including inhalation.

The amount of pesticide received by a person varies from 0.15 to 0.25 gram (weighed in powder form) per hour, depending on weather at the time of spraying it in a crop field.

The information came to light as Rural Development Academy (RDA) in Bogra conducted a five-year research programme in Amrul union under Shahjahanpur upazila of Bogra district in cooperation with CABI Bioscience UK.

Published about two

months ago, the research report says that all the farmers under observation lacked knowledge on technical matters and safety measures about pesticide spraying.

Farmers involved in pesticide spraying do not understand the health hazard during spray and afterwards, the report says, adding that many farmers often blow from the mouth into the spraying pipe to make it

"Farmers are advised to apply a kind of 'massage oil' on the whole body to prevent liquid pesticide to harm the skin. They should also wear adequate dress at the time of spraying. As farmers generally wear short dresses, liquid pesticides affect the body directly and cause problems like uneasy feeling, vomiting and even fainting," said agriculturist AKM Zakaria, joint director of Bogra RDA and coordinator of the research programme.

RDA scientists also invented a transparent mask to prevent pesticide inhaling

by sprayers.

"Earlier I felt uneasy after spraying liquid pesticide as I did not have knowledge for spraying it safely and did not know the use of newly invented mask. Several farmers including Hamidul Haque and Jahangir Alam of the same village fainted too. Now use of the transparent mask helps us," said Md Noor-ul-Islam, 53, of Gopalbari village in Bogra Sadar upazila.

Heart and kidney trouble may occur along with other problems if one continues receiving liquid pesticide, Dr AH Sadik, former professor of medicine at Shaheed Ziaur Rahman Medical College Hospital in Bogra, said.

5 hurt as BCL rivals at RU lock in clash

Five activists of Bangladesh Chhatra League (BCL) were injured in a factional clash on Rajshashi University (RU) campus yesterday.

Supporters of BCL leader Awal Kabir Joy-led faction beat up a canteen boy in the morning. As the activists of Majedul Islam Apu-led faction protested it, their rivals swooped on them, leaving Romel, a master's student of genetics department, injured.

Immediately after the incident, supporters of both factions, equipped with iron roads, hockey sticks and firearms, attacked each other, leaving Majedul Islalm Apu and other three others of his faction--Mahbub, Himu and

Sajal--injured.

On Information, RU proctor and assistant proctors along with law enforcers went to the spot and brought the situation under control.

The injured are undergoing treatment at university medical centre.

BCL RU unit General Secretary Ayeen Uddin said action will be taken against those who tried to vitiate the atmosphere of the campus.

RU Proctor Prof Chowdhury Zakaria said additional police have been deployed on the campus to avert further clash.

Meanwhile, BCL RU unit yesterday opened a website on the occasion of its 62nd founding anniversary.

Rab members in separate drives in Shibganj upazila recovered three firearms and bullets and arrested three alleged illegal arms sellers Sunday night.

River route shortens but fare increases

Owners of river transport including launches, trawlers and speedboats on important Mawa-Kawrakandi river route have increased the fares although dredging work during the last one year has shortened the route by almost half and the fuel price decreased.

To reduce the distance to be plied on the route, the present Awami League-led government spent crores of taka for dredging the rivers.

But the initiative, aimed at lessening the sufferings of lakhs of passengers of 21 districts in southern region, actually benefited a few transport owners.

During the dry season last year launches and ferries

had to take 31 kilometres on per passenger fare to Tk 120 Mawa-Palerchar- from earlier Tk 110 under the Mongamajhi channel,

BIWTA sources said. After dredging on two channels, the length reduced to 14 kilometres. Due to emergence of new shoals in the current dry season, the distance is 16 kilometres now, they said.

The price of diesel was Tk 48 per litre last year, which is Tk 44.50 now.

The BIWTA and district council lease fee was Tk 8 and a passenger on this route had to pay Tk 17 last year.

The present government reduced the lease fee to Tk 5

but the launch owners increased the fare to Tk 20. On December 23, owners

of speedboats that ply illegally on the route, increased

Approval of the ministry is required for increasing fare, officials said.

But owners of launches and speedboats are using the names of influential persons of the ruling party to increase fare as per their will, said several passengers.

"Length of the river route came down to almost half as the government arranged dredging at a cost of Tk 12 crore during the last one year. Dredging is still going on. So there is no logic behind increasing the fare," **BIWTA Executive Engineer** (Dredging Division) Masuqul Haq said.

Young man kills father

A teenage boy shot his father dead in the town on Sunday just for a motorbike. Victim Abul Kalam, 50, was owner of 'Book Land' bookstall at Victoria Road. Police and family sources said, Hridoy asked his father to buy him a motorbike. At one stage, he shot Abul Kalam leaving him seriously injured. He was rushed to Tangail General Hospital where the onduty doctors declared him dead.
