Take preparations to rehabilitate 2 crore people abroad

JS body asks expat welfare ministry

A parliamentary standing committee yesterday asked the expatriate welfare ministry to take all-out preparations so that two crore people predicted to be displaced as aftermath of climate change can be rehabilitated abroad with jobs.

The parliamentary standing committee on expatriate welfare and overseas employment ministry also expressed concern over the massive downtrend in manpower

export last year. The watchdog body of the House also asked the authorities concerned to bring back a Bangladeshi worker's dead body which has been kept at a mortuary of a Malaysian hospital for the last one year.

Member of the committee Shaheda Tareq Deepti, who recently visited Malaysia, raised the issue of a dead

Bangladeshi worker there. "The body has been kept at a mortuary for one year. The family and relatives of the dead even do not know about him. It's really unfortunate that the concerned embassy

body back to the country," said Deepti, also a ruling Awami League lawmaker.

On reducing of manpower export, Chairman of the committee Anisul Islam Mahmud said over eight lakh Bangladeshi workers were exported in 2008 while the number reduced to only four lakh last year.

"The reason is severely reducing of manpower export in Malaysia. We exported only 14,000 manpower there in 2009 while the number was around four lakh in 2008." On rehabilitation of dis-

placed people caused by climate change, Anisul said: "It is predicted that around two crore of our people will be displaced because of climateinduced bad impacts. We have asked the ministry to take serious steps from now on so that displaced people can be rehabilitated to European and other countries ensuring their jobs."

The committee chief said this while talking to reporters after the meeting at Jatiya Sangsad Bhaban.

"We have asked the minis-

TAX EVASION

Jalil asked to appear before court Jan 18

A Dhaka court yesterday again asked former Awami League general secretary Abdul Jalil to appear before it on January 18 in connection with a tax eva-

sion case. Judge ANM Bashir Ullah of the Senior Special Judge's Court passed the order after Jalil's lawyer submitted a petition, saying his client could not appear before the court yesterday due to his illness.

The same court asked Jalil on November 17 last year to

appear before it yesterday. The High Court on October 18 granted anticipatory bail for three months to Jalil in the case.

Earlier on October 15, the same court issued an arrest warrant against Jalil hours after the National Board of Revenue (NBR) filed a case against him in connection with dodging income tax of overTk4lakh.

In the statement, the NBR mentioned that Jalil, chairman of Mercantile Bank Limited, evaded income tax worth Tk 4,07,485 on his income of Tk 54,60,234 from the bank for the fiscal years 2003-2008. He concealed his income of Tk 54 lakh in his tax returns.

Jalil repeatedly provided false information about his real income and expenditure, alleged the NBR.

RID PHARMA DIRECTOR GETS BAIL

Police fail to submit reports on execution of arrest warrants

A Dhaka court yesterday granted bail to Sheuli Rahman, a director of Rid Pharmaceutical Ltd and wife of its Managing Director Mizanur Rahman, in a case filed against them for manufacturing toxic paracetamol syrup that claimed the lives of at least 28 children.

Meanwhile, Brahmanbaria Sadar Police Station failed to submit reports on execution of arrest warrants and property attachment of three other defendants in the case, although the court asked the officer-in-charge (OC) of the police station time and again to do so.

Judge Golam Mortuza Majumder of Dhaka Drug Court passed the bail order upon a bond of Tk 50,000 with two guarantors after Sheuli, one of Rid Pharma's directors, appeared before the court and sought bail.

But the court did not pass any order regarding the submission of reports on execution of arrest warrants and property attachment of the three absconding accused.

The accused are director Abdul Gani, and pharmacists Mahbubul Islam and Enamul

Mizan's Lawyers submitted a bail petition yesterday, but the court fixed January 17 for hearing on it. The court also fixed February 17 for next hearing of the case.

On October 12 of 2009, Mizan surrendered to Dhaka Metropolitan Sessions Judge's Court following a High Court (HC) directive, and sought bail. But he was sent to jail.

On August 18 the same year, Mizan's wife Sheuli Rahman appeared before the HC, seeking anticipatory bail and secured it for six months.

At least 28 children died of renal failure following intake of Rid's paracetamol syrup and suspension, across the country from June to August last year.

On August 11, the Dhaka Drug Court issued arrest warrants against the five after Directorate of Drug Administration Superintendent Shafiqul Islam filed the case with the court.

A case against them was filed in Brahmanbaria as well, while three other cases were filed against the Rid management in Comilla, Narayanganj and Sylhet.

CHT land disputes to be solved thru' discussion

ment. The Awami League leader said if there is any contradiction in the peace accord, the government will sit with all the stakeholders and then would take a decision to solve the problem.

About constitutional recognition to the indigenous people, she said the constitution has ensured their rights.

Sajeda stressed the need for taking an initiative to protect their traditional culture, language and lifestyle. Speaking as the special

guest, State Minister for CHT Affairs Dipankar Talukdar said the government had made a progress regarding the implementation of the accord. Chaired by Prof Ajoy Roy,
