## Dhaka, Yangon narrow gap on sea boundary

Agree on demarcation following both equidistance and equity of resources; next talks in April

Bangladesh and Myanmar yesterday decided to demarcate the maritime boundary of the two countries, accommodating the demands of both equidistance and equity of resources as the guiding principles.

The decision came at a two-day highlevel meeting that ended yesterday afternoon at a hotel in Chittagong.

The meeting also decided to hold another round of talks by next April in Myanmar. Additional Foreign Secretary of UN

Myanmar Ambassador to Bangladesh U Phae Thann Oo, who was also present at the meeting, said, "We are very happy with the fruitful discussion. It was a very good discussion. It will continue."

During Friday's talk, Bangladesh and Myanmar both placed their proposals on demarcation, opening the discussion on a positive note to resolve the dispute over the natural gas and mineral-rich zone of the Bay of Bengal.

Bangladesh proposed fixing the maritime boundary following the principle of equity of the resources while Myanmar

recommended line-based equidistance system for demarcating maritime bound-

As per a UN charter, the principle of equity takes into account a country's population, economic status and needs, GDP growth and other humane issues for demarcating maritime boundary. In contrast, the equidistance system marks the boundary through geometric calcula-

If the principle of equity is applied, Bangladesh may get a bigger maritime area than Myanmar wants Bangladesh to have.

## High hopes pinned on PM's India visit

Prime Minister Sheikh Hasina today embarks on her first state visit to India since assuming office a year ago with Bangladesh pinning high hopes on opening up a new chapter in Indo-Bangla bilateral relations and keeping the issues of yawning trade imbalance, security

and water sharing high on the agenda. Hasina reaches New Delhi this evening on a three-day visit, sending signals she would seize the opportunity to seek warmer ties and resolution of longstanding issues with the world's largest democ-

"We are eagerly looking forward to the visit of the prime minister, and I strongly believe it will enable us to build on the already solid foundation of our existing friendly relations with India," said Foreign Minister Dipu Moni at a roundtable in

## Raise major issues boldly, uphold national interest

Khaleda asks Hasina on her India trip

Wishing Sheikh Hasina success on her visit to India, BNP Chairperson Khaleda Zia said the premier should elicit assurance from India about some important issues like water sharing, maritime boundary, trade and market extension for Bangladeshi products and permission for Bangladeshi TV channels in India.

"The visit won't be fruitful if these serious issues are not high on the agenda," she said at a press conference last night at her Gulshan office.

She said BNP wants to cooperate with the government in the greater interest of the country. "We are placing the expectation and aspiration of the people ahead of the prime minister's visit to India so that she can raise the issues boldly to uphold our national interest."

Khaleda said the allegation has been rife that Indian security forces picked up their rebel leaders from Bangladesh territory, which is an extreme violation of the sovereignty of Bangladesh. She hoped Hasina would raise this issue too during her visit to India.

Three of the five death-row convicts in Bangabandhu murder case yesterday sought presidential mercy through the jail authorities.

Lt Col (artillery) Mohiuddin Ahmed, Major Bazlul Huda and Major (lancer) AKM Mohiuddin Ahmed submitted their petitions to the jail authorities, Inspector General (prisons) Brig Gen Ashraful Islam Khan told a press briefing at his office in the evening.

The rest two--Lt Col Sultan Shahriar Rashid Khan and Lt Col Syed Farooqur Rahman--will file review petitions through law-

The jail authorities will today forward the mercy petitions to the home ministry, added the prisons chief.

Law Minister Shafique Ahmed last night told The Daily Star that the home ministry will send the petitions to the law ministry, which in turn will send those to the prime minister's office. From the PMO, the applications will go to the president's

The IG prisons said Sultan Shahriar Rashid and Farooq will have the chance to seek clemency till one or two days before the execution.
