CIA base bomber calls for attacks on US in video

The Jordanian doctor who killed seven CIA employees in a suicide attack in Afghanistan said all jihadists must attack US targets to avenge the killing of the Pakistani Taliban leader, according to a video that appeared posthumously yesterday on an Arabic news channel.

Humam Khalil Abu Mulal al-Balawi appeared next to the new leader of the Pakistani Taliban, Hakimullah Mehsud, and explained how the "emigrants" Muslim jihadists from abroad were given shelter by the Pakistani Taliban and so should exact revenge for US attacks.

In August, Baitullah Mehsud, the supreme commander of the Pakistani Taliban was killed by a CIA missile strike.

"We will never forget the blood of our emir Baitullah Mehsud, We will always demand revenge for him inside America and outside," he said, addressing the "enemies of God" and Jordanian intelligence. "It is an obligation of the emigrants who were welcomed by the emir."

Al-Balawi, wearing traditional Afghan dress, spoke in Arabic during the minute-and-a-half video. Several extremist Islamic Web sites linked to the Jazeera video.

Sanction can't deter Iran from its nuke plan

Says Ahmadinejad

Iran's President Mahmoud Ahmadinejad said yesterday that further UN Security Council sanction will not deter Tehran from pursuing its controversial nuclear programme.

The hardliner also vowed that Iran will not back down "one iota" in the face of international pressures over the atomic work, which the West fears may be a cover for weapons development despite Iran's persistent denial.

"They issued several resolutions and sanctioned Iran ... They think Iranians will fall on their knees over these things but they are mistaken," Ahmadinejad said in a speech in southern Iran carried live on state television.

"We are not interested in conflicts (but) you are continually demanding things," he said to world powers, led by the United States, which

are seeking to curb Iran's atomic ambitions.

"They should not think they can put up obstacles in Iranians' way ... I assure the people that the government will whole-heartedly defend Iran's rights and will not back down one iota," he said.

Iran is already under three sets of UN Security Council sanctions over its defiance and refusal to suspend enrichment, which lies at the heart of international fears about its nuclear programme.

The process that makes nuclear fuel can also be used to make the fissile core of an atomic bomb.

World powers gave Iran until the end of 2009 to accept a UN-brokered deal to ship most of Iran's low-enriched uranium (LEU) abroad to be further refined into reactor fuel by Russia and France.

Palestinians snub US call, demand settlement freeze

Europe shivers as cold snap hits transport, power links

Europe faced weekend weather misery with scores of flights cancelled Saturday as snow blanketed swathes of the continent, severing key highways and disrupting rail and electricity links.

Germans were urged to buy enough food and medicines to last for up to four days in the face of a blizzard. The government said all non-essential travel should be avoided.

More than 200 flights were cancelled at Frankfurt, Europe's third largest airport, on Saturday, spokesman Juergen Harrer said, adding many more had been delayed. Traffic on the A5 highway

between Germany and France was paralysed Saturday after French police blocked off the border road to trucks due to heavy snow, German traffic police said. With much of Britain

already shivering through the worst spell of bad winter weather for more than 30 years, a further blanketing was expected. Forecasters say up to 20 centimetres (seven inches) could settle in the east.

The conditions hit weekend sports games -- five English Premier League football matches were called off and five out of the six Premiership rugby union fixtures were also cancelled.

Northern Areas Reduction of Poverty Initiative (NARI) Consulting Services for Socio-Economic Assessment The World Bank Office, Dhaka

The Northern Areas Reduction of Poverty Initiative (NARI) is a US\$27 million project that the Government of Bangladesh (GOB) will prepare and implement, with support from the World Bank. NARI's objective is to facilitate access to employment opportunities in the garment sector for poor and vulnerable women from Bangladesh's poorest region by providing information, technical, and "life skills" training, transportation, housing and other support to obtain jobs and adjust to urban life and employment.

A Socio-Economic Assessment (SEA) is needed to inform the design of NARI and other GOB initiatives that aim to link lagging areas to economic drivers in Bangladesh. The World Bank intends to finance the assignment described below under trust funds provided by the UK's Department for International Development (DFID) and the Bank's Gender and Development Unit. The SEA requires a Consultant to conduct rigorous diagnostics and identify supportive interventions along the entire labor supply chain-from the Northern monga-prone region to receiving areas in the garment sector-to align the needs of labor supply with those of labor demand, while minimizing risks to a vulnerable pool of labor. The Consultant will receive about US\$150,000 and must complete the assignment by June 15, 2010.

The SEA will produce technical reports on the following: (i) a plan of interventions that mitigate risks posed to project beneficiaries and other stakeholders; (ii) a participatory process in which stakeholders inform the risk management plan and NARI project design; (iii) an analysis of labor demand in the garment sector, with attention to factories in Expor Processing Zones (EPZs) in Dhaka, Karnaphuli and Ishwardi; (iv) a mechanism to ensure transparent targeting and selection of beneficiaries; and (v) an information and communication campaign for target populations. Draft technical reports must be shared with stakeholders and final versions submitted with a Recommendations Report for project design.

The qualifications required for the assignment include, but are not limited to: (i) research and operational experience relevant to Bank-supported operations and other large-scale development projects; (ii) an active presence and good reputation in Bangladesh; (iii) a sound knowledge of the garment industry and, preferably, of migration and the northern monga areas; (iv) a long track record in operations-oriented quantitative and qualitative research on poverty reduction; (v) experience in conducting participatory and consultation processes involving a broad range of stakeholders; (vi) experience in social mobilization around labor and gender issues; (vii) a proven track record of coordinating and producing deliverables for complex research assignments; and (viii) a cadre of staff capable of supporting the above requirements.

The World Bank is inviting Expressions of Interest (EOI) from firms (consulting companies educational institutions and any other organization) with the capacity to plan, execute and deliver the above outlined assignment. Italians evacuate migrants, bring in police after clashes

Italian authorities sent in extra police and evacuated migrants yesterday from a southern Italian town after residents violently attacked African farm workers protesting against their conditions.

The clashes which began late Thursday left 67 people injured in the Calabrian town of Rosarno, latest reports said, but calm was generally restored Saturday, with barricades erected by locals dismantled and shops open.

Police said the 18 injured included 31 foreigners, the latest of whom was fired at with a shotgun on Saturday, 19 policemen and 17 locals.

Nine buses with police escorts evacuated 320 immigrants early Saturday to a reception centre at Crotone, some 170km from Rosarno, as locals applauded.

Astronomers spot 'super-Earth' 80 light years away

US astronomers have detected the second smallest exoplanet ever discovered with a mass just four times heavier than the Earth, adding to a growing number of low-mass planets dubbed "super-Earths."

"This is quite a remarkable discovery," said Andrew Howard, an astronomer at the University of California at Berkeley.

"It shows that we can push down and find smaller and smaller planets," he said in a presentation at the 215th meeting of the American Astronomical Society in Washington DC this week.

The exoplanet, a name given to planets outside our solar system, has been dubbed HD156668b, and is located around 80 light vears from Earth in the direction of the Hercules constellation.
