Ashuganj power plant needs urgent overhaul

Production sometimes dips below 350MW because of run-down units

Ashuganj Power Station Company Limited (APSCL) can not produce power to the capacity while the power station, one of the largest in the country, sees gradual fall in production due to rundown machinery.

Although the capacity of eight powergenerating units is 724 megawatt (MW), the station can now produce around 618 MW, sources at the power station said.

Out of eight units, GT-1, GT-2 and ST (combined cycle) units are incurring heavy losses and the authorities have a plan to set up a 150 MW power unit soon by replacing the three units, said a reliable

As several units are not functioning well, the authorities have lowered its production capacity to 678 MW. But it has failed to generate the said amount of electricity regularly. Even sometimes power production goes

below 350 MW.

Sources said most of the units of the station are in a dilapidated condition and two or three units often remain out of order. The units also become inoperative due to technical faults and lack of proper maintenance.

Unit-1 of 64 MW and unit2 of 64 MW went into operation in 1970 while unit3 of 150 MW, unit4 of 150 MW, unit5 of 150 MW, gas turbine (GT)-1 unit of 56 MW, GT-2 unit of 56 MW and combined cycle steam turbine (ST) of 34 MW started production between the years 1982 and 1988.

According to official record of APSCL, authorities cannot fully depend on any unit of the station. The power generation of the units is not up to the mark in view of the production cost, the record says.

All units, excepting unit5, have exceeded the time limit of 50,000 working hours long ago but the authorities have not taken any initiative yet for overhauling, sources said.

condition of anonymity said it would be better to repair the faults of the units again and again instead of doing overhauling work spending crores of taka as the units are obsolete.

Another source said spare parts of the units are not available in the market. In order to get spare parts, the APSCL authorities will have to give order to respective firms at least one year ago.

Contacted, Abdul Khaleque, managing director of APSCL, said six units of the station need overhauling. "It is not possible to do overhauling work of all the units at a time. We are going to take a plan to perform overhauling gradually,"

The MD added that they have a plan to set up a 150 MW unit replacing GT1, GT2 and ST units while another 450 MW unit replacing unit-1 and unit-2.

A feasibility study of the replacement project is going on at the station. APSCL is trying to get financial support from vari-However, a high official of APSCL on ous development partners, he added.

Cold wave comes only to tell on the poor

The second spell of the cold wave this season has come as an added misery for the poor and disadvantaged people, especially in the northern districts.

The fresh cold wave from Sunday has disrupted normal life in Thakurgaon and Panchagarh districts, reports our Thakurgaon correspondent.

As people are forced to stay indoors, business and official activities are hampered while students' attendance in schools and colleges fell.

The minimum temperature recorded in Thakurgaon was 10 degrees Celsius while it was nine degrees in Panchagarh district yesterday, local met office sources said.

The sun remained invisible during the last two days.

Only a couple of days before, the region faced a two-week long cold wave that started in mid-Decemberlastyear.


Although different government and non-government organisations are distributing warm clothes among the poor people but it is too inadequate

for the demand. "I wrote to the higher authorities for more blankets and warm clothes for distribution among the poor cold-hit people. We have also requested solvent people to help the poor. The district administration has distributed several hundred blankets," Thakurgaon Deputy Commissioner Munshi

Shahabuddin Ahmed said. Agricultural activities are being disturbed as farmers cannot work in crop fields due to the chilling cold, said Daliluddin, deputy director of Thakurgaon Department of Agriculture Extension.

Increasing number of patients, especially children and elderly people, are coming to hospitals with coldrelated diseases, said Dr Khairul Kabir, acting civil surgeon of Thakurgaon.

Seventeen people died of cold related diseases during last spell of cold wave in Thakurgaon district, family

and hospital sources said.

Our Chapainawabganj Correspondent adds: Poor people who can hardly afford warm cloths are the worst sufferers of the ongoing cold wave.

Septuagenarian Rahima Bewa shivers in cold at her tiny hut in Shehala Colony Moholla of Chapainawabganj municipality area as she has no warm cloths.

The poor woman is passing a miserable life as she is yet to get old age allowance or vulnerable group feeding (VGF) card or any other facilities from the government authorities.

Her husband died 35 years ago. Her two sons also died five years ago.

"I am alone and helpless. Earlier I worked as a maid in others' house but now I am too weak. I get something to eat when people give and starve

otherwise. I need a blanket in this winter. I also want a VGF card or old age allowance," said Rahima.

Like Rahima, many people are crying for warm cloths.

Our staff correspondent reports from Khulna: Biting cold claimed three lives in Batiaghata upazila of Khulna district on Saturday and Sunday.

They are -- Abdul Gani Sheikh, 108, Rizia Begum, 82, and Mohammad Ali Howlader, 68, -- all from Bhandarkot union under the same upazila.

Affected with various coldrelated diseases, over a hundred children and elderly men and women were admitted to upazila health complex during last one week, said upazila Chairman Ashraful Alam

Patients are suffering due to shortage of doctors and crisis of medicines, he said.

Law enforcers raided different areas of Cox's Bazar town over the last three days and arrested 70 more Rohingyas who entered the country

The drive started at 7:00am on Saturday and continued until yesterday afternoon.

Officer-in-Charge (OC) of Cox's Bazar Model Police Station Prodip Kumar Das said several thousand Myanmar Rohingyas, who illegally entered the country, are now staying in the town and getting involved in different professions.

They pull rickshaws and work at hotels and restaurants and also as day labourers, the OC

said, adding that most of them are involved in criminal activities in the town.

The OC further said drive will continue and action will also be taken against those who are sheltering the Rohingyas.

Separate cases have been filed with Model Police Station against the arrested Rohingyas on charges of entering Bangladesh illegally.

On January 5 and 6, the law enforcers arrested 39 Rohingyas, raiding different places including Tekpara, Burmese Market, bus terminal and the town's main road.

They also recovered 30 rickshaws from the arrested Rohingyas and later produced them in Cox's Bazar Judicial Magistrate's Court that sent them to jail.

'71 KILLING IN BAGERHAT

Jamaat leader sued again

The chief judicial magistrate's court of Dinajpur yesterday rejected the bail plea of two members of banned Islamist outfit Jama'atul Mujahideen Bangladesh (JMB) and sent

The court also fixed the next date of hearing of the case on February 28.

Court sources said, police produced Rafiqul Islam alias Zobayer alias Russel alias Jasim, 28, 'military commander' of JMB Rajshahi region and Shahidul Islam, 55, an Ehser member of the outfit to the court amid tight security.

Sources said, there are about 12 cases pending against the two JMB arrestees with different police stations of Rajshahi, Chapainawabganj, Gaibandha and Nilphamari.

Rab-5 on December 3 last vear raided the residence of Shahidul Islam, 55, son of Korban Ali of Kashigari village under Ghoraghat upazila of Dinajpur and arrested him along with bomb making materials and leaflets.

On the basis of Shahidul's statement, police arrested Rafiqul Islam after a few days from Chapainawabganj.

A case was filed with a Bagerhat court yesterday against naveb-e-ameer of Jamaat-e-Islami Abul Kalam Muhammad Yusuf and 29 others on charge of killing a freedom fighter during LiberationWar in 1971.

The accused include former lawmaker and Morelgani upazila BNP president Dr Miah Abbas Uddin.

Martyred freedom fighter Zainal Fakir's wife Achhia Khatun of Sonatola village under Sharankhola upazila filed the case with Bagerhat additional chief judicial magistrate court yesterday noon.

Achhia in her complaint said, a gang, led by Yusuf, picked up freedom fighter Zainul from Tafalbari bazaar on June 9 in 1971. The accused hacked Zainul, shot him dead and threw his body into the nearby canal, she alleged.

The court ordered the OC of Sharankhola police station to record the allegation.

Earlier on December 4 last year, Yusuf and 35 others were sued on charges of killing freedom fighters, setting fire to a house and looting valuables from it during Liberation

Khadija Begum of Dakkhin Rajoir village under Sharonkhola upazila of Bagerhat filed the case with the additional chief judicial magistrate's court.

The court ordered the officer-in-charge of Sharonkhola police station to record the case as an ejahar.

The plaintiff in her statement said, the accused led by Jamaat leader AKM Yusuf and Miah Abbas Uddin set up a camp on the first floor of the building that houses police station at Rayenda Bazar of the upazila in 1971 and killed a number of freedom fighters at the camp.

On June 7, 1971, a group of freedom fighters, including her husband Ismail Hossain Hawlader and Asmat Munshi of Khuriakhali village, attacked the camp, she said.

Both sides traded bullets and at one stage the accused caught the freedom fighters, including Ismail and Asmat Munshi, and

beat them dead, she added. The plaintiff alleged that

the accused on June 8, 1971 attacked her house, looted rice, cash, gold ornaments and other valuables and set the house afire.

Khawja Masum said, the value of the seized jatka would be about Tk 2 lakh. The fish would be given away to orphanages, he added.

Under trial prisoner dies

He died at around 3:00 pm while under treatment. Himel is son of late Nurul Islam of Dargapara village under Panchbibi upazila in Joypurhat district.

Bullets recovered

A nine-year-old boy allegedly committed suicide in Janpur Bangpara area of the district town early yesterday. Police said Akil Hasan, son of Helal Uddin, killed himself by hanging from the ceiling of his house at about 2:00am. On information, police recovered the body in the morning and sent it to Sadar hospital morgue for autopsy. The reason behind the suicide could not be known immediately.

Police recovered the body of a young girl from a tobacco field at Bilnalai village in Ghior upazila on Sunday. Victim Shilpi Akter, 18, was a worker at a private clinic at Savar. She hailed from Brahmangaon village of the upazila. Locals said, they noticed the body of the girl at the tobacco field in the morning and informed police. Police rushed to the spot and sent the body that bore injury marks, to Sadar hospital morgue for autopsy.

Rival pirates lock in fierce gunfight

Two rival groups of pirates traded gunshots at Tambulbunia under Sharankhola Police Station of Bagerhat district Sunday

Forest (ACF) Bipul Chandra Das said the pirates of notorious Raju Bahini and Shohag Bahini of the Sundarbans traded over 200 rounds of bullets during the gunfight that continued for an hour. At one stage, Shohag Bahini

retreated in the face of a fierce attack by Raju Bahini, the ACF said, adding that no one was killed or injured during the fight.

Officer-in-charge (OC) of Sharankhola Police Station has requested the higher authorities to provide more forces and logistic support to launch drives against the pirates of the Sundarbans.

Meanwhile, pirates belonging to Ali Bahini of the Sundarbans have threatened reprisal for attacking their ringleader Ali Hossain Jamaddar, 34, on Sunday.

Ali Hossain came under attack by angry mob at Khuriakhali and Chalitabunia Assistant Conservator of villages under Sharankhola upazila of Bagerhat district Sunday morning. The villagers beat him up severely and gouged out his eyes at Boyatirvila near Terobeka forest camp under the same upazila.
Police and forest workers

later rescued seriously injured Ali Hossain from the hands of villagers and took him to Sharankhola Upazila Health Complex where he is undergoing treatment under police guard.

The villagers also rescued trader Sanjoy Halder, 28, who was abducted by the member of the gang on Saturday for ransom.
