## Illegal brick kiln chimneys belching smoke freely

Huge logs being used as firewood in Jhenidah ignoring law

A staggering 70 of the 80 brick kilns in Jhenidah district are running without

Thousands of trees, mostly from forests, are destroyed daily during the brick production season as the brick kilns are using huge logs as firewood, ignoring the existing law.

Investigation reveals that only 10 of the 80 brick kilns have license while only three or four owners are abiding by all the rules and regulations.

Those few owners claimed that it is tough to abide by all the rules as production cost is high.

Brick kiln association sources said brick production season lasts from February to June every year. Generally a brick kiln having a single-chimney brick kiln produces 27/28 lakh bricks in

each season and a two-chimney brick kiln produces 50 lakh bricks.

Two thousand maunds of wood is needed to burn one lakh bricks and accordingly, one lakh maunds of wood is needed to burn 50 lakh bricks, they said, adding that one crore maunds of wood is needed to burn bricks in the district each

Brick kilns should not be set up without the permission of Directorate of Environment, said District Forest Officer Gias Uddin.

A 120-feet high chimney is needed to run a brick kiln and no brick kiln should be set up in a crop land or in the village. But most of the brick kilns are flouting

the rules, the forest official said. Asked why no action is taken for flouting the rules, forest department officials said they do not have sufficient man-

Visiting different areas of Jessore district, this correspondent found that several brick kilns in Jhenidah Sadar, Kaliganj and Moheshpur upazilas do not have proper chimney or no chimnev at all.

As most of the brick kilns are situated in densely populated areas, many people are affected with respiratory diseases due to emission of toxic gases from the burningfileds.

Children are the worst sufferers and most of them suffer from lungs disease, said Dr Abu Bakar Siddique of district civil surgeon's office.

Wishing anonymity, a few officials of district and upazila administration said they fail to take action against the illegal brick kiln owners due to interference by influential ruling party leaders.

#### Murder for dowry

A woman was murdered allegedly by her husband at Charnarua village in Sahzadpur upazila early yesterday. Police said victim Asma Khatun, 40, and her husband Abdud Samad had an altercation in the early hours of yesterday. At one stage, Samad slit Asma's throat with a sharp weapon, resulting in her death on the spot. Family sources said, Samad had been demanding a large sum of money as dowry for long from the parents of Asma. But Asma's father could not meet the demand because of poverty. Police yesterday sent the body to the Sadar Hospital morgue for autopsy. Samad and his family members went into hiding after the killing.

#### Principal's room locked

Yesterday, as soon as the principal came to the college, the agitated students locked in an argument with him over the issue and at one stage locked his office room and confined him for an hour. Later, the college teachers and Boalia High School headmaster Anisur Rahman urged the students to call off their agitation programme and assured them of taking steps to meet their demand immediately.

Judgement in the sensational Rajshahi University (RU) teacher Muhammad Yunus murder case is scheduled to be delivered today.


Rajshahi speedy trial tribunal earlier fixed the verdict date on completion of arguments in the case on December 31.

However, the tribunal's public prosecutor Entajul Haque Babu told this correspondent that the verdict date might be deferred as the tribunal judge is on leave.

Yunus, a professor of economics department, was murdered while on morning walk near his Binodpur house a few yards away from the campus on December 24 in 2004. Inspector Mohammad

Helaluddin of Criminal Investigation Department (CID) submitted the charge sheet in the case against eight JMB militants on September 10, 2007.

Meanwhile, a Rajshahi court on Tuesday issued arrest warrants against three people in connection with Lima

Parvin murder after a judicial probe found that she was murdered over dowry dispute. The Women and Children

Repression Prevention Court issued warrants for arrest of Lima's husband Anisur Rahman, father-in-law Abdul Malek and mother-in-law Anjara Begum.

A student of management department of Rajshahi University, Lima was allegedly tortured and murdered at her in-laws' house at Jagirpara of Puthia upazila on

Her in laws attempted to cover up the murder by showing it as an incident of suicide, said Lima's lawyer Zahrul Islam.

Later, police pressed charges against the three accused for 'instigating' her to commit suicide.

Challenging the charge sheet, Lima's father Taslim Uddin submitted a noconfidence petition and demanded a judicial probe into the incident on November 15.

The court then ordered metropolitan magistrate Asafud Doula to investigate the matter. The magistrate submitted the investigation report on Monday revealing that Lima was tortured and killed over dowry issue, said

Zahrul Islam. Rajshahi University chapter of Bangladesh Mohila Parishad is looking after the case, said the chapter's general secretary and psychology teacher Mahbuba Kaniz Keya.

The Parishad employed the lawyer for Lima as her father is too poor to run the case, she

#### Dense fog disrupts ferry, launch services


Launch and ferry services on Paturia-Doulatdia river route remained suspended for six hours till 9:00am yesterday due to dense fog causing sufferings to the passengers.

Seven ferries loaded with passengers and vehicles were also anchored at Paturia and Doulatdia ferry points.

Ashraf Ullah Khan, Manager of (BIWTC) at Aricha told the news agency that ferry and launch services were suspended at 3:00am to avoid any accident as the visibility in the channel was very poor due to dense fog.

The movement of river crafts, however, resumed at nine in the morning as the fog started to disappear.

Sources said a huge traffic jam was created on both sides of the ferry points due to the suspension of services.



# JP MP's remarks anger Satkhira AL

In an instant reaction to his speech, local leaders and activists of Kaliganj uazila AL and its front organisations took out a procession at upazila headquarters and then held a rally at Phultala intersection at around 8:30pm.

Terming the allegations brought against the AL and Jubo League leaders false and baseless, the speakers asked the lawmaker to withdraw his remarks through a statement. Otherwise, they said he will be declared unwanted in his constituency. Later, the AL and Jubo League men burnt the effigy of Golam Reza.
