## Call to ensure political empowerment of women

Speakers at a roundtable yesterday stressed the need to make room for more women in parliament in order to ensure women's participation in decisionmaking.

Women parliamentarians needs to form a caucus among themselves and work from inside to ensure women's equal participation in politics, they

The Bangladesh Alliance for Women Leadership (BDAWL) and the Bangladesh Enterprise Institute (BEI) jointly organised the roundtable on 'Women leadership in Bangladesh: Aspirations, Achievements and Outlook on Future' at it the BEI conference room in the city. Leading women alumnae from various

US organisations took part in the roundtable.

A 34-member delegation called 'Among Women' from the US is currently visiting Bangladesh to share their ideas on women's movement for a fair share in the policy making positions in Bangladesh, with more women getting all fields.

Nasim Firdaus, executive director of BDAWL, said that during the last parliament election women played a major role in deciding the fate of the country for the next five years. Although more than 50 percent voters were women during the last election, they did not make much progress in the leadership role, she Dilara Chowdhury of Jahangirnagar pointed out.

She identified poverty and lack of confidence and opportunity in the political field as the main reasons.

Rokia Afzal Rahman, president of Bangladesh Federation of Women Entrepreneurs, stressed the need for women's economic emancipation and political empowerment.

She said that things are looking up in access to economic activities in recent times.

She pointed out that more than 80 percent of the workers in readymade garment sector are women who get the credit for fetching the largest chunk of export-oriented foreign currency.

BEI President Farooq Sobhan, Prof University, cultural personality Sara Zaker, Nasreen Awal Mintoo, chairperson of Women Entrepreneurs Association of Bangladesh, also spoke.

### Punishment to killers of Sunny demanded

Bangladesh Jubo Moitree yesterday demanded exemplary punishment to the killers of Rezwanul Islam Chowdhury Sunny, a leader of Bangladesh Chhatra Moitree.

The demands came from a protest rally of Jubo Moitree, the youth front of Workers' Party of Bangladesh, at Muktangan in the city.

Jubo Moitree leaders at the rally claimed that the cadres of the ruling party's student body have been creating anarchy at the educational institutions across the country but the government has not yet taken any initiative to address the problem.

They demanded immediate arrest of Bangladesh Chhatra League (BCL) cadres who were involved in the killing of Sunny and due compensation to his family.

They also demanded the government bear the treatment cost of the Chhatra Moitree leaders and workers who received injuries in the attack.

Jubo Moitree President Sadeque Hossain Khan Babu, General Secretary Mostafa Alamgir Ratan, Publicity Secretary Mahbubul Islam Sohel and Chhatra Moitree leader Bappa Ditta Basu also spoke.

Later, they brought out a protest procession that paraded different city streets.

Sunny, a leader of Rajshahi Polytechnic Institute unit of Chhatra Moitree, was killed in an attack by BCL men over establishing supremacy on the campus on January 7.

## Concerted efforts a must to combat human trafficking

Speakers tell seminar

Speakers at a seminar yesterday called for concerted efforts by the government, non-government and international organisations to combat human traffick-

It is a multi-dimensional issue, which needs to be addressed properly, they

The Centre for Women and Children Studies (CWCS) organised the seminar on 'Framing the Problems of Human Trafficking: Challenges and Way Forward' at the Biam auditorium in the

Dr Robin Haarr, associate professor, Criminal Justice and Police Studies, College of Justice and Safety, Eastern Kentucky, presented the keynote paper.

She talked about the causes and dynamics of human trafficking, importance of awareness raising, rehabilitation, protection and safe migration and effective investigations and interception multi-agency response.

"It is not the responsibility of one organisation to provide protection, rehabilitation and economic empowerment for trafficking victims. Rather, it requires collaboration between international and local NGOs, national and local governments, legal and victim advocates and private enterprises," she said.

Migration when it goes wrong is also trafficking, she said, adding that safe migration should be ensured.

Speaking as the chief guest, Additional Inspector General of Police NBK Tripura highlighted different programmes that have been taken involving the police force to combat human trafficking.

The police launched an antitrafficking investigation unit within the Criminal Investigation Department (CID) on June 17, 2008. It deals with the cases of human trafficking to ensure nar.

of trafficking in human beings, he said.

Next to drugs and arms, human trafficking is considered the largest organised crime that has grave consequences for the safety, welfare and human rights of its victims, he said, adding that combating and preventing human trafficking requires holistic approach by all stakeholders and integrated actions on prosecution, prevention and protection.

the Senior Special Judge's Court passed the order upon a bond of Tk 20,000 with two guarantors after Atiq along with his lawyers surrendered before the court and sought bail in the case.

After taking into cognizance the charges against the accused for trial, the court also fixed February 17 for hearing on charge framing against the accused and shifted the case to the Special Judge's Court-3 of Dhaka for its quick disposal.

During the hearing, Judge said if the ministers and lawmakers were honest, the country would have run prop-

During the hearing, defence lawyers told the court that their client was implicated in the case as part of a conspiracy to harass him while the prosecution opposed it saying that the sections of the case are nonbailable.

Earlier on December 15 last year, ACC Assistant Director Dewan Shafiuddin Ahmed, also the investigation officer (IO), submitted the charge sheet against Atiq to the Chief Metropolitan Magistrate's Court of Dhaka and showed 23 people as prosecution witnesses.

This was the first time the ACC pressed charges against a ruling party lawmaker since this government took over.

The IO also appealed to the court for issuance of arrest warrant against the lawmaker and an order to attach his properties, as he has been shown absconding in the case.

On May 27 in 2008, ACC Assistant Director Shamsul Islam filed the case against Atiq with Ramna Police Station.
