Eastern Refinery Limited, a subsidiary company of Bangladesh Petroleum Corporation (BPC) intends to appoint a consulting firm for its consultancy services on the installation of pipeline and a single point mooring (the SPM system). The SPM system involves the construction of a floating buoy where tankers can moor to receive or to deliver crude or HSD, to and from refineries using direct pumping method. The SPM is proposed to be installed at south west of Kutubdia Island, and will be linked to the existing refinery storage facilities through an about 77 KM pipeline that traverses on land as well as below the water surface.
2. The Government of the People's Republic of Bangladesh has received a loan from the Islamic Development Bank (IDB) and intends to apply part of the proceeds of this fund for payments under contract for consultancy services for installation of a Single Point Mooring (SPM).
3. The consultancy services for the SPM project includes:
  - a. To prepare the Front End Engineering Design (FEED) document.
    - i) The data collection, surveying and technical analysis for Met-Ocean Data (tide, currents data, weather winds, data for tide, currents and wind, visibility, pipeline and SPM stability, dive time and other related items, installation methodologies).
    - ii) Data collection and confirmation of the Geotechnical Data (soil investigation in sub-sea and offshore locations, SONAR survey for the laying and design of the pipeline and SPM components, bathymetric survey and other related items).
    - iii) Route Surveys and Right of Way finalization.
  - b. To prepare the design engineering for:
    - i) SPM system and its components.
    - ii) Proposed pipeline.
    - iii) SCADA system.
  - c. To prepare detailed and itemized costing for project component. To perform project risk assessment study and develop mitigation measures.
  - d. To prepare consultancy planning and scheduling.
  - e. To prepare the tender documents for the selection of the Engineering, Procurement and Construction (EPC) contractor, its evaluation and procurement of long lead items.
