US drones pound Pak tribal belt: 11 more militants killed

Taliban claim Mehsud safe, release his audio tape

ANI, Peshawar

Unmanned US Predator aircraft continued to pound Pakistan's lawless tribal region on Friday evening, with 11 extremists reportedly being killed in twin drones strikes in North Waziristan.

According to officials, at least five drones were seen hovering over the region and fired four missiles targeting a suspected militant hideout.

Local administrative officials also confirmed the missile hit, The Nation reports.

While the Pakistani security forces are still ascertaining reports about the death of the Tehrik-e-Taliban Pakistan (TTP) leader Hakimullah Mehsud in a US drone

strike, the TTP has released an audio tape of Mehsud claiming that their leader is

Mehsud, in his audio message, claimed that he is unhurt, and that it is a conspiracy of the government to flash the news about his death.

"Sometimes they (the government) launch propaganda about my martyrdom through media and sometimes they say that the operation has been completed in South Waziristan. This can never happen," The Nation quoted Mehsud, as saying.

However, there was no mention of the day or date of the drone strike in which Mehsud is said to have been killed, which raises questions over whether the message was recorded after the said strike.

Meanwhile, the BBC quoted a Taliban leader, as saying that Mehsud has been injured in Thursday's attack.

It may be noted that 15 militants were reportedly killed in a US missile hit in the tribal controlled region between North and South Waziristan on Thursday. Security officials said Mehsud too may have been killed in the attack, but they have failed to substantiate the report.

The Pakistan government and the Army have clarified that they are uncertain over the TTP's top commander's death.

Sources said the US drones fired missiles close to the region where the TTP chief Hakimullah Mehsud was believed to have been killed in a similar strike earlier this week.

5 killed in Kenya mosque riots

At least five people were killed Friday when Kenyan police fired live rounds and teargas to suppress a protest by Muslims demanding the release of a radical Jamaican cleric, police said.

"Five people have died, some of them have been shot and there are those with other injuries but we cannot really tell who shot them because some of the protesters were armed and were shooting at our officers," said a senior police officer who asked not to be named.

US, Norway deny funding Rajapakse ouster bid

The United States and Norway yesterday denied funding Sri Lanka's main opposition to defeat President Mahinda Rajapakse's reelection bid later this month.

The US embassy in Colombo said it "strongly" rejected the charges made by a ruling party legislator that he was given 30 million rupees (265,000 dollars) that had come from the US and Norwegian embassies to defect to the opposition.

Legislator Mohamed Musammil told reporters in Colombo Friday that he was given a suitcase full of the cash to defect and support the main opposition presidential candidate, Sarath Fonseka.

"This is the money which had come from the US embassy, the Norwegian embassy,"

Musammil said. The US and Norwegian embassies in separate statements denied the allegation and said they were ready to work with whomever won the January 26 election. The two countries had backed Colombo's failed peace bid with Tamil separatists.

"The United States is neutral and we strongly condemn allegations that we are supporting one side over another," the US statement said.

Norway, which was the peace broker until the Rajapakse administration withdrew from a faltering truce and escalated a military campaign against the Tigers early last year, denied it was funding the opposition in Colombo.

"The accusation is untrue and totally unacceptable," the Norwegian embassy said in a statement. "Norway has never -- and will never -- interfere in an election in another country.

Rajapakse is seeking re-election after government troops in May wiped out the Tamil Tiger rebels and ended a 37-year separatist conflict that claimed up to 100,000 people, according to United Nation figures.

3 dead in train collision in fog-bound N India

Three people died and around a dozen were injured when two express trains collided in thick fog in India's northern state of Uttar Pradesh yesterday, a senior railway official said.

The accident happened near Tundla, 25km from the Taj Mahal town of Agra, when the driver of one of the trains apparently did not react to a signal, slamming his train into another on the same track.

"According to preliminary information, there are three deaths," Devesh Mishra, divisional railway manager at Agra told

Television footage showed two carriages of the Shram Shakti Express, travelling from New Delhi to the industrial hub of Kanpur, badly mangled after the collision.
