Conspiracy still on to foil trial of war criminals

Warns Sector Commanders Forum

Member-Secretary of the Sector Commanders Forum (SCF) Lt General (ret) Harun-ur-Rashid yesterday said conspiracy is on to foil war criminals' trial.

He said the anti-liberation forces are trying to create an unstable situation in the country in a bid to compel the government to stop its move to try war criminals. "They under different banners are spreading propaganda against trial of the war criminals. They dared to accord reception to a few freedom fighters, which is insulting to all patriotic people. So the government should start trial of the

war criminals without further delay," Harun said while addressing a freedom fighter-public meeting at Panchagarh government auditorium in the town.

Urging all to boycott war criminals socially and politically, he said war criminals have no right to participate in national politics as they played anti-liberation role in 1971. They should be tried to ensure justice in the country and uphold the spirit of the Liberation War.

The other speakers said trial of the war criminals has to be begun without further delay as people gave their mandate to the AL-led grand alliance government on this issue in the last parliamentary election.

SCF leaders and people observed one-minute silence to pay homage to the martyrs of the Liberation War.

Sector Commanders Forum Panchagarh unit Coordinator Shaikhul Islam presided over the meeting which was addressed, among others, by Major General (ret) Masudur Rahman and Organising Secretary of SCF Rajshahi division Saiduzzaman Tara, JSD central leader Nazmul Haque Prodhon, JSD district unit Secretary SM Liakat Ali, district SCF leader Johirul Islam, Abdul Mazid and Abdus Sattar. Mother of two raped allegedly by BCL leader, accomplices

Maid's body recovered, parents say murder

A housewife was gangraped allegedly by a Chhatra League (BCL) leader and his accomplices at Raninagar village under Solonga police station in Ullapra upazila on Thursday night.

The victim is mother of two children and hailed from Raipur in Sirajganj town.

Police said, a group led by Borohor union Chhatra League secretary and another activist picked up the woman from Hatikumrul area at around 11:30 pm while she was returning home from her relative's house in Gaibandha.

The criminals took her to a house at Raninagar village and gangraped her.

Hearing her screaming, locals rushed to the spot and caught red-handed BCL leader Babu while his other accomplices managed to flee. But Babu later got released with the help of some headmen who assured the villagers of taking the culprits into task.

A case was lodged with

Solonga police station in this connection.

Contacted, OC of the police station said, he was preparing to send the woman to hospital yesterday for medical test and treatment.

Our Correspondent in Dinajpur reports: Police yesterday recovered body of a young housemaid from Kosba village under Dinajpur town.

Victim Nilu Akhter, 12, was daughter of Md Abdul Latif of Nun-Sahar Chowdhurypara under Dinajpur Sadar upazila.

Parents of the victim said their daughter had been working at the house of Mozzammel Hossain Ujjal at Koshba for the last three months. They said Nilu was murdered for unknown reasons.

However, Mozzammel Hossain claimed that the girl committed suicide on Friday night by hanging herself from a window grill.

Dinajpur police declined to make comments immediately over the issue. They were waiting for autopsy report.

Outlaws give 'death sentence' to five of rival party

Posters in several areas of Gangni upazila in Meherpur

Newly formed outlawed party Purbo Banglar Communist Party (PBCP-Congress) pasted posters in several areas in Gangni upazila in Meherpur on Friday and Saturday night.

The posters said that the party recently gave 'death sentence' to five cadres including regional leader of its rival outlawed party PBCP-Lal Pataka.

The outfit said they will 'execute the death sentence'

within the next few days.

According to local sources, the outfit pasted the posters on walls of houses and shutters of shops at Arpara, Bhibla, Charpara in Gangni of Meherpur. Some posters were also hung on trees.

In the posters, the outfit claimed one 'Dada Thakur' as their leader.

Police however, could not say as to who pasted the posters and when.

Officer-In-Charge (OC) of Gangni police station said they were unaware about the incident, adding they never came across any outlawed party like PBCP-Congress.

In Pabna, Rapid Action Battalion (Rab) personnel on Friday arrested a leader of Purbo Banglar Communist Party (ML-Lalpotaka) from Paschim Bangram village in Ataikula upazila.

Arrestee Aslam, 35, is son of Jabbar Pramanik of the village, reports UNB.

Acting on a tip-off, a team of Rab-12 conducted a drive at the village at noon and arrested Aslam.

He was wanted in various cases, including of a double murder, Rab sources said.

Five bombs recovered

Rapid Action Battalion (Rab) members yesterday recovered five bombs from Bishoykhali village in Sadar upazila.

Acting on a tip-off, Rab-7 members raided the spot near the Begabati River at about 12:30 pm and recovered the bombs in an abandoned condition.

The bombs were kept in a polythene bag, Rab sources said.

The elite force suspected that criminals might have kept the bombs there for carrying out subversive activities later at a convenient time.

DISPUTE OVER HEADMASTER RECRUITMENT

AL men rampage thru' school

Ruling party men yesterday attacked the teachers and students of Balapara High School under Sadar upazila of Thakurgaon over recruitment of a headmaster for the school.

They ransacked office and classrooms, forced the teachers and students to leave the school and put it under lock and key, according to acting headmaster Abdur Razzak and locals.

Locals said a group of Awami League activists led by General Secretary of Begunbari Union Awami League Boni Amin came to the school in the morning and swooped on the teachers and students. They ransacked office and classrooms and then forced the teachers and students to leave the school.

As assistant teacher Zakia Jahan protested, they assaulted her and also beat up another assistant teacher Abul Kalam Azad as he carried a reporter of a national daily in his motorbike to the school soon after the incident.

Acting headmaster Abdur Razzak told this correspondent recruitment test for the headmaster of the school is scheduled to be held on Sunday and Boni Amin, also the headmaster of Nargoon High School, is one of the

candidates.

"Apprehending that the governing body will recruit me as a full-fledged headmaster, he attacked the teachers and locked the school to foil recruitment," Razzak said.

Santhi Khatun, a student of class XI, and Shusmita Rani, a student of class VIII, told this correspondent that when they came to school at around 10:00am, a group of people

suddenly attacked them and forced them to leave the school. The students strongly protested the incident and demanded punishment to the attackers.

When contacted, Boni Amin told this correspondent that local people alleged irregularities and corruption in the school. He denied allegations that AL men led by him attacked the teachers and

students and ransacked office and classrooms of the school.

Acting headmaster Abdur Razzak said he informed the upazila nirbahi officer and local police station of the matter. "We are taking preparation to lodge a case in this connection," he said. No case was filed with the police station concerned as of filing of this report at 5:00pm yesterday.
