These corrigenda shall supersede the contents of same contexts or texts in the RFP advertisement and the pre-proposal meeting minutes issued earlier.
Amended clauses
4. Any eligible Private Health Organizations/NGOs or CBOs may submit or participate in proposals in any or all package/s. Interested organization(s) must meet the following criteria and provide documentary evidences to be considered as responsive during the preliminary examination. Proposals failing to meet the criteria shall be returned unopened after the selection process is over. The organizations shall also meet other qualification and experience criteria mentioned in the RFP documents for technical evaluation.

b) An organization or the lead organization in case of a consortium must have proven experience on intervention implementation (to be substantiated by submission of annual report, project completion report etc) with MSM and/or hijra for a minimum period of three years;

e) Legally binding MOUs with the consortium partners, defining roles responsibilities and obligations of each member, if applicable. The members of the consortium shall be jointly and severally responsible for the performance of the assignment.
